1. Offers should be submitted **ONLINE via e-Procurement System** separately in two parts as follows :

For detailed instructions, please see clause no. 2 of "Instructions to Bidders of GCC Rev. 06".
 2. If bidder uploads price bid in the unpriced section (techno-commercial attachment page) of the tender in e-procurement, in that case bidder(s) shall only be responsible for such mistake and any consequences thereof. Hence all bidders are requested to be more careful at the time of uploading the Unpriced and Price Bid for Part-I and Part-II respectively to avoid mismatch.

9. Unsolicited fresh/revised price bids shall not be entertained.

14. Delivery Schedule :

For Lot-I : Four (04) months from the date of drawing/documents approval in CAT-I issued by BHEL/CUSTOMER. The drawing/documents submission/resubmission schedule shall be as per clause no. 4.1 of section-I of Technical Specification. Drawings/ documents submitted shall be complete in all respects with revised drawing/documents submitted incorporating all comments. Any incomplete drawing/documents submitted shall be treated as non-submission with delays to bidder's account. For any clarification/ discussion required to complete the drawing/documents, the bidder shall himself depute his personal to BHEL for across the table discussions/ finalization/submissions of drawings/documents. Drawing/documents submission/resubmission schedules are to be adhered by the bidders and any delay in the same from bidder's end shall be deducted from delivery period indicated from CAT-I approval.

Subsequent Lot : Subsequent lot shall be cleared for manufacture based on progress of engineering and site requirements. A lead-time of three (03) months shall be given from the date of clearance of quantities for completion of supply of subsequent lot.

15. **Over all (%) variation in contract value :** The variation on overall package value due to changes in the scope shall be limited $\pm 30\%$.

16. **Pre-Qualifying Requirement :**

Bidders are requested to furnish the details as per "TECHNICAL PRE-QUALIFYING REQUIREMENTS" (enclosed with the enquiry document). Along with the tender, bidders to furnish all legible & valid documents required for Technical PQR. The same shall be properly co-relating with respective clause of PQR.

Bids of only those bidders shall be evaluated who meet the Technical pre-qualifying requirements.

17. Bidders to note for compliance that this is a conditional enquiry (Open Tender), and the price bid (Part-II) opening/RA shall be subject to fulfilment of Technical pre-qualifying requirements & Techno-commercial qualification/recommendation of bidder by BHEL-PEM.

18. The bidders (who are not registered with BHEL-PEM)- Online Registration Portal is operational in BHEL. Non-registered bidders, who wish to apply for registration with BHEL-PEM, have to apply through Online Registration Portal available at www.bhelpem.com → vendor section → Online Supplier Registration. All credentials and/or documents duly signed and stamped related to registration has to be uploaded on the website and submit the application for registration. One set of hard copy of the filled-up SRF downloaded from Online Registration Portal duly signed and stamped has to be submitted."

19. BHEL reserves the right to go for Reverse Auction (RA) (Guidelines as available on www.bhel.com) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. Bidders to give their acceptance with the offer for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.

Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'Process compliance form' (to the designated service provider) as well as 'Online sealed bid' in the Reverse Auction. Non-submission of 'Process compliance form' or 'Online sealed bid' by the agreed bidder(s) will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines for suspension of business dealings with suppliers/ contractors (as available on www.bhel.com).

The bidders have to necessarily submit online sealed bid less than or equal to their envelope sealed price bid already submitted to BHEL along with the offer. The envelope sealed price bid of successful L1 bidder in RA, if conducted, shall also be opened after RA and the order will be placed on lower of the two bids (RA closing price & envelope sealed price) thus obtained. The bidder having submitted this offer specifically agrees to this condition and undertakes to execute the contract on thus awarded rates.

If it is found that L1 bidder has quoted higher in online sealed bid in comparison to envelope sealed bid for any item(s), the bidder will be issued a warning letter to this effect. However, if the same bidder again defaults on this count in any subsequent tender in the unit, it will be considered as fraud and will invite action by BHEL as per extant guidelines for suspension of business dealings with suppliers/ contractors (as available on www.bhel.com)."

As a reminder to the bidders, system will flash following message (in RED Colour) during the course of 'online sealed bid':

"Bidders to submit online sealed bid less than or equal to their envelope sealed bid already submitted to BHEL".

20. **Reverse Auction :** "The Bidders has to quote the Single Price (i.e. Total Cost to BHEL) in Reverse Auction. Prices are to be inclusive of Packing & Forwarding charges, all the routine & type tests as per tender scope, Freight as applicable, including loading (if any). De-loading (if any) shall be done in line with NIT/SCC/GCC terms". GST shall not be included as evaluation is to be done excluding GST.

21. Evaluation will be done on overall L1 (Total cost to BHEL excluding GST) basis with necessary loading as applicable.

22. To oversee implementation of **Integrity Pact (IP)**, **Shri D.R.S. Chaudhary, IAS (Retd.)** has been appointed as Independent External Monitor (IEM) by BHEL.

A. IP is a tool to ensure that activities and transactions between the Company and its Bidders/Contractors are handled in a fair, transparent and corruption free manner. A panel of Independent External Monitors (IEMs) have been appointed to oversee implementation of IP in BHEL.

The IP as enclosed with the tender is to be submitted (duly signed by authorized signatory who signs in the offer) along with techno-commercial bid. Only those bidders who have entered into such an IP with BHEL would be competent to participate in the bidding Process (Refer Annexure-IX of GCC, Rev.06). In other words, entering into this Pact would be a preliminary qualification.

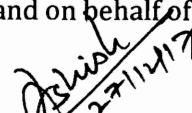
