14. **Delivery Schedule: -**
- SUPPLY: -** Delivery completion shall be Four (04) months from Drgs. /docs. approval in CAT-I. Drawing/Documents submission/re-submission schedule shall be as per Annexure-IV of Technical Specification (Master Drawing List with schedule of submission). In case there are delays of submission/resubmission of drawings/documents as per above schedule, that much days would be reduced from delivery period.
15. Permanent registration and one-year insurance of the vehicles in the name of the end customer will be in bidder's scope.
16. Temporary registration and on-road insurance for the vehicles also is in bidder's scope.
17. **Pre-Qualifying Requirements:** Bidders have to provide the required details as per PRE-QUALIFICATION REQUIREMENT CRITERIA (enclosed as NIT Tender Documents) in their Techno-Commercial offer. Bids of only those bidders shall be evaluated who meet the Pre-Qualifying requirements.
18. Bidders are requested to refer Performance Bank Guarantee (PBG) format & rules and adhere to it while furnishing PBG.
19. **Reverse Auction: -**

"BHEL reserves the right to go for Reverse Auction (RA) (Guidelines as available on www.bhel.com) instead of opening the electronically submitted price bid, submitted by the bidder.

This will be decided after techno-commercial evaluation. Bidders to give their acceptance with the offer for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.

Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'Process compliance form' (to the designated service provider) as well as 'Online sealed bid' in the Reverse Auction. Non-submission of 'Process compliance form' or 'Online sealed bid' by the agreed bidder(s) will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines for suspension of business dealings with suppliers/ contractors (as available on www.bhel.com).

The bidders have to necessarily submit online sealed bid less than or equal to their electronically submitted price bid already submitted to BHEL along with the offer. The electronically submitted price bid of successful L1 bidder in RA, if conducted, shall also be opened after RA and the order will be placed on lower of the two bids (RA closing price & electronically submitted prices) thus obtained. IMPORTANT INSTRUCTION TO BIDDERS IN CASE OF REVERSE AUCTION

The Bidders has to quote the Single Price (i.e. Total Cost to BHEL availing input tax credit) in Reverse Auction. Price are to be inclusive of Packing & Forwarding charges, all the routine & type tests as per tender scope, Freight charges, Insurance charges (if applicable) etc., including loading (if any) as applicable.

20. CIF is not available for this package
21. Prices are Firm.
22. If any bidder uploads price bid in the unpriced section (techno-commercial attachment page) of the tender in e-procurement, in that case bidder(s) shall only be responsible for such mistake and any consequences thereof. Hence all bidders are requested to be more careful at the time of uploading the Unpriced and Price Bid for Part-I and Part-II respectively to avoid mismatch
23. All the above Tender Documents shall automatically become a part of the Order/Contract after its finalisation.
24. Evaluation shall be on over all L1 basis (total cost to BHEL) excluding GST quoted by bidder. Bidders have to refer SCC Rev02 & GCC Rev06 (along with GST related corrigenda to GCC Rev06) for the same.
