If bidder uploads price bid in the unpriced section (techno-commercial attachment page) of the tender in e-procurement, in that case bidder(s) shall only be responsible for such mistake and any consequences thereof. Hence all bidders are requested to be more careful at the time of uploading the Unpriced and Price Bid for Part-I and Part-II respectively to avoid mismatch.

14. Delivery Schedule :

For Lot-I : Five (05) months from the date of drgs. /docs. approval in CAT-I or manufacturing clearance, whichever is earlier. The drawings/documents submission/resubmission schedule shall be as per Clause No. 4.2 of Section I, Volume-II of technical Spec. No. PE-TS-421-507-E013, Rev.0. Drawings/documents submitted shall be complete in all respects with revised drawings/documents submitted incorporating all comments. Any incomplete drawings/documents submitted shall be treated as non-submission with delays to bidder's account. For any clarification/ discussion required to complete the drawings/documents, the bidder shall himself depute his personal to BHEL for across the table discussions/ finalization / submissions of drawings/documents. Drawings/documents submission/resubmission schedules are to be adhered by the bidders and any delay in the same from bidder's end shall be deducted from delivery period.

Subsequent Lot : Subsequent lot shall be cleared for manufacture based on progress of engineering and site requirements. A lead-time of three (03) months shall be given from the date of clearance of quantities for completion of supply of subsequent lot.

- 15. Over all (%) variation in contract value :** The variation on overall package value due to changes in the scope shall be limited $\pm 30\%$.

16. Pre-Qualifying Requirement :

Bidders are requested to furnish the details as per "TECHNICAL PRE-QUALIFYING REQUIREMENTS" (enclosed with the enquiry document). Along with the tender, bidders to furnish all legible & valid documents required for Technical PQR. The same shall be properly co-relating with respective clause of PQR.

Bids of only those bidders shall be evaluated who meet the Technical pre-qualifying requirements.

- 17. Bidders to note for compliance that this is a conditional enquiry Open tender, and the price bid (Part-II) opening/RA shall be subject to following criterion :**

- Fulfilment of Technical pre-qualifying requirements & Techno-commercial qualification/recommendation of bidder by BHEL-PEM.
- Approval of bidder by Customer (who are not approved by customer) : Approval shall be taken up by BHEL with customer based on the credentials/reference list. Hence, bidders to submit the credentials as per format enclosed for submission of bidders credentials with Enquiry Letter (NIT).
- Bidders, who are approved by NTPC in any NTPC/BHEL project for Cable Tray and Support System-Boltable Type, shall be considered as approved by end customer for this tender subject to the fulfilment of the conditions, if any, mentioned in the NTPC approval letter. Bidder must furnish their NTPC approval letter for Cable Tray and Support System – Boltable Type package in lieu of the credentials mentioned at sl. no. (b) above.

- 18. The bidders (who are not registered with BHEL-PEM)- Online Registration Portal is operational in BHEL. Non-registered bidders, who wish to apply for registration with BHEL-PEM, have to apply through Online Registration Portal available at www.bhelpem.com → vendor section → Online Supplier Registration. All credentials and/or documents duly signed and stamped related to registration has to be uploaded on the website and submit the application for registration. One set**

of hard copy of the filled-up SRF downloaded from Online Registration Portal duly signed and stamped has to be submitted."

19. BHEL reserves the right to go for Reverse Auction (RA) (Guidelines as available on www.bhel.com) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. Bidders to give their acceptance with the offer for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.

Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'Process compliance form' (to the designated service provider) as well as 'Online sealed bid' in the Reverse Auction. Non-submission of 'Process compliance form' or 'Online sealed bid' by the agreed bidder(s) will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines for suspension of business dealings with suppliers/contractors (as available on www.bhel.com).

The bidders have to necessarily submit online sealed bid less than or equal to their envelope sealed price bid already submitted to BHEL along with the offer. The envelope sealed price bid of successful L1 bidder in RA, if conducted, shall also be opened after RA and the order will be placed on lower of the two bids (RA closing price & envelope sealed price) thus obtained. The bidder having submitted this offer specifically agrees to this condition and undertakes to execute the contract on thus awarded rates.

If it is found that L1 bidder has quoted higher in online sealed bid in comparison to envelope sealed bid for any item(s), the bidder will be issued a warning letter to this effect. However, if the same bidder again defaults on this count in any subsequent tender in the unit, it will be considered as fraud and will invite action by BHEL as per extant guidelines for suspension of business dealings with suppliers/contractors (as available on www.bhel.com).

As a reminder to the bidders, system will flash following message (in RED Colour) during the course of 'online sealed bid':

"Bidders to submit online sealed bid less than or equal to their envelope sealed bid already submitted to BHEL".

20. **Reverse Auction** : "The Bidders has to quote the Single Price (i.e. Total Cost to BHEL) in Reverse Auction. Prices are to be inclusive of Packing & Forwarding charges, all the routine & type tests as per tender scope, Freight as applicable, including loading (if any). De-loading (if any) shall be done in line with NIT/SCC/GCC terms". GST shall not be included as evaluation is to be done excluding GST.
21. Evaluation will be done on overall L1 (Total cost to BHEL excluding GST) basis with necessary loading as applicable.
22. Bidders to note that packing of equipment shall be sea worthy. For sea worthy packing of equipment/items, refer sea worthy packing specification document (Ref. No. PE-TS-888-100-A001) of export jobs enclosed with Enquiry (NIT).
23. CIF is not available for the subject package.

24. Successful bidder shall abide by all Applicable Laws, Rules and Regulations of Bangladesh relating to the execution of contract and performance of work. Successful bidder shall obtain and maintain all consents, permits and licenses that are required under Applicable Laws of Bangladesh.
25. No announcements, press releases, handouts or photographs for publication etc. relating to purchase-order/work-order or any part of the supply/work shall be issued or released by successful bidder without BHEL's prior written approval.

27. Inspection shall be done by BHEL/End Customer/Third party Agency (finalized by BHEL).
28. L1 bidder will have to submit BG as per format enclosed with Enquiry Letter (NIT) instead of format mentioned in GCC, Rev.06.
29. The bidder along with its associate/collaborators/sub-contractors/sub-vendors/consultants/ service providers shall strictly adhere to BHEL Fraud prevention policy displayed on BHEL website <http://www.bhel.com> and shall immediately bring to the notice of BHEL management about any fraud or suspected fraud as soon as it comes to their notice.
30. Foreign and indigenous bidders participating through open tender will necessarily have to buy class III DSCs issued by the certifying authorities in India. Basic procedure/checklist has been uploaded on www.bhel.com for participating in future tender enquiries through e procurement.
31. The offers of the bidders who are on the banned list as also the offers of the bidders, who engage the services of the banned firms, shall be rejected. The list of banned firms is available on BHEL website www.bhel.com.

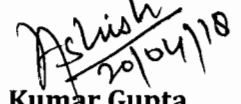
