3. **Verification of PQR documents:** Bidders to ensure that Third party/customer issued certificates being submitted as proof of PQR qualification should have verifiable details of document/certificate issuing authority such as name & designation of Issuing Authority and its organization contact number and e-mail Id etc. In case the same found not available, Purchaser has right to reject such document from evaluation.

21. **Make in India:** This package is divisible in nature. Minimum Local content for this package is 50%. Margin of purchase preference shall be 20%.
