3. Pre-Qualifying Requirements:

Bidder has to provide the required details as per TECHNICAL PQR (enclosed as NIT Tender Documents) in its Techno-Commercial offer and has to note that bids of only those bidders shall be evaluated who meet the Technical Pre-Qualifying requirements.

4. Bidder has to note that this is a conditional Open Tender enquiry. Price bid (Part-II) opening/RA participation of the bidder is subjected to following:

- 1) Technical PQR Qualification
- 2) Approval by End Customer (M/s TSGENCO)
- 3) Techno-Commercial recommendation by BHEL

6. Delivery Schedule:

a. Stage-I qty. (for Unit-1 & Unit-2) shall be known as Lot-I Qty.

b. Stage-II qty. (for Unit-3, Unit-4 & Unit-5) shall be released in more than one lot (i.e. lot II, lot III...).

Delivery for Lot-I quantities: Supply within Four (04) months from date of approval of primary drawings/ documents in CAT-I or manufacturing clearance issued by BHEL, whichever is earlier. This is subjected to initial submission of drgs./docs. within two weeks from the date of PO as per Technical Specification No.PE-TS-417-507-E004. Vendor to re-submit documents, if any, within 7 days of comments received from BHEL, taking care of all the comments of BHEL/customer. In case, there are delays in submission/resubmission (by vendor) of documents beyond the stipulated time frame indicated above then that much days of delay would be reduced from the delivery period.

Delivery of Lot-II quantities (for Stage II - Unit 3, 4 & 5): Within Four (04) months from date of manufacturing clearance by BHEL. Separate clearance shall be given by BHEL.

Delivery of Subsequent Lots (i.e. Lot III, IV, ...for Stage II - Unit 3, 4 & 5): Within Three (03) months from date of manufacturing clearance by BHEL. Separate clearance shall be given by BHEL.

Note:- Trial Operation date for this project is 16/10/2021. Manufacturing clearance for Stage-2 quantities shall be given on or before Trial Operation Date i.e. 16/10/2021.

7. Evaluation will be done on overall L1 (Total cost to BHEL excluding GST) basis, with necessary loadings as applicable.
8. CIF is not available for this package.
9. PVC is applicable for the subject package. PVC shall be as per Annexure-A.
10. Overall (%) quantity variation: The variation on overall package value due to changes in scope shall be +/- 30% of the total contract value. This will prevail over the quantity variation clause no.6.0 indicated in the GCC rev 06.
11. Additional Overhead Charges shall be 5% instead of 30% as mentioned in clause No. 26.2 of GCC Rev. 06 for risk & purchase clause.
12. The bidder along with its associate/collaborators/sub vendor/subcontractors/sub vendors/consultants/ service providers shall strictly adhere to BHEL fraud Prevention Policy displayed on BHEL website www.bhel.com and shall immediately bring to the notice of BHEL Management about any fraud or suspected fraud as soon as it comes to their notice. BHEL Fraud prevention policy is also uploaded in vendor's section on www.bhelpem.com.
13. In case of joint bidding, Bidders shall be required to furnish scope matrix which should be clearly defined between foreign bidder and their Indian representative along with the offer for the Main Supply.
14. Bidders to note Model Conciliation Clause under BHEL Conciliation Scheme,2018 as available at bhelpem website at Tender Section-Important instruction for Bidders(also enclosed as Tender Documents)
15. Bidder to note: "For this procurement, Public Procurement (Preference to Make in India), Order 2017 dated 15.06.2017 & 28.05.2018 and subsequent Orders issued by the respective Nodal Ministry shall be applicable even if issued after issue of this NIT but before finalisation of contract/PO/WO against this NIT. In the event of any Nodal Ministry prescribing higher or lower percentage of purchase preference and/or local content in respect of this procurement, same shall be applicable. Vendors are requested to go through the above mentioned orders and confirm the following: -
"The local supplier at the time of tender, bidding or solicitation shall be required to provide self-certification that the item offered meets the minimum local content as per above mentioned orders and shall give details of the location(s) at which the local value addition is made."

16. MSE/Start up bidders to submit applicable documents along with their offer for availing the benefits as per GOI guidelines. Further, PEM is directly registered with RXIL(TReDS) Platform. Bidders are requested to get registered with RXIL(TReDS) Platform to avail the facility as per GOI guidelines.
17. Bidders have to indicate the freight charges in percentage of total quoted Ex-Works prices.
18. The bidders (who are not registered with BHEL-PEM)- Online Registration Portal is operational in BHEL. Non-registered bidders, who wish to apply for registration with BHEL-PEM, may apply through Online Registration Portal available at www.bhelpem.com → vendor section → Online Supplier Registration. All credentials and/or documents duly signed and stamped related to registration has to be uploaded on the website and submit the application for registration. One set of hard copy of the filled-up SRF downloaded from Online Registration Portal duly signed and stamped has to be submitted.
19. BHEL reserves the right to go for Reverse Auction (RA) (Guidelines as available on www.bhel.com) instead of opening the price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. Bidders to give their acceptance with the offer for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.

Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'Process compliance form' (to the designated service provider) as well as 'Online sealed bid' in the Reverse Auction. Non-submission of 'Process compliance form' or 'Online sealed bid' by the agreed bidder(s) will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines for suspension of business dealings with suppliers/contractors (as available on www.bhel.com).

The bidders have to necessarily submit online sealed bid less than or equal to their price bid already submitted to BHEL along with the offer. ***The price bid of successful L1 bidder in RA, if conducted, shall also be opened after RA and the order will be placed on lower of the two bids (RA closing price & submitted price bid price) thus obtained. The bidder having submitted this offer specifically agrees to this condition and undertakes to execute the contract on thus awarded rates.***

If it is found that L1 bidder has quoted higher in online sealed bid in comparison to submitted price bid for any item(s), the bidder will be issued a warning letter to this effect. However, if the same bidder again defaults on this count in any subsequent tender in the unit, it will be considered as fraud and will invite action by BHEL as per extant guidelines for suspension of business dealings with suppliers/contractors (as available on www.bhel.com)."

"The Bidder has to quote the Single Price (i.e. Total Cost to BHEL availing input tax credit & excluding GST) in Reverse Auction. Price are to be inclusive of Packing & Forwarding charges, all the routine & type tests as per tender scope, Freight as applicable, including loading & cost of withdrawal (if any).".

20. Bidders have to note that Deviations from NIT are generally not acceptable. Deviations, if any, are to be listed out clearly, as per Annexure-II, of GCC Rev 06, in techno-commercial offer. Any deviation mentioned or shown separately or found hidden in offer, will not be taken cognizance of.

In case of deviations from NIT, the bidder shall give the cost of withdrawal of such deviation in Price Bid, as per Annexure-II, Deviation Sheet (Cost of Withdrawal) of GCC Rev-06. For multiple deviations, all deviations are to be mentioned in "Deviation Sheet" and "cost of withdrawal" must be mentioned separately against each deviation.

21. Foreign and indigenous bidders participating in subject tender will necessarily have to buy class III DSCs (Digital Signature Certificate) issued by the certifying authorities in India. Basic procedure /checklist is uploaded on "www.bhel.com" for participating in future tender enquires through e procurement.
22. L1 bidder has to submit BG as per format enclosed with Enquiry Letter(NIT) instead of format mentioned in GCC, Rev.06.
23. MSE bidder has to declare UAM number on CPPP, failing which such bidder will not be able to enjoy the benefits as per Public Procurement Policy for MSEs order 2012.

25. Foreign bidders will have to quote C&F (cost & freight) basis. For importing materials on C&F basis, bidders to note following:
- As per Incoterms (CFR), risk transfers to buyer when the goods have been boarded on the ship in the country of Export. Hence, shipped on board date mentioned on the clear Bill of Lading or Air way Bill, shall be treated as the date of Shipment/ Dispatch for all contractual purposes including calculation of LD.
 - Usance period (90 days) of the L/C shall start from the date of Bill of lading/Air Way Bill.
 - Bill of Lading shall be considered as equivalent document (refer clause 9.7.1 b of GCC rev.06) for recognition of dispatch.
 - For claiming payment under clause 9.1.1 and 9.2.1 of GCC rev.06, Bill of lading shall be considered instead of receipted LR (refer clause 9.7.2 b of GCC rev.06).
 - Freight is to be quoted as inclusive in basic price by vendor and is not to be quoted separately.
 - Insurance for evaluation purposes shall be @ 0.1 % of quoted C&F price.
26. Bid should be free from correction, overwriting, using corrective fluid etc. Any interlineation, cutting, erasure or overwriting shall be valid only if they are attested under full signature(s) of person(s) signing the bid else bid shall be liable for rejection.
