2.2 Bidders to note that offers shall be submitted strictly in accordance with the requirements of the above tender documents. Deviations (Technical as well as Commercial), if any, shall be listed out clearly with their techno-commercial offer in the annexure-II of GCC Rev-06 only.

2.6 Tenderers must enclose the Quality Plan in the prescribed format, for approval. Material will be despatched only after Purchaser's/Owner's inspection at the hold points specified in the approved Quality Plan and issue of Material Despatch Clearance Certificate (MDCC).

2.7 Late tenders will be rejected.

2.8 **Delivery Schedule:**

For Main Supply including Sump Model Study: Delivery completion shall be within SIX (06) months from the CAT-I approval of drawing/documents or from the date of manufacturing clearance, whichever is earlier.

Drawings/documents submission/ resubmission schedule shall be as per Cl no. 6.0 of sub-section IA of Section-I of technical specification no. PE-TS-421-100-N001 (Rev01). Delay in submission/ resubmission of drawings/documents shall be reduced from delivery period.

Mandatory spares: - Mandatory spare to be supplied within four (04) months from manufacturing clearance by BHEL-PEM. Separate dispatch/ manufacturing clearance will be issued for Mandatory Spares.

Installation checks & PG Test:- Vendor shall depute their personnel within 30 days of intimation by BHEL. Beyond this period LD shall be applicable as per GCC Rev06.

2.9 All vendors participating in an open tender shall be required to meet the PQ criteria irrespective of their being registered/ not registered with BHEL, failing which offer of such vendor(s) shall be rejected. Price bid (Part-II) opening/Reverse Auction is subject to the following: -

b) **Approval of bidder by Customer (who are not approved by customer):** Approval shall be taken up by BHEL with customer based on the credentials/reference list. Hence, bidders to submit the credentials as per format given in NIT for submission of bidders credentials.

c) **Bidders, who are approved by NTPC in any NTPC/BHEL project for subject package, shall be considered as approved by end customer for this tender subject to the fulfilment of the conditions, if any, mentioned in the NTPC approval letter. Bidder must furnish their NTPC approval letter for subject package in lieu of the credentials mentioned at S.No. (b) above.**

Online Registration Portal is operational in BHEL. Non-registered Vendors, who wish to apply for registration with BHEL-PEM, have to apply through Online Registration Portal available at www.bhelpem.com ' vendor section ' Online Supplier Registration. 2.10 Prices are firm. PVC is not applicable for this tender.

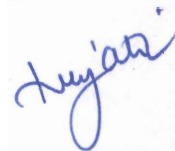
2.11 Quantity Variation:

Overall (%) variation in contract value due to changes in the scope shall be limited to +/- 10%, which will prevail over the quantity variation clause no.6.0 indicated in the GCC rev. 06.

2.12 "BHEL reserves the right to go for Reverse Auction (RA) (Guidelines as available on www.bhel.com) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. Bidders to give their acceptance with the offer for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.

Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'Process compliance form' (to the designated service provider) as well as 'Online sealed bid' in the Reverse Auction. Non-submission of 'Process compliance form' or 'Online sealed bid' by the agreed bidder(s) will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines for suspension of business dealings with suppliers/contractors (as available on www.bhel.com).

The bidders have to necessarily submit online sealed bid less than or equal to their envelope sealed price bid already submitted to BHEL along with the offer. 2.13 Evaluation will be done on overall L1 (Total cost to BHEL) basis. Evaluation shall be done excluding GST quoted by bidders.

2.14 Available Pump Drive HT motors:

HT motors for Raw Water Pumps have been manufactured considering the corresponding pump requirements and same cannot be altered now. Further the GA & T-S curve for HT motors are attached as Annexure-A in technical specifications. Bidder to select offered pumps so that these HT motors are compatible to offered pumps.

2.15 Separate POs would be placed for Main Supply, Mandatory Spares & Service Activities.

2.16 Guarantee period for this tender shall be till 23/08/2023.

2.17 Successful bidder shall abide by all Applicable Laws, Rules and Regulations of Bangladesh relating to the execution of contract and performance of work. Successful bidder shall obtain and maintain all consents, permits and licenses that are required under Applicable Laws of Bangladesh.

2.18 Payment terms shall be as follows:

- For Supply of Pump: As per cl no. 9.2 of GST related corrigendum to GCC rev-06.
- For Supply of Mandatory Spares: As per cl no. 9.1 of GST related corrigendum to GCC rev-06.

2.20 As per Govt. notification regarding applicable GST for exports shall be as follows:

2.21 If any bidder has mentioned the term **Not Applicable / Not Require / Not Quoted** in BHEL price format. Hence bidder to need to substantiate the same. If the same item will require in future for the system same will be supplied free of cost.

2.22 Indigenous bidders need to indicate the freight charges in percentage of total Ex-works in unpriced format.

2.23 Freight value quoted by any bidder as NIL/Inclusive then the Freight value as derived by BHEL at Average of % freight in last 03(min.) identical purchases for the similar/identical package (after deloading service tax portion, if any) wherever freight charges are available shall be considered for evaluation.

2.24 Foreign and indigenous bidders participating through open tender will necessarily have to buy class III DSCs issued by the certifying authorities in India for future tenders. 2.27 Foreign Bidders will have to quote C&F (Cost & Ocean Freight) basis instead of FOB as per following terms & conditions:

- a) As per Incoterms (CFR), risk transfers to buyer when **the goods** have been loaded on board the ship in the country of Export. Hence, shipped on **board date** mentioned on the clean Bill of Lading or Air way Bill, shall be treated as the date of Shipment/ Dispatch for all contractual purposes including calculation of LD.
- b) Usance period (90 days) of the L/C shall start from the date of Bill of lading/Air Way Bill.
- c) Bill of Lading shall be considered as equivalent document (refer clause 9.7.1 b OF GCC rev-06) for recognition of dispatch.
- d) For claiming payment under clause 9.1.1 and 9.2.1 Bill of lading shall be considered instead of receipted LR (refer clause 9.7.2 b of GCC rev-06)
- e) Freight is to be quoted as inclusive in basic price by vendor and is not to be quoted separately.
- f) Insurance for evaluation purposes shall be @ 0.1 % of quoted C&F price.
- g) There will be no change in MRC payment. In case MRC is not received within 120 days from the date of Bill of lading, Bill of lading shall be treated as MRC for vendor payment purpose. Accordingly, 10% MRC payment shall be made within 180 days from the date of Bill of lading/Air way bill.
