12. **Bidder to note that this is a conditional Open tender enquiry for non BHEL registered bidders and non-approved bidders by customer. Hence, price bid (Part-II) opening/RA shall be subject to following criterion:**

14. **Delivery Schedule: -**

Equipment Supply: Delivery schedule shall be four (4) months from the date of Approval of PRIMARY documents in Cat-I by BHEL/customer subject to bidder's first submission of primary documents within two weeks from the date of LOI/PO & subsequent revision within 10 days of BHEL comments. Any deficiency in the document w.r.t. agreed specification/comments from BHEL shall be treated as non-submission and No. of days delay in submission/resubmission of complete documents during approval process, on account of this, would be reduced from the delivery.

Document submission/resubmission schedule after award of contract shall be as indicated in Cl. No. 3.1, Section I of technical specification No. PE-TS-425-615-C001, Rev 0. Primary documents are those documents which affects the Manufacturing/delivery directly, hence primary documents shall be considered for LD calculation. Secondary documents are those documents which do not affects the Manufacturing/delivery directly.

Supervision of E&C: Supplier has to deploy its Service Engineer / Supervisor at project site within 15 days of BHEL intimation.

15. Pre-Qualifying Requirements: Bidders have to provide the required details as per PRE-QUALIFICATION REQUIREMENT CRITERIA (enclosed as NIT Tender Documents) in their Techno-Commercial offer. Bids of only those bidders shall be evaluated who meet the Pre-Qualifying requirements.
16. Bidders are requested to refer Performance Bank Guarantee (PBG) format & rules and adhere to it while furnishing PBG.
17. BHEL reserves the right to go for Reverse Auction (RA) (Guidelines as available on www.bhel.com) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. Bidders to give their acceptance with the offer for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.

Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'Process compliance form' (to the designated service provider) as well as 'Online sealed bid' in the Reverse Auction. Non-submission of 'Process compliance form' or 'Online sealed bid' by the agreed bidder(s) will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines for suspension of business dealings with suppliers/ contractors (as available on www.bhel.com).

The bidders have to necessarily submit online sealed bid less than or equal to their envelope sealed price bid already submitted to BHEL along with the offer. The envelope sealed price bid of successful L1 bidder in RA, if conducted, shall also be opened after RA and the order will be placed on lower of the two bids (RA closing price & envelope sealed price) thus obtained. The bidder having submitted this offer specifically agrees to this condition and undertakes to execute the contract on thus awarded rates.

If it is found that L1 bidder has quoted higher in online sealed bid in comparison to envelope sealed bid for any item(s), the bidder will be issued a warning letter to this effect. However, if the same bidder again defaults on this count in any subsequent tender in the unit, it will be considered as fraud and will invite action by BHEL as per extant guidelines for suspension of business dealings with suppliers/ contractors (as available on www.bhel.com)."

type tests as per tender scope, Freight charges, Insurance charges (if applicable), Goods & Service Tax as applicable etc., including loading (if any) as applicable.

18. Prices are firm.
19. The variation on overall package value due to changes in the scope shall be limited to +/-25%. This will prevail over the quantity variation clause no.6.0 indicated in the GCC rev 06.
20. Payment term for design engineering charges is as follows: -
"100% on certification from engineering on completion of design & Engineering works" and along with bill of supply Payment.
21. CIF allocation is not available for this package
22. If any bidder uploads price bid in the unpriced section (techno-commercial attachment page) of the tender in e-procurement, in that case bidder(s) shall only be responsible for such mistake and any consequences thereof. Hence all bidders are requested to be more careful at the time of uploading the Unpriced and Price Bid for Part-I and Part-II respectively to avoid mismatch
23. All the above Tender Documents shall automatically become a part of the Order/Contract after its finalisation.
24. Evaluation will be done on overall L1 (Total cost to BHEL) basis. GST shall not be considered for evaluation.
25. The offers of the bidders who are on the banned list and also the offers of the bidders, who engage the services of the banned firms, shall be rejected. The list of banned firms is available on BHEL website <http://www.bhel.com>.
26. 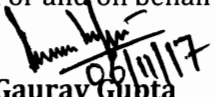
