13. Risk and Cost Purchase: - 5% overhead charges to be considered instead of 30% (presently in GCC Rev 06 clause no 26.2(b)).
14. The nature of package is "Non Divisible" & local content applicable for this package is 100%.
15. Bidders are requested to refer following clause regarding Public Procurement (Preference to Make in India) - PPP-MII.

IMPORTANT INSTRUCTION TO BIDDERS IN CASE OF REVERSE AUCTION

The Bidders has to quote the Single Price (i.e. **Total Cost to BHEL i.e. Grand total FOR site excluding GST**) in Reverse Auction. Price are to be inclusive of Packing & Forwarding charges, all the routine & type tests as per tender scope, Freight charges, Insurance charges (if applicable), Cost of withdrawal (if any), including loading (if any), De-loading (if any) shall be done in line with NIT terms

23. H1 bidder (whose quote is highest in online sealed bid) will not be allowed to participate in further RA process.
24. **Overall (%) variation in contract value:** The variation on overall package value due to changes in the scope shall be limited to +/- Zero (0) %. This will prevail over the quantity variation clause no.6.0 indicated in the GCC rev 06.
