- 4.11 Delivery Schedule: - **Main Supply:** Material shall be cleared for manufacturing lot wise based upon Engineering progress and site requirement. Supply of each lot shall be completed by vendor within four (04) months from Lot clearance from BHEL. Drawing/documents submission shall be as per ANNEXURE-D (Documents submission schedule) of SECTION I VOLUME II of technical specifications of Bhadradri Project and every re-submission of drawing/documents within 7 days from the date of BHEL comments incorporating all the comments. Delay, if any will be attributed to respective accounts.
- Supervision of E&C:** Vendor shall depute their representative to project site for Supervision of Erection and Commissioning within 15 days of BHEL intimation.
- Mandatory spares:** Delivery shall be four months from the date of manufacturing clearance by BHEL.

4.12 "BHEL reserves the right to go for Reverse Auction (RA) (Guidelines as available on www.bhel.com) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. Bidders to give their acceptance with the offer for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.

Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'Process compliance form' (to the designated service provider) as well as 'Online sealed bid' in the Reverse Auction. Non-submission of 'Process compliance form' or 'Online sealed bid' by the agreed bidder(s) will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines for suspension of business dealings with suppliers/ contractors (as available on www.bhel.com).

The bidders have to necessarily submit online sealed bid less than or equal to their envelope sealed price bid already submitted to BHEL along with the offer. The envelope sealed price bid of successful L1 bidder in RA, if conducted, shall also be opened after RA and the order will be placed on lower of the two bids (RA closing price & envelope sealed price) thus obtained. The bidder having submitted this offer specifically agrees to this condition and undertakes to execute the contract on thus awarded rates.

If it is found that L1 bidder has quoted higher in online sealed bid in comparison to envelope sealed bid for any item(s), the bidder will be issued a warning letter to this effect. However, if the same bidder again defaults on this count in any subsequent tender in the unit, it will be considered as fraud and will invite action by BHEL as per extant guidelines for suspension of business dealings with suppliers/ contractors (as available on www.bhel.com)."

4.13 **All vendors participating in an open tender shall be required to meet the Financial and Technical PQR criteria irrespective of their being registered/ not registered with BHEL, failing which offer of such vendor(s) shall be rejected. - (iii) Performance Certificates for satisfactory working of the system /equipment's.
- (iv) Copies of major supply order executed by the vendor.

4.14 Payment terms:

Payment of basic price of material supplied, along with freight & GST shall be paid against receipt of material at site on pro-rata basis. 15% of basic price of materials supplied will be retained as security deposit which will be released on pro – rata basis as per details below:

- a) 10% will be released on pro-rata basis after submission of Material Receipt Certificate (MRC) from project site engineer of owner/purchaser. For obtaining MRC from project site/ owner, vendor shall depute their representative to project site. Packages shall be opened at site in presence of vendor representative for verification of material supplied. If any material found damaged/ short supplied during verification, then Vendor shall be responsible for replenishment.
- b) 5% will be released after submission of As Built drawings prepared by vendor subsequent to inspection of installation, handover of installation and receipt of "as built marked up" drawings from site. BHEL site engineer shall arrange for joint inspection of the installation by purchaser's and customer's representative for completeness and correctness of work. Any defect pointed out during such inspection, revised drawing(s) for corresponding design of lighting system shall be promptly issued by vendor. Vendor shall be responsible for their design till completion of work and handing over to end client.

Payment terms for supervision of E&C are as under:

-100% payment shall be released after successful completion of the activity, on Site certification.

4.15 Quantity Variation:

- i). Overall quantity variation shall remain as +/- 30% of total order value in line with clause no. 6.0 of GCC REV-06.
- ii). Quantity released (in Lots) upto 100% of contract value shall be intimated within 02 years from date of original P.O.
- iii) Qty variation of supply and supervision of E&C upto 30% of order value may exceed.
- iv). Price Shall remain firm for supply as well as Supervision of E&C till completion of contract.

4.16 Evaluation shall be done item wise excluding GST quoted by bidder.

4.17 CIF is not available for this tender.

4.18 Foreign and indigenous bidders participating through open tender will necessarily have to buy class III DSCs issued by the certifying authorities in India for bid submission. Basic procedure /checklist has been upload on www.bhel.com for participating in future tender enquires through e procurement.

4.19 MSE suppliers can avail the intended benefits only if they submit, attested copies of either EM II certificate having deemed validity (Five years from the date of issue of acknowledgement in EM II) or valid NSIC certificate or EM II certificate along with attested copy of CA certificate applicable for

the relevant financial year (latest audited). Documents should be notarized or attested by a Gazetted Officer. Bidder to also note that MSEs who submit registration certificate or register themselves after placement of PO shall also be given payment preference as per MSMED-Act 2006.

- 4.20 Indigenous bidders need to indicate the freight charges in percentage of total Ex-works in unpriced format.
- 4.21 All the tender documents shall automatically become a part of the Order/Contract after its finalization.
- 4.22 The bidder along with its associate/collaborators/sub vendor/subcontractors/sub vendors/consultants/ service providers shall strictly adhere to BHEL fraud Prevention Policy displayed on BHEL website <http://www.bhel.com> and shall immediately bring to the notice of BHEL Management about any fraud or suspected fraud as soon as it comes to their notice. - 4.28 As per Incoterms (CFR), risk transfers to buyer when the goods have been loaded on board the ship in the country of Export. Hence, shipped on board date mentioned on the clean Bill of Lading or Air way Bill, shall be treated as the date of Shipment/ Dispatch for all contractual purposes including calculation of LD.
- 4.29 Usance period (90 days) of the L/C shall start from the date of Bill of lading/Air Way Bill.
