Please refer to GCC Rev. 07 (available at <http://10.51.1.22:1024/GCC/GCCRev07.pdf> OR <https://www.bhelpem.com/Documents/GCC/GCCRev07.pdf>) Bidders are requested to go through the same while submitting the offer.

1. Pre-Qualifying Requirements:

Bidders have to provide the required details as per TECHNICAL PQR in their Techno-Commercial offer and has to note that bids of only those bidders shall be evaluated who meet the Technical Pre-Qualifying requirements.

2. Bidders have to note, "For this procurement, The Local Content to categorize a supplier as class I local supplier/ Class II Local supplier/ Non-Local Supplier and purchase preference to class I local Supplier, is as defined in Public Procurement (Preference to Make in India), order 2017 dtd. 04.06.2020 issued by DPIIT. In Case of subsequent orders issued by the nodal ministry, changing the definition of local content for the items of the NIT, the same shall be applicable even if issued after issue of this NIT, but before opening of Part-II bids against this NIT". Clause no 26 of (ITB) GCC REV. 07 is not applicable in view of above.

Following may also pls. be noted by the bidders:

- Min. Local content for subject tender is 74%
- Tendered package is divisible
- Margin of purchase preference shall be 20%.

3. The bidder has to note that this is a conditional tender enquiry. Price bid (Part-II) opening of the bidder is subjected to following:

- Approval of make of equipment by BHEL/Customer.
- Techno-Commercial recommendation by BHEL.
- Qualification of Technical PQR.

4. This item/package /system falls under the list of items defined in para 3 of ministry of finance guideline dtd. 20.09.16 (Procurement of items related to Public safety, Health, Critical Security operations & Equipments etc.) & hence criteria of prior experience/Turnover shall be same for all the bidders including startup/MSME.

5. Bidders have to note that Department of Expenditure's (DOE) Order (Public Procurement No. 1 and No. 2) vide ref. F. No.6/18/2019-PPD dated 23/07/2020 is applicable to subject tender. Bidders have to go through Annexure-B (of this NIT letter) and to note that same forms the part of NIT. Accordingly, a bidder has to bid as per the provisions of above referred DOE's order/s & **Annexure-B.**

6. All bidders to comply Govt. of India, Ministry of Power, Order No. 25-111612018-PG dtd. 02.07.2020 regarding imported items/ equipment's/ components.

7. In case of joint bidding, Bidders shall be required to furnish scope matrix which should be clearly defined between them along with the offer for complete scope of quoted items as per NIT.
8. Bidders have to note that following forms the part of Tender Documents:

 - Technical PQR
 - Price format
 - Special Conditions of Contract (SCC of project)

Bidders to note that offers shall be submitted strictly in accordance with the requirements of the above Tender Documents & all the above Tender Documents along with post-bid agreements/MoMs (during Techno-Commercial evaluation) shall automatically become the part of the Order/Contract after its finalisation.

9. DELIVERY TERMS:

Delivery Schedule: Within Four (04) months from date of CAT-1 approval of Primary drawing/documents or BHEL manufacturing clearance whichever is later. In case date of CAT-1 approval of Primary drawing/documents is later than the date of BHEL manufacturing clearance then for delay analysis, any delay in submission/re-submission of Primary drawing/documents shall be reduced from the given delivery period of 04 months. Delay in BHEL's comments/approval beyond 18 days shall also be considered for delay analysis. In case BHEL manufacturing clearance date is later than date of cat-1 approval of Primary drawing/documents, then for delay analysis submission/re-submission time of Primary drawing/document shall not be considered. - B. The delivery conditions specified are for contractual LD purposes, however BHEL may ask for early deliveries without any compensation thereof.
- C. Non-applicable drawings shall be decided during execution of the package.
- D. Wherever schedule of drawings/documents submission/ re-submission is stipulated in the Technical Specifications, same shall be superseded by delivery specified in NIT.
- E. Bidders have to note the following also: -
- a. Bidder has to submit detailed 'bill of material' (BoM) at the time of drawing/document submission after placement of PO. Each item of the BoM to be uniquely identified with item code no. or item serial no.
 - b. Supplier to ensure that all items which will find separate mention in the packing list are covered in this detailed BoM.
 - c. Supplier to also give the following undertaking in the BOM:
"The BOM provided herewith completes the scope (in content and intent) of material supply under PO No. -----, dated -----with NIT terms.

Supplier has to made first submission of BoM within 30 days of CAT-I or CAT-II approval of primary documents, whichever is earlier and subsequent revision within 10 days of BHEL comments. BoM shall be considered as Secondary Document.

10. Evaluation will be done item-wise on total cost to BHEL, excluding GST with necessary Loading/s (as applicable).
11. Site demonstration & handing over charges shall be as per Annexure -I of volume IIB, section II of Technical Specification # PE-TS-411-556-E003 R03 & are exclusive of GST. These Site demonstration & handing over charges will not be part of evaluation. Price of one visit and one day shall be considered for ordering for each vendor for Site demonstration & handing over in line with rates specified in technical specification.
12. Overall (%) quantity variation: The variation on overall package value due to changes in the scope shall be 0%.
13. Bidders to ensure that Third party/Customer issued certificates being submitted as proof of PQR qualification should have verifiable details of documents/certificate issuing authority such as name & designation of issuing authority and its organization contact number and e-mail id etc. In case the same found not available, purchaser has right to reject such document from evaluation.
14. CIF is not applicable for this package.
15. BHEL shall be finalizing this tender with price bid opening and will not be conducting Reverse Auction. Vendors to quote suitably.

17. Prices shall be Firm till completion of contract.
18. The bidders who are not registered with BHEL-PEM may apply for registration in BHEL-PEM through Registration Portal available at www.bhelpem.com-->vendor section-->online supplier registration. All credentials and/or documents duly signed & stamped related to registration has to be uploaded on the website & submit the application for registration. One set of hard copy filled-up SRF downloaded from Online Registration Portal duly signed & stamped has to be submitted.
19. If any bidder uploads price bid in the unpriced section (techno-commercial attachment page) of the tender in e-procurement, in that case bidder(s) shall only be responsible for such mistake and any consequences thereof. Hence all bidders are requested to be more careful at the time of uploading the Unpriced and Price Bid for Part-I and Part-II respectively to avoid mismatch.
20. Bidders have to note that Deviations from NIT are generally not acceptable. Deviations, if any, are to be listed out clearly, as per Annexure-II (Deviation Sheet – Cost of Withdrawal), of GCC Rev 07, in techno-commercial offer. Any deviation mentioned or shown separately or found hidden in offer, will not be taken cognizance of.

In case of deviations from NIT, the bidder shall give the cost of withdrawal of such deviation in Price Bid, as per Annexure-II, Deviation Sheet (Cost of Withdrawal) of GCC Rev-07. For multiple deviations, all deviations are to be mentioned in “Deviation Sheet” and “cost of withdrawal” must be mentioned separately against each deviation.

21. MSE Bidder has to declare UAM number on CPPP, failing which such bidder will not be able to enjoy the benefits as per Public Procurement Policy for MSEs order 2012.
22. All terms & conditions shall be as per NIT, SCC of Project & GCC Rev. 07. In the event of any contradiction in the terms and conditions mentioned, the order of preference shall be as mentioned in cl.no. 36 of GCTC of GCC Rev. 07.
