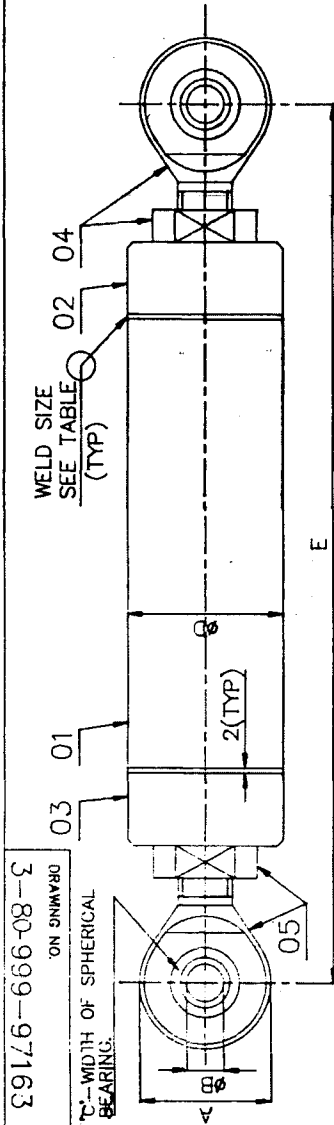

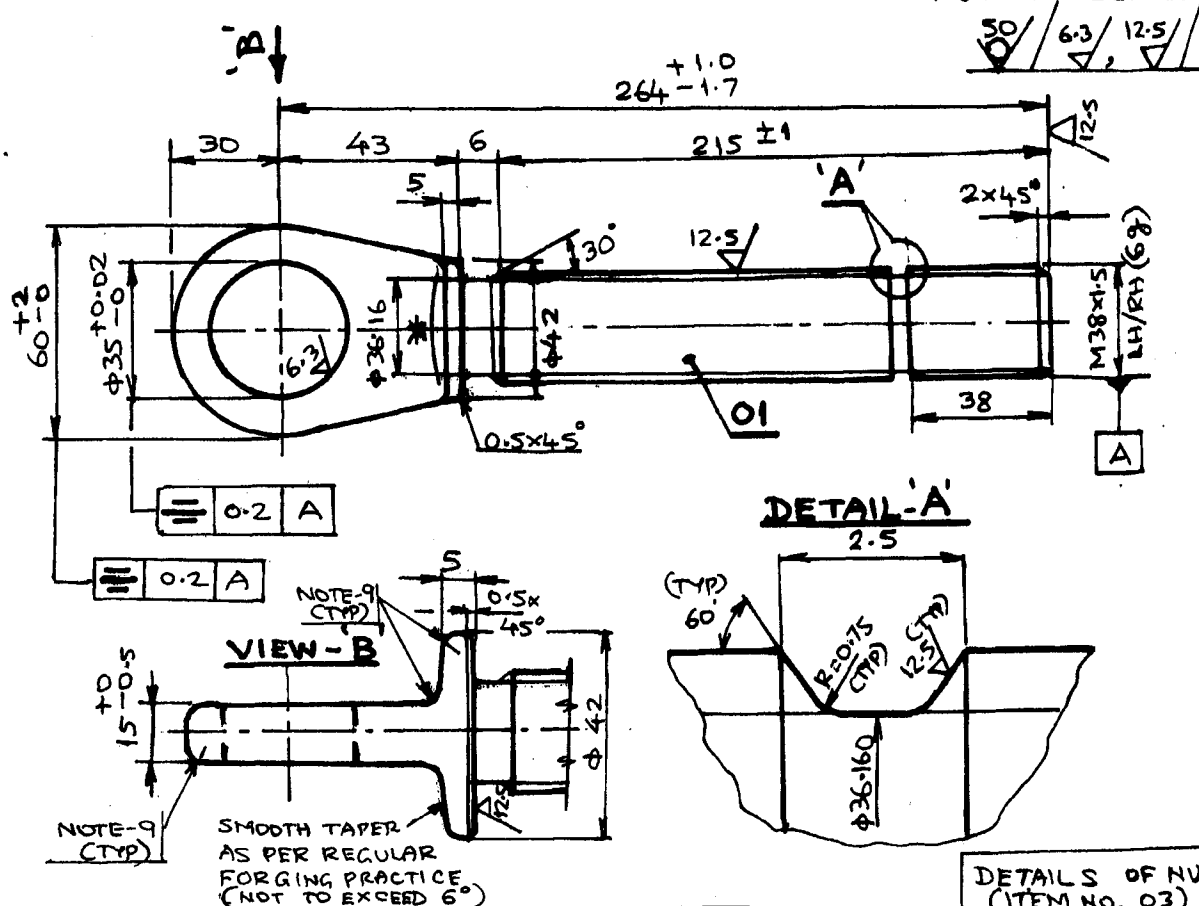

11 Special Provision for Micro and Small Enterprises (MSE): Applicable for INDIAN Manufacturers only:
