EARNEST MONEY DEPOSIT (EMD):

- 3.1 Every tender Must be accompanied by the prescribed amount of Earnest Money Deposit in any one of the following forms:

- 4.4 Regarding adjustment of Earnest Money Deposit towards part of Security Deposit, refer clause 4.2 above, the successful tenderer shall not commence any work under the contract before remitting the Security Deposit except as directed by BHEL.

4.7 **Collection of Security Deposit:**

- 4.7.1 The successful tenderer shall have to furnish a Security Deposit Bank Guarantee (SDBG) for an amount of 5% of the total P.O. value in the prescribed format within 10 (Ten) days from the date of placement of Letter of Intent. SDBG shall be from Consortium Banks of BHEL/ from a reputed Bank and confirmed by any consortium Bank of BHEL/ Schedule Banks/Public Financial Institutions as defined in the Companies Act. All Bank charges on account of issuance and confirmation of SDBG whether incurred in India or outside India will have to be borne by the vendor.
- SDBG shall be submitted by vendor within 10 (Ten) days from the date of placement of Letter of Intent & to be kept valid up to completion of supply.
- 4.7.2 If the value of the work done at any time exceeds the accepted agreement value, the Security Deposit shall be correspondingly enhanced and the additional Security Deposit shall immediately be deposited by the contractor or recovered from payments due to the contractor.
- 4.7.3 The recoveries made from running bills (cash deduction towards balance SD amount) can be released against submission of equivalent Bank Guarantee in acceptable form, but only once, before completion of work, subject to approval of BHEL.
- 4.7.4 Security Deposit should cover up to the period of guarantee also.

4.9 Return of Security Deposit:

If the contractor duly performs and completes the contract in all respects to the entire satisfaction of BHEL, and presents an absolute "No Demand Certificate" in the prescribed form and return properties belonging to BHEL handed over, lent or hired by him for carrying out the said works the security deposit will be released to the contractor after deducting all costs or expenses or other contracts entered into with the contractor, only after the satisfactory completion or guarantee period.

4.10 No interest shall be payable by BHEL on Earnest Money / Security Deposit or any money due to the contractor from BHEL.

4.11 In no case Security Deposit can be released before settling all claims under this contract.

17.0 Taxes and duties shall be as per tender.

18.0 Bidders are required to submit their BEST price as per tender Price Schedule format in e-procurement portal/platform in the form & manner as mentioned in tender.

19.0 Overwriting or erasures should be avoided. If however, they exist they must be invariably attested.

20.0 "BHEL reserves the right to go for Reverse Auction (RA) (Guidelines as available on www.bhel.com) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno- commercial evaluation. Bidders to give their acceptance with the offer for participation in RA. Non- acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.

21.0 Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'Process compliance form' (to the designated service provider) as well as 'Online sealed bid' in the Reverse Auction. Non-submission of 'Process compliance form' or 'Online sealed bid' by the agreed bidder(s) will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines for suspension of business dealings with suppliers/ contractors (as available on www.bhel.com).
