1. Rate contract on firm price basis for 2 year from placement of Rate Contract PO will be done with a provision for further extension after review on mutual consent.

Two rate contracts (one as per BOQ Annexure IIIA with CIF and other as per BOQ Annexure IIIB without CIF) are proposed to be done with the L1 vendor for 100% value at L1 FOR site price. However, ordering against respective project under RC is subject to customer approval. 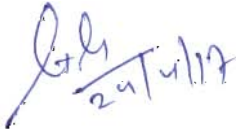
