PRE-QUALIFICATION REQUIREMENTS (TECHNICAL) FOR EOI OF RESIN ROPE

1. **ITEM DESCRIPTION:** Polyester Resin Rope (PRR) or Epoxy Resin Rope (ERR) consists of a bundle of Glass Fibres or sleeves enclosed in a braided polyester fibre sleeve impregnated with a binder mixture containing Unsaturated Polyester resin or Epoxy Resin system with suitable fillers. It is used as soft packing in the overhang of stator winding of Turbo-Generator for consolidation of the overhang. The rope is to be supplied in different diameters 10mm / 15mm / 20mm / 25mm. The Resin Rope shall be uniformly filled/ impregnated and be formable & flexible. For Polyester Resin rope, the fibres shall be stretched besides one another and be lightly twisted. For Epoxy Resin Rope, there shall be preferably three layers of braiding one above the other. The resin Rope is in B stage when supplied & cures on heating at 80°C for 15hrs. After curing the material at 80°C for 15hrs, the material must give a compressive strength of >40N/mm² at Room Temperature & a Glass Transition value of >70°C (Polyester Resin Rope) & >80°C (Epoxy Resin Rope). Compression Strength at 80°C must be >40% of compression strength value at Room Temperature. The cured material shall be blister free.
2. **EXPERIENCE:** The vendor should have manufactured and supplied Resin Rope for Turbo-generators to reputed power plant equipment manufacturers world-wide during the last 7 years. The supplied material should have following properties:
SHELF LIFE: The properties of the material must be guaranteed even after a 3-month storage at temperature ≤12°C for Polyester Resin Rope and 6-month storage at temperature ≤12°C for Epoxy Resin Rope.
In support of which, vendor to submit the following documents: -
 - a) Vendor should have manufactured and supplied the above material against at least 2 Purchase Orders in last 7 years from the date of enquiry. Vendor to furnish copies of Purchase Orders of the same.
 - b) Vendor to furnish Test Certificates (for dimensional, mechanical and electrical test, etc.) for the Purchase Orders furnished against Clause a).
 - c) End User Certificate: Vendor to furnish at least one Certificate from End User or Generator Manufacturer certifying that Polyester Resin Rope (PRR) or Epoxy Resin Rope (ERR) supplied by the vendor has been successfully used in manufacturing of Turbo-Generator rotor and the said Turbo-generator has been in operation for at least 1 year. The End User Certificate should be pertaining to any one of the above Purchase Orders.
3. **MANUFACTURING FACILITY:** The Vendor to confirm that they have all the in-house facilities for manufacturing this item.
4. **TESTING FACILITIES:** The Vendor to confirm that they have all the in-house facilities for testing this item. If the vendor intends to outsource any testing activity, particulars of the same along with details of the laboratory to be furnished to BHEL.
Notes:
 1. BHEL reserves the right to verify the information submitted by the vendor. In case the information is found to be false or incorrect, the offer shall be rejected.
 2. All the documents should be furnished in English language only. If the documents are not in English, then they must be accompanied by duly certified English translations of the same.
