**PRE-QUALIFICATION REQUIREMENTS (TECHNICAL) FOR**  
**ROTOR SLOT WEDGES**

**1. EXPERIENCE:**

1.1. The vendor should have manufactured and supplied COLD DRAWN & HEAT TREATED ROTOR COPPER WEDGE profiles of material grade CuCo2BeZr having 0.2% Proof Strength of 550 N/mm<sup>2</sup> min. for large size Turbo-generators (rating > 210 MW) to reputed power equipment manufacturers world-wide for at least last 3 years. Vendor to furnish copies of Purchase Orders executed for copper wedges. Also vendor to provide documentary evidence of the acceptance of material like Acceptance Certificate or letter from customer.

1.2. Vendor to give annual production capacity and output in MT for the last 3 years along with customer-wise break-up for Rotor Copper Wedges.

2. **MANUFACTURING FACILITIES:** The vendor should have facilities for manufacturing rotor copper wedges like bar casting, extrusion, heat treatment, cold drawing, etc. Vendor to furnish details (including make, model and year of manufacture) and technical specifications of the manufacturing facilities available at their works along with photographs.

3. **MANUFACTURING PLAN:** Vendor to provide detailed Manufacturing Plan of wedges giving particulars of the manufacturing processes including heat-treatment cycle.

**4. TESTING ACILITIES:**

4.1. The vendor should have facilities for carrying out the following tests and provide details (including make and year of manufacture) of test equipment available at their works:

- a) Chemical Composition
- b) Mechanical Testing
- c) Electrical Conductivity
- d) Dimensional measurement & straightness checking

The testing facilities should be duly calibrated against measurement standards traceable to national or international measurement standards.

4.2. The vendor should have facilities and qualified personnel for carrying out Non-Destructive Tests such as Ultrasonic Testing and Dye Penetrant testing and should provide details of the same.

5. The vendor should furnish copies of Test Certificates of previously supplied material.

6. The vendor shall source the raw material from reputed suppliers and shall furnish details of the same to BHEL along with Mill Test Certificate.

7. If the vendor plans to outsource any activity/testing, particulars of the same along with details of the sub-vendor/laboratory to be furnished to BHEL.

8. BHEL reserves the right to verify the information submitted by the vendor. In case the information is found to be false or incorrect, the offer shall be rejected.

9. These pre-qualification requirements are not applicable for registered vendors of BHEL for this item.
