Annexure B

General Eligibility criteria for applying new vendor registration

S.No	Eligibility Criteria
1	The vendor should be a <u>MANUFACTURER</u> of the product.
2	Vendor should have been in <u>continuous business of the product for minimum 3 years.</u> Benefits for start-up will be given as per the guidelines issued by Government of India
3	The vendor should <u>not have been referred to BIFR/NCLT</u> /any other negative feedback from other Government agency.
4	In case the vendor is a foreign vendor, <u>the D&B report</u> with complete details shall be produced.
5	Benefits for MSE vendors will be given as per MSME act.

Product specific requirement will be obtained at the time of evaluation of vendor application.

Note: The eligible vendor shall send all relevant supporting documents in support of the above.
