#### VENDOR SOURCING SPECIFICATION

## **General Requirements:**

- The sourcing agency must have executed similar type of assignment at least in two reputed Companies.
- 2. Service Provider has to facilitate
  - Supplier sourcing,
  - Collection of credentials,
  - Due diligence of supplier.
  - Assessing the suitability for the supply of materials (material groups) to the BHEL
- Technical/Spot assessment shall have to be done by the service provider. Based on satisfactory compliance of the potential vendor, the service provider may recommend such vendors to BHEL
- 4. However, BHEL reserves the right to do the technical/spot assessment of such vendors recommend by the service provider. This is part of BHEL's Vendor registration process.

#### Scope:

- 1. BHEL will provide the material groups along with detailed specifications, for which additional vendors will be required to be added. Based on BHEL input, the sourcing agency/agencies shall analyse the feasibility of vendor addition (both indigenous and foreign).
- 2. Service Provider to act as an extended arm of BHEL for the addition of new vendors.
- 3. MSE vendors shall also be considered wherever found eligible for these material groups.
- 4. Help the potential vendors to register through the on-line SRF portal.
- 5. Guide the potential vendor in compiling the SRF file hard copy and assist them to ensure all the requirements are met with.
- 6. Interact with BHEL and the potential vendors for removing any bottleneck issues related to vendor registration.

## Measurable Activities for the purpose of payment:

- No. of successful vendors got registered out of total vendors referred to BHEL
- 2. Minimum of three vendors for 1V material groups shall have to be added.
- 3. Minimum of two vendors for 2V material group shall be added.
- 4. Minimum of one vendor for 3V material group shall be added,

## For Activity A:

- The submission of RFI document dully filled and verified along with the associated documents.
- Service Provider will communicate to BHEL about the enabled vendor.
- Report on recommendation check and approvals to be furnished by the service provider.

## **Commercial terms and conditions:**

- 1. Payment will be done for the cases as per the above offered and negotiated rate per permanent registration.
- 2. In case the vendor is marked for development/trial, the payment will be **50**% of the charge agreed for one permanent registration.
- 3. If there are more than 10 rejections out of the recommendations given by the service provider(s), agreement with such service provider will be terminated at the discretion of BHEL.
