Supplier must follow safety and environmental guidelines given in Annexure-C. 5. Annexures-A, B, C, D, E, F, G, H, I and J are inherent part of this NIT. Tender shall be awarded to techno-commercially qualified bidder who quotes lowest landed rate on a grand total package basis including cost of supply, Installation & Commissioning and comprehensive maintenance. Method of finalization i.e. Reverse Auction or Price bids opening shall be decided by BHEL later on based on the number of techno-commercially qualified bidders. 9. Supplier shall be liable for comprehensive maintenance and operation of solar power plants installed on all buildings and ground comprising of total capacity of 170 KWp Solar PV Plant as per scope of NIT. 10.
