The Suppliers not meeting the above criteria OR not submitted the above required documents will be disqualified.

PROCEDURE FOR EVALUATION OF OFFERS FOR RC VALVES

The offers will be submitted as two part bid system i.e., Techno –commercial offer including PQR and price offer.

Initially, only techno – commercial offer will be opened for scrutiny.

Offers will be evaluated as follows:

(A) Techno – commercial offer:

1) The offers will be reviewed with respect to the Technical Pre-Qualification Requirements. The offers which do not meet the requirement will be disqualified and will not be processed further. The technically qualified offers will only be processed further.

2) Offers of Indian suppliers:

The filled up Supplier Registration Forms of the technically qualified Suppliers will be evaluated as per the procedure stipulated in 'Supplier Evaluation, Approval & Review Procedure.

3) Offers of Foreign suppliers:

The filled up Supplier Registration Forms of the technically qualified Suppliers will be evaluated as per the procedure stipulated in 'Supplier Evaluation, Approval & Review Procedure.

4) Technical scrutiny of Offers:

a) The offers qualified as per PQR will be taken up for technical scrutiny.

b) The technical offers will be scrutinized as per specification and drawing requirement.

c) The Supplier Registration Forms of technically suitable offers at (2) or (3) above will be evaluated by MISCC in line with Supplier Evaluation, Approval & Review Procedure.

d) Final Recommendation will be given by MISCC to include the Suppliers in PMD and for ordering the subject items.

e) The technically suitable vendors who are accepted by MISCC shall be taken up with the customer by Engineering through Contracts Management for addition of their name in customer approved vendor list.

(B) Price offer:

a) The price bids shall be opened of those vendors only who will be approved by customer as per above point (A)4(e).

b) The price bids shall not be opened of those vendors who will not be approved by customer as per above point (A)4(e).
