1. Bids are invited in sealed envelope for Contract of hiring of following two categories of vehicles as under:
 - a. 02 No. Hatchback Taxies (Indica/Swift/Figo/i10 Grand/Polo etc.)
 - b. 01 No. Sedan Taxi (Indigo/Amaze/Swift Dzire/Etios etc.)
2. The commencement date of the contract shall be date given as per LOI or LOA, whichever is earlier.

Instructions for furnishing of offer

1. Offer to be submitted in two bid, i.e. Techno Commercial Bid and Price Bid. Techno commercial bid consist of General Terms & Conditions as per schedule – A, Qualifying requirement and Criteria for evaluation of tender as per schedule –B , and blank price bid as per schedule –C.
2. Price bid to be submitted duly filled as per schedule – D.
3. Price bid of only the technically qualified bidders shall be opened.
4. Bidder must properly sign all documents, on each page.
5. Price bid and techno commercial bid to be submitted in separate envelop mentioning tender enquiry no. and tender opening date. Both the envelop (price bid and Techno commercial bid) to be kept in third envelop mentioning tender no. and tender due date with the name of bidder, addressed to Sr. Manager CPR BHEL Jhansi. This offer to be dropped in tender box located at CISF post ADM Gate BHEL Jhansi.
6. Overwriting /correction may attract for rejection of offer.

GENERAL TERMS & CONDITIONS

Schedule - A

1. Contractor/Operator will have to fulfill all legal obligations regarding minimum wages, PF, ESI, Pollution Norms, Motor Vehicle Act, GST etc. as may be applicable to him. The vehicles should have valid taxi permit issued by R.T.O., Jhansi. The vehicle must be comprehensively insured for driver, passengers & the third party for the period of the contract.
2. The contractor has to abide by all laws, rules & regulations of Government, applicable to this type of work. Ignorance of the same does not entitle him to any concessions or claims.
3. The vehicle(s) may be required to go outside Jhansi. Permit charges/Toll tax of other States shall be reimbursed against documentary proof.
4. Driver should have valid driving license for commercial light Motor vehicles. Driver without license shall not be permitted.
5. The Vehicle will have to be properly maintained as per RTO norms, dust proof and in good running condition, which includes at least the following:
 - i.Upholstery in good condition including washed and ironed white seat covers;
 - ii.Dusting of dashboard, rear board, matting, windscreen, windows and body.
 - iii.BHEL may inspect the vehicle for above parameters and reserves the right to call replacement, if the vehicle is not found satisfying the above conditions.
6. Placard indicating name of Guest, name of Company etc. will have to be displayed by the driver at the Railway station for receiving incoming guests. The Transport Pool In-charge will give details from time to time. Failure to comply with this provision may result in a penalty of Rs.100/- per incident. Each vehicle has to keep two sketch pens, white sheets, blade & cello tape for writing the name of the arriving guest and paste it on the front wind screen.
7. The driver of the vehicles should be well behaved and courteous with the passengers equipped with mobile phone.. He should display restraint and wisdom in dealing with excited passengers. In case of misbehavior by the driver, a penalty of upto Rs.50/- can be imposed for each occasion. In case there are multiple repetitions with a particular driver, he will have to be changed.
8. Night charges shall be paid separately @ Rs.200/night (MAX. 6 NIGHTS), if the services are taken after 12 hours of duty period. Offer with any deviation or any comments/additional remark/condition on price bid shall be liable for rejection of offer.
9. Security Deposit: Contractor shall be liable to Security Deposit @ 2.5% of the contract value.
Mode of deposit:
The balance amount to make up the required Security Deposit of 2.5% of the contract value may be accepted in the following forms:
 - i) Electronic Fund Transfer in favour of BHEL
 - ii) Bank Guarantee from Scheduled Banks/ Public Financial Institutions as defined in the Companies Act. The Bank Guarantee format should have the approval of BHEL.
 - iii) Fixed Deposit Receipt issued by Scheduled Banks/ Public Financial Institutions as defined in the Companies

- Act.(FDR should be in the name of the Contractor, a/c BHEL)
- iv) Securities available from Indian Post offices such as National Savings Certificates, Kisan Vikas Patras etc. (held in the name of Contractor furnishing the security and duly endorsed/ hypothecated/ pledged, as applicable, in favour of BHEL)
10. **Payment Terms:** Payment shall be made within 30 days after submission of bill duly completed in all respects. Bill to be submitted to Sr. Manager, CPR, BHEL Jhansi.
11. **Taxes & Duties :** GST shall be paid extra as applicable.
12. **ARBITRATION:** All disputes arising in connection with the contract shall be settled by mutual consultation. If no agreement is reached the dispute shall be settled in accordance with provision of Arbitration & Conciliation Act 1996 (Latest Applicable) and the rule made thereunder. Head of BHEL Jhansi shall appoint the Arbitrator & the award of Arbitrator shall be final & winding on both parties. The venue of Arbitration shall be Jhansi.
13. **JURISDICTION:** Any matter of dispute arising out of or in connection with the contract shall be under Jurisdiction of Jhansi Court only.
