PREAMBLE AND TERMS & CONDITIONS

PREAMBLE

- 1. Scope of work involves construction and maintenance works of civil, structural steel/RCC, expansions, renovations and Horticultural, Electrical and pesticide works in BHEL R&D campus also within a radius of 50 km from BHEL R&D.
- 2. Usually working hours are limited to day time only. In emergency cases works may be carried out during nights with the specific prior permission of BHEL R&D management. In such case it is to be carried out in the presence of BHEL R&D officials or their authorized persons.
- 3. The works executed in the own name of applicant only will be considered for eligibility criteria.
- 4. Dissimilar/irrelevant works will not be considered for eligibility criteria.
- 5. Documentary evidences for turnover, works experience, PF, ESI, sales tax registration and other statutory requirements etc., all as indicated & required should be furnished without which the application for enlistment cannot be considered.
- 6. The applicant shall strictly adhere to various labour laws in force.
- 7. The applicant shall follow norms of BHEL R&D security system for movement of men, materials & machinery within the campus.
- 8. BHEL General conditions of contract will apply.

TERMS AND CONDITIONS

- 1. Any Indian individual, sole proprietorship firm, partnership firm, public or private limited company is entitled to get enlistment as a contractor in BHEL R&D under these terms and conditions, provided the eligibility criteria and other norms are satisfied. The enlisted contractors have to abide by all rules made herein and as mentioned from time to time during the currency of their enlistment
- 2. No individual or a firm having such individual as one of the partners, who is a dismissed government servant or disqualified from the approved list of contractors or demoted to lower class or having business banned/suspended by any government department in the past or convicted by a court of law shall be entitled for enlistment, if it is found so at a later date action will be taken against the individuals.
- 3. No Engineer or any other official employed in Engineering or Administrative duties in the Engineering Department of the Government of India is allowed to work in BHEL R&D either as contractor or as employee of a contractor for a period of Six Months after his retirement from Government service unless he has obtained prior permission of Government of India to do so. Even after enlistment if either the contractor or any of his employee is found to be a person who had not obtained the prior permission of Government of India as aforesaid, the name of contractor shall be removed from the list of enlisted contractors.
- 4. An applicant is not permitted to have enlistment in more than one name.
- 5. A partner of a firm or director of a company enlisted as a contractor cannot be as a partner/director in any other units of BHEL.
- 6. The enlistment in BHEL R&D shall entitle them to be considered for issue of tender notice subject to the conditions laid down in Notice Inviting Tenders only. It shall not confer any right on them either to be necessarily issued the tender papers or for award of work..
- 7. The applicant shall have to submit the application in the prescribed form to the enlistment authority complete with all documents.
- 8. Incomplete applications and applications not accompanied with necessary documents are liable to be rejected.
- 9. The enlistment authority shall have the right to verify the details furnished by the applicant.
- 10. If the enlistment authority finds the applicant suitable for enlistment, the enlistment order will be issued to the applicant, and, otherwise, intimation of rejection will be intimated to the applicant. The decision of the enlistment authority shall be final and binding on the applicant.
- 11. The enlistment will be valid for a period of three years from the date of issue of enlistment.
- 12. The enlistment will be done for classes as mentioned in the application form and in case the applicant is not found suitable for the class applied, then the applicant will be registered in the next eligible lower class, if suitable.
- 13. Applications for enlistment are also will be received from the agencies during any financial year after the initial enlistment. Subsequently, these applications will be scrutinised and communicated, which is also valid till next enlistment takes place.

- 14. The financial soundness shall be judged on the basis of the solvency certificate or the working Capital certificate, as the case may be, issued by the Bankers/recognised financial institutions of the contractor. Such certificate shall be issued by a scheduled bank/recognised financial institutions.
- 15. The applicant shall have to pay a non refundable enlistment fee in the form of a crossed demand draft drawn in favour of "Accounts Officer, BHEL R&D, Vikasnagar, Hyderabad". For serial No.1 to 6 the enlistment fee is Rs.1,000/- (Rupees One thousand only) which is to be submitted along with the application form. The application without enlistment fee will be liable for rejection.
- 16. The applicant who got registered as enlisted contractor shall submit a copy of IT return form every subsequent year to the enlistment authority.
- 17. The applicant/ firm shall not modify the existing partnership or enter into any fresh partnership without the prior approval of the enlistment authority. Such proposal, if any, shall be submitted in advance giving full details of the intended partnership/sole proprietorship along with the draft partnership deed/affidavit and documents. Any change in status of the contractor as an 'individual' or in constitution of the firm without prior approval of the enlistment authority will render the contractor/firm liable to be removed from the approved list of contractors.
- 18. If a firm is converted in to two or more firms by any action of its partners, the new firm(s) or any separated partners(s) in his (their) individual/joint capacity shall have to apply for the enlistment afresh on the basis of work experience gained as a separate entity.
- 19. If new partners are taken in the firm, each new partner shall have to satisfy the conditions as mentioned in Sl.Nos.1, 2 &3.
- 20. If the number of original partners of a firm reduces to less than half due to any reason including death of partner(s), the enlistment of the firm shall be withdrawn.
- 21. The address of contractor or firm applying for enlistment should be the same in all documents, and any change in address to be intimated time to time.
- 22. The applicant shall have to abide by all the rules, terms and conditions of the contract and the Notice Inviting Tenders. He shall have to execute the works satisfactorily on time and with good quality. In case of failure the enlisting authority shall have the right to demote a contractor to a lower class, suspend business with him for any period, debar him or remove his name from the approved list of contractors after issue of show cause notice. Decision of the department shall be final and binding on the contractor.
- 23. Enlisting authority may modify, add, delete and/ or change any of the above terms and conditions and the same shall be binding on all enlisted contractors.
