23. RISK PURCHASE: The delivery period stated shall be realistic and shall be strictly adhered to. 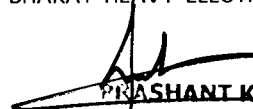

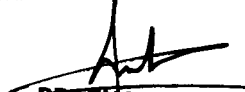
