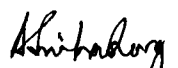

1. We intend to procure **GI Perforated cable trays with accessories** for which Sealed Quotations are invited in Two-bid system i.e., Price Bid and Technical Bid along with un-priced bid (in duplicate). Sealed Quotations shall be submitted strictly in compliance with Commercial Terms and Conditions (CTC) enclosed at ANNEXURE-A (for Indigenous suppliers) or ANNEXURE-B (for Foreign suppliers) whichever is applicable and Technical Delivery Conditions (TDCs). The offers of those Vendors who do not comply with all the Clauses of CTC and TDCs in total are likely to be rejected. Documents submitted with the offer shall be signed and stamped on each page by authorised representative of the vendor. No deviations are permitted.

The sealed Quotation shall be submitted super scribing our enquiry reference and category of enquiry so as to reach us on or before **14:00 Hrs of 13.09.2017**. The Quotation received after the due date is liable to be rejected. In case any supplier is not in a position to submit the Quotation strictly as per Technical Delivery Conditions (TDC) and Commercial Terms & Conditions (CTC) may submit REGRET letter.

2. **Pre- qualification criteria:**

The supplier need to submit the supporting documents for the following along with technical bid. **Offers without supporting documents in line with requirement shall not be considered for scrutiny.**

- Vendor shall furnish at least 3 references in last 5 years for our review.

5. Inspection : By BHEL or its authorized Inspection Agency

(Indigenous Supplier needs to register ONLINE in BHEL website (www.cqir.bhel.in) for offering for Inspection for first time. On readiness of ordered material, supplier shall raise the inspection call request online (www.cqir.bhel.in) with minimum notice period of 07 working days to the authorized representative of the Purchaser for inspection/testing as provided in PO). Inspection Charges will be borne by BHEL for Indigenous vendors

15. GST Clauses:

The bidder to specify in their offer (part 1 bid) the category of their registration under GST like Registered, Unregistered and composite dealer.

The provisional GST registration number of Bharat Heavy Electrical Ltd, Heavy Plates and Vessels Plant, Visakhapatnam is “37AAACB4146P7Z8” with state Code as “37” and State Name as “Andhra Pradesh”.

17. SPECIAL PROVISION FOR MICRO AND SMALL ENTERPRISES (MSE):
