- 4.0 No Deviation with respect to tender clauses and no additional clauses/ suggestions/ clarification in Techno-commercial bid/ Price bid shall normally be considered by BHEL. Bidders are requested to positively comply with the same.
- 5.0 BHEL reserve the right to accept or reject any or all offer without assigning any reasons thereof. BHEL also reserve the right to cancel the tender wholly or partly without assigning any reason thereof. Also BHEL shall not entertain any correspondence from bidders in this matter (except for the refund of EMD). However, BHEL may communicate rejection to the unsuccessful bidder after award of work and acceptance by the successful bidder.
- 6.0 Bidders must visit site/ work area and study the job content, facilities available, availability of materials, prevailing site conditions including law & order situation etc before quoting for this tender. - 8.0 BHEL may decide holding of pre-bid discussion [PBD] with all intending bidders as per date indicated in the NIT. The bidder shall ensure participation for the same at the appointed time, date and place as may be decided by BHEL. Bidders shall plan their visit accordingly. The outcome of pre-bid discussion (PBD) shall also form part of tender.
- 9.0 In the event of any conflict between requirement of any clause of this specification/ documents/drawings/data sheets etc or requirements of different codes/standards specified, the same to be brought to the knowledge of BHEL in writing for clarification before due date of seeking clarification (whichever is applicable), otherwise, interpretation by BHEL shall prevail. Any typing error/missing pages/ other clerical errors in the tender documents, noticed must be pointed out before pre-bid meeting/submission of offer; else BHEL's interpretation shall prevail.
- 10.0 Unless specifically mentioned otherwise, bidder's quoted price shall deemed to be in compliance with tender including PBD, if any.
- 11.0 Bidders shall submit Integrity Pact Agreement (Duly digitally signed by authorized signatory who signs in the offer), if applicable, along with techno-commercial bid. This pact shall be considered as a preliminary qualification for further participation. Detail of Independent External Monitor (IEM) for the subject tender is furnished above.
- 12.0 The Price Bids of only those bidders will be opened who will be qualified for the subject job on the basis of evaluation on pre-qualification criteria/ techno-commercial bids, approval/ acceptance of customer (as applicable), etc. BHEL's decision in this regard shall be final & binding. BHEL commits to take all measures necessary to prevent corruption in connection with the tender process and execution of the contract. BHEL will during the tender process treat all Bidder(s) in a transparent and fair manner, and with equity.

1.2 Commitment by Bidder/ Supplier/ Contractor:

1.2.1 The bidder/ supplier/ contractor commit to take all measures to prevent corruption and will not directly or indirectly influence any decision or benefit which he is not legally entitled to nor will act or omit in any manner which tantamount to an offence punishable under any provision of the Indian Penal Code, 1860 or any other law in force in India.

1.2.2 The bidder/ supplier/ contractor will, when presenting his bid, disclose any and all payments he has made, and is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the contract and shall adhere to relevant guidelines issued from time to time by Govt. of India/ BHEL.

4. The language in the tender documents downloaded by the Bidders shall at no point of time be changed, altered or modified in any manner by the Tenderer. 5. Performance Bank Guarantee

Where ever so required, the Supplier shall arrange to provide a Performance bank guarantee (PBG). The indigenous suppliers have to provide the PBG from any one of the Nationalized Banks, listed in the tender terms. However, the PBG shall be confirmed by any of the Bankers listed by us. The PBG shall guarantee the performance of the equipment / materials / items supplied and shall cover the guarantee period. The PBG shall have a claim period of 3 months in addition to the guarantee period. In the event of failure of the supplies made within the guarantee period, BHEL would encash the entire PBG. The PBG shall be for a value of 10% of the Purchase order.

The supplier (/s) has to get the PBG format (pre-printed) from BHEL and get the same stamped by the Banker. Change of PBG terms either by the supplier's Banker or by the supplier, after servicing of the order is not acceptable. Similarly, PBG prepared by the supplier (typed by them) will also not be acceptable to BHEL. The pre-printed form issued by BHEL shall be used for making the PBG.

6. Reverse Auction Terms & Conditions

This will be decided after techno-commercial evaluation. Bidders to give their acceptance with the offer for participation in RA (*as per Vol-IC Techno-commercial Compliance in e-portal*). Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.

Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'Process compliance form' (to the designated service provider) as well as 'Online sealed bid' in the Reverse Auction. Non-submission of 'Process compliance form' or 'Online sealed bid' by the agreed bidder(s) will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines for suspension of business dealings with suppliers/ contractors (as available on www.bhel.com).

The bidders have to necessarily submit online sealed bid less than or equal to their envelope sealed price bid already submitted to BHEL along with the offer. The envelope sealed price bid of successful L1 bidder in RA, if conducted, shall also be opened after RA and the order will be placed on lower of the two bids (RA closing price & envelope sealed price) thus obtained. The bidder having submitted this offer specifically agrees to this condition and undertakes to execute the contract on thus awarded rates.

If it is found that L1 bidder has quoted higher in online sealed bid in comparison to envelope sealed bid for any item(s), the bidder will be issued a warning letter to this effect. However, if the same bidder again defaults on this count in any subsequent tender in the unit, it will be considered as fraud and will invite action by BHEL as per extant guidelines for suspension of business dealings with suppliers/ contractors (as available on www.bhel.com).

Bidder must have supplied 750 Kg BHELMAX and 750 Ltr. BHELSOL in the last Two (2) years as on latest date of bid submission to any Government, Semi Government/ or any Customer.

B Financial Turnover

Bidders must have achieved an average annual financial turnover (Audited) of Rs. 8 Lakhs or more, over the last three Financial Years (FY) i.e. '2014-2015, 2015-16, 2016-2017'.

C Price Bid Opening

Price bids of those bidders who stand qualified subsequent to the compliance of PQR criteria A and B shall be opened.

Explanatory Notes for PQR

- i. 'Supplied' in QR - A means bidder should have delivered the Chemicals# Bidder shall submit the relevant documents against the above PQRs inclusive of Purchase order (wherein PO no., date, PO Value etc. is legible) along with proof of supply (i.e. - Completion Certificate/ Copy of Invoices / LR Copies/ Store Receipt Vouchers/ Payment Advice etc.) in the respective attachments in their offer in support of PQR.

 - a. Sample will be collected from the first batch of bulk mixed inhibitor (min 74 Liters) in presence of BHEL representative.
 - b. This sample will be tested at BHEL/Trichy Labs and based on the acceptable test results, clearance will be given by the Trichy Lab for proceeding with manufacturing the remaining lot.
 - c. Further mixing of the balance quantities shall be done in presence of BHEL representative
 - d. The same will be sealed (displaying batch no and date of manufacture) and dispatched to site by vendor.
 - e. In case of any shortage of raw chemicals leading to additional procurement during preparation of complete lot, a fresh sample has to be prepared / tested and cleared for use. Therefore, the vendor must ensure sufficient quantities input of raw materials beforehand.
2. Testing and verification of inhibitor sample shall be done at BHEL Trichy R&D Lab.
3. If the sample prepared by the supplier fails to meet the acceptable level of BHEL-Trichy Lab in the second time, testing charges will recovered from the bills of the vendor.
4. Ultimate responsibility of getting inhibitor cleared after testing lies with the vendor.
5. Motorized stirrer to be used for mixing MBT with Di-Ethanolamine for preparation of BHELMAX and BHELSOL. Vendor must have the above facility.

9. Test certificate, guarantee certificate (if applicable) to be furnished along with the supply. Test certificate mentioning shelf life to be furnished by the supplier with the material.
10. Material Dispatched Clearance Certificate (MDCC): **Supplier should supply/dispatch the material after receiving clearance from BHEL PSWR project site.**
11. Packing Details: The Chemicals must be supplied in suitable package to avoid the leakage /damage /loss.
12. Chemicals will be accepted only if accompanied by "Material Test Certificate" of manufacturer / ITA Lab in accordance with relevant IS Code. Tenderer should agree for compliance.
13. All chemicals should be supplied with MSDS (Material Safety Data Sheet). Chemicals without MSDS will not be accepted.

III. Techno – Commercial Terms and Conditions:

1. Tenders beyond the scheduled due time cannot be submitted by the bidders in the e-procurement portal.
2. Offer must be submitted in **Two-Part Bid only** i.e. techno-commercial bid and price bid separately. Single bid offer shall be liable for rejection.
3. No Consortium bidding is allowed for the subject tender.
4. Part offer shall be rejected i.e. bidder must quote for the total quantity as per Enquiry.
5. **Price:** Bidders should quote the prices in the Volume – II - Price Bid in e-portal
6. **Evaluation criteria –**
 - a. Price bids of the techno-commercially acceptable offers shall be opened for Price Evaluation.
 - b. Evaluation shall be carried out on Package-wise. Conditional offers will not be considered.

2. Price Bid will consists of requirements of both the Sites i.e. BTPS Manuguru, Telangana and RFCL, Ramagundam, Telangana.
3. Price shall be inclusive of Packaging and Forwarding charges, Freight and Transit Insurance charges.
