**2. Introduction:**

BHEL is the largest engineering and manufacturing enterprise in India in the energy related/infrastructure sector, today. BHEL was established more than 50 years ago, ushering in the indigenous Heavy Electrical Equipment industry in India - a dream that has been more than realized with a well-recognized track record of performance. The company has been earning profits continuously since 1971-72 and paying dividends since 1976-77.

BHEL manufactures over 180 products under 30 major product groups and caters to core sectors of the Indian Economy viz., Power Generation & Transmission, Industry, Transportation, Telecommunication, Renewable Energy, etc. The wide network of BHEL's 17 manufacturing divisions, four Power Sector regional centers, over 100 project sites, eight service centers and 18 regional offices, enables the Company to promptly serve its customers and provide them with suitable products, Systems and services. The high level of quality & reliability of its products is due to the emphasis on design, engineering and manufacturing to international standards by acquiring and adapting some of the best technologies from leading companies in the world, together with technologies developed in its own R&D centers.

BHEL's vision is to become a world-class engineering enterprise, committed to enhancing stakeholder value. The company is striving to give shape to its aspirations and fulfill the expectations of the country to become a global player.

**3. Objective:**

The tender is invited for providing **"40 Mbps (1:1) internet connectivity through leased line" at BHEL Asiad Office, Sirifort New Delhi** for a period of **TWO years**. The tender has to be submitted in TWO PARTS namely TECHNO-COMMERCIAL & PRICE-BID.

The term 'ILL' or 'Internet Lease Line' used hereafter shall mean internet Lease Line Bandwidth 40Mbps (1:1) including last mile on OFC and 40 Mbps (1:1) Internet port and Bandwidth from ISP and any hardware, software including Warranty & Maintenance Support etc. required for entire contract period of 2 years at BHEL House, Sirifort Road New Delhi. It also includes integration with BHEL's Router, providing 64 IPV4 IP addresses & /64 IPV6 IP addresses, reverse DNS entry on provider's IP addresses.

BHEL is currently having Internet Lease line from M/s Power Grid Corporation of India. As this tender is for redundant internet lease line therefore, bidders excluding M/s Power Grid Corporation of India may quote in this tender enquiry.

**NOTE:**

- 1) In case a bidder does not meet all the conditions mentioned in Eligibility Criteria, bidder will be disqualified.
- 2) All data shall be verifiable by BHEL.

**5. Scope of Work:**

BHEL intends to setup a 40 Mbps 1:1 Internet Leased Line circuit.

The scope of work includes supply, installation, configuration, provisioning, commissioning, management & monitoring of proposed Internet circuit. This broadly includes following:

- a) Supply, Installation and configuration of end equipment like fibre circuit etc.



- b) Providing dedicated Internet Port of 40 Mbps with 1:1 committed information rate. The bandwidth must be exclusively dedicated for BHEL.
- c) Provisioning of Last Mile from the Service Provider's nearest POP to BHEL Asiad location. The last mile for the delivery of Internet Leased Line would be over optical fiber Network, which will be backhauled over ISP's network to the nearest Internet PoP further to the Internet Gateways. Optical fiber connectivity, backbone as well as last mile shall be in complete ring topology to minimize the downtime. The two arms of the ring shall enter BHEL campus in two separate ducts, which shall be in separate trenches and in opposite directions. The ring should provide automatic failover of the last mile, so that if there is cut in one arm of the fiber, the link shall continue to work through the other arm without any disruption.
- d) Termination, Configuration & Commissioning of the links with BHEL Cisco routers like 3900,2800 etc.
- e) Sustenance services for Internet link and all equipment provided by Bidder during the entire contract period.
- f) Bidders shall provide the rack to house the Fiber and all indoor equipment, if required. Bidder has to do site visit in advance and check for the space suitability for housing the rack. Rack may have to be shipped in knocked down format and assembled again in Switch/Server room.
- g) The Service Provider shall provide 24x7 service supports for call logging and fault rectification for the Internet circuit which means support for the physical link as well as associated hardware supplied to make the circuit functional. Escalation matrix shall be provided by Bidder.
- h) IPv6 Compliance: The network should be fully IPv6 compliant. It should be possible to run both IPv4 & IPv6 concurrently on the network i.e. Dual Stack.
- i) **IP ADDRESSES, Reverse DNS entries and Name Resolution Facility:**
  - The Service Provider shall provide BHEL with 64 nos. globally valid IPv4 Addresses from its pool.
  - The Service Provider shall provide BHEL with /64 nos. globally valid IPv6 Addresses from its pool.
  - All IPs provided by Bidder shall have Reverse DNS entries enabled from day one so that any Mail Servers being implemented with Bidder's IP shall have Reverse DNS entry so that other servers on Internet do not reject Mails from these servers due to lack of DNS entry.
  - BHEL currently has its own DNS servers. However, Bidder shall provide access to at least 2 no. of its own DNS servers on IPv4 and IPv6 for further resolution of name queries on Internet. This shall be provided on BHEL's IP series from APNIC as well as IP nos. provided by Bidder to BHEL.
- j) Network Management & Support: The Service Provider shall do proactive monitoring and fault management of the network on an End-to-End basis remotely from its own Network Operations Centre (NOC) and provide the report through standard MRTG reports available through Web access or some other online means. Report should also include monthly uptime status of the link.

**k) INSTALLATION:**

- The Bidder shall carry out total installation work as per the requirements of the complete project.
- Necessary power and communication cables for complete H/W installation including interfacing cables required for inter-connection of different equipment supplied by Bidder are in the scope of Bidder and shall be supplied at no extra cost.
- The installation work shall be carried out in a neat workman-like manner by skilled, experienced and competent workmen.
- All skilled & unskilled labour, materials, equipment, instruments, hardware, tools, consumables, fasteners, accessories etc. whether specifically mentioned or not in the specification but required for complete installation and testing in all respects will be in the scope of the Bidder and no extra cost shall be paid for the same.

## **I) INTERFACE EQUIPMENT**

Rack for housing fiber circuit and associated equipment like router, modem, battery etc. if required. The Rack shall be installed in Switch/Server room at 3rd Floor in BHEL Asiad. Bidder to visit the site to ascertain the requirement for this. No separate price will be paid if RACK is to be supplied by the bidder.

- Bidder should specify any other equipment (if required) for interfacing. It shall be the Bidder's responsibility to configure and demonstrate the total solution so that it performs satisfactorily.
- It shall be Bidder's responsibility to interface the circuit with existing available Cisco Routers like 3900, 2800 etc making requisite configuration on the same.

## **5.1 ACCEPTANCE TEST PROCEDURE (ATP):**

- a) ATP shall be conducted by the Service Provider to establish that the connectivity and all hardware and software has been supplied by the Bidder strictly as per the specifications and is in perfect working conditions.
- b) Once the system is fully installed (as per technical & functional requirement) and is made operational, its operation and performance would be observed for duration of two continuous working days. The ATP would start on a mutually agreed date and time after the preliminary observation of two days.
- c) At least one representative of the Service Provider shall be present during the entire ATP, if required. Bidder's representative should be capable of performing all tests, interpret the meaning of each diagnostic and satisfy BHEL representative(s) with satisfactory answers.
- d) Following procedure would be followed during the ATP:
  - The complete system with all its hardware and software would be operated continuously for two continuous working days on 24 hours per day basis. Requisite requirements of IP numbers, DNS services, reverse DNS entry etc. shall be tested.
  - An overall availability of 99.5 % would be ensured by the Bidder during ATP for the leased line and the interface equipment. If any equipment or the leased line is not available for more than eight (8) hours or if it is found at the end of ATP that its availability is less than 99.5 %, BHEL would not accept that particular equipment or the leased line and its ATP would restart (from



zero) after making necessary rectifications/replacements. If any equipment or the leased line is not operating to its full specifications, it shall be treated as down for the purpose of computation of its availability. However, downtime shall not be counted for problems because of the equipment (H/W & S/W) from sources other than the Bidder.

- During the physical verification, it would be established that all hardware and software have been supplied as per BHEL technical specifications.
- All problems/deficiencies as pointed out by BHEL shall be immediately attended to by the Bidder.
- BHEL shall issue an ATP certificate on successful completion of ATP, provided that an overall availability of 99.5% has been achieved and no hardware or software problem/ deficiency reported during the ATP is pending. Further, no major hardware or software problem/deficiency which indicates that the supplied hardware/software is of poor quality and/or faulty design should be detected during the ATP.

## 5.2 Penalty for SLA Non-Conformance

### 5.2.1 Service Level Agreement (SLA):

#### Network Availability & Performance:

The Network availability and performance parameters will be as under:

The "Network Uptime" includes both link uptime as well as the end equipment uptime. This shall be calculated on monthly basis.

#### Computation of Availability:

Availability of service shall be assessed by the following formula:

$$\text{Uptime} = 100 * \left( 1 - \frac{\text{Total outage duration in minutes}}{\text{Maximum Available Time in minutes}} \right)$$



Maximum Available Time = No. of days in month \* 24 \* 60 – (Scheduled Maintenance Time +BHEL introduced Outage)

Note: Scheduled Maintenance Time should not be more than one hour per month and BHEL should be informed at least 48 hours in advance and subsequent approval / acceptance should be taken from BHEL.

### 5.2.2 Penalties:

Network Availability (SLA Compliance) will be reviewed quarterly and penalties for non-compliance will be deducted on quarterly basis from the rental charges. The penalty will be calculated for Internet Leased Line as per the following formula:

$$\text{Penalty} = F \times (H \times D)$$

Where,

F = Multiplication Factor as per table given below.

H = Minute wise Rental Charges

(i.e. Quarterly Rental Charges/ Total number of minutes in the Quarter)

D = Downtime in minutes

Note: Bidder shall ensure that, under no circumstances, service shall be down for 'More than 4 hours at a stretch in a single working day peak usage time Monday to Saturday (i.e. from 8 am to 8 pm)'. For each such instance where downtime is more than the above limits, the downtime hours will be doubled while calculating the total uptime for the quarter.

### 5.3 Penalty for Late commissioning:

If the installation, termination and commissioning are not completed within the delivery schedule, a penalty of 0.5% per week (or part thereof) subject to maximum of 10% of the total order value for entire contract period for the project not completed in time as per the schedule defined in RFP. This penalty will be deducted from

the first quarter charges, in case the penalty amount to be deducted is more than the first quarter charges, the same will be adjusted from the consecutive quarter.

#### **5.4 Start of work:**

The work will start from the date of issue of acceptance certificate by BHEL.

#### **5.5 Rates:**

Rates are to be quoted as per Price Bid Format. Details of prevailing rates of taxes should be indicated separately. Bidders, in their own interest, are requested to check up and indicate the different tax tariff like service tax etc. Taxes not mentioned by the bidder in their bid will not be entertained at later date. However, during the execution of the contract any increase or decrease in the above taxes/imposition of new taxes will be entertained on submission of relevant documentary proof.

#### **5.6 Taxes & Duties:**

Taxes (Service Tax & VAT) shall be extra and payable as per prevailing rates. Any change in applicable taxes or imposition of any new applicable tax by GOI, the same shall be borne by BHEL on submission of documentary proof by the vendor. However, any decrease in applicable taxes or any new tax, benefit shall be passed on to BHEL. In case GST is introduced by GOI in place of existing taxes, the same shall be payable after equitable adjustment.

#### **5.7 Payment Terms:**

Payment shall be released on a quarterly basis at the end of each quarter after the successful completion of Acceptance Test Procedure (ATP) as per section 5.1. Any statutory deduction such as TDS, WCT, etc., if applicable, shall be deducted from the quarterly charges

Payment will be released within 30 days of submission of verified invoices along with following documents-

- a) SLA reports for the quarter (certified by BHEL)
- b) Service tax payment proof
- c) Swachh Bharat Cess Payment proof etc.

#### **5.8 Sub-Contracting:**

Order / contract or any part thereof shall not be sub-contracted, assigned or otherwise transferred to any third party without prior written consent from BHEL.

#### **5.9 SUPPLY CONDITION**

All equipment, if any, supplied and installed at the stipulated location(s) shall be NEW and conforming to the contract technical specifications, if any. The certificate of newness is to be furnished.

#### **5.10 LOCATION & CONSIGNEE ADDRESS**

The Bidder should provide access network for providing last mile (local loop) at BHEL Asiad using Optic Fibre Cable (OFC) with termination within the building where Internet Lease Line is required. End connection on router placed at 3<sup>rd</sup> Floor Server Room of the building will be on Ethernet port. Rack for housing fibre circuit and associated equipment like modem, battery etc. and Router, if required shall also be provided as part of the Internet bandwidth services. The Rack shall be installed in Network/ Server room at 3<sup>rd</sup> Floor in BHEL Asiad, Sirifort, New Delhi.

For a detailed understanding of the layout, route map, existing hardware, software and networking environment at BHEL, the bidders should visit and acquaint themselves of the existing setup. Bidder shall visit the site for complete appraisal and assessment of existing facilities and site requirement, prior to submission of their offers.

#### **5.11 PROJECT COMPLETION:**

The installation, commissioning and configuration of the ILL should be successfully completed within 6 weeks of placement of order by BHEL.

Documentation & Project Management: The successful bidder shall provide documentation for:

- SLA Management / Monitoring & Reporting
- Help Desk Management
- Problem Management along with trouble ticketing & Escalation Matrix
- Performance Management / Change Management

The successful bidder shall nominate one technically competent person as Project Manager who will be single point of contact from Service Provider's end during the implementation period. There will be one Project Manager from BHEL side also who will coordinate during the implementation period.

#### **5.12 Customer Support:**

The Service Provider shall implement a centralized help desk for logging the complaints. Service Provider shall provide a toll free/Universal number for complaint logging. The service window for the support shall be 24x7x365. All calls should be logged and a trouble ticket should be raised within 05 minutes from the time of information on that call. The Service Provider shall mark all trouble tickets as "closed" upon resolution of the issue noted. Service Provider shall also provide the online facility to watch the trouble ticket status.

Each call has to be responded within 20 minutes of complaint logging by BHEL or BHEL authorized agency.

#### **5.13 SHIFTING TO OTHER LOCATION**

**5.13.1** After initial installation as per location detail given by BHEL, one time shifting service within the same building or building of services from one location to another (if required) shall be the responsibility of the Bidder. Here Shifting of location means Shifting of ILL within the BHEL Asiad Building including shifting of cable entry point from Outside into the building. The entire requisite works like dismantling of equipment, packing, transportation and transit insurance shall be the responsibility of the Bidder. No payment will be made by BHEL to the Bidder on this account. The time given for shifting and installation at new location will be mutually agreed and time taken beyond that period will be treated as downtime.

**5.13.2** If there is cable cut inside the BHEL premises due to any reason (maximum up to two times) during the contract period, Vendor has to restore the connectivity without any financial liability to BHEL.

#### **5.14 ADDITIONAL FACILITY/ UPGRADE REQUIRED IN FUTURE**

In case any additional facility/ upgrade is required, the Bidder shall provide the same at mutually agreed terms.

## 6. General Terms and Conditions:

### 6.1 Ethical Standard:

Bidders are expected to observe the highest standard of ethics during the execution of this Contract. In pursuit of this policy, the Purchaser will reject a proposal for award if it finds out that the Bidder being considered for award has engaged in corrupt or fraudulent practices in competing for the Contract. For the purposes of this provision, the terms set forth below are defined as follows:

- a) "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action in the procurement process or in Contract execution; and
- b) "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process including collusive practices designed to establish bid prices at artificial, non-competitive levels to deprive the Purchaser of the benefits of competition;

The Bidder along with its associate/ collaborators/ sub-contractors/ sub-vendors/ consultants/ service providers shall strictly adhere to BHEL Fraud Prevention Policy displayed on BHEL website <http://www.bhel.com> and shall immediately bring to the notice of BHEL Management about any fraud or suspected fraud as soon as it comes to their notice.

By signing the Bid Forwarding Letter, the Bidder represents that for the software it supplies, it is the owner of the Intellectual Property Rights in the software. Willful misrepresentation of these facts shall be considered a fraudulent practice without prejudice to other remedies that the Purchaser may take.

### 6.2 Cost of Bidding:

The Bidder shall bear all costs associated with the preparation and submission of its bid and the Purchaser will in no case be responsible or liable for those costs.

### 6.3 Procedure for Submission & Opening of Bids:

Bids shall be accepted by the official inviting the tenders, in two parts, as described below, on or before the due date & time indicated in the Tender Notice.

#### Part-I : EMD & Techno-Commercial Bid

This part shall consist of the following:

- 1) EMD of Rs.11,600/- (Rupees Eleven thousand six hundred only) only in the form of Banker's cheque/ Pay order/ Demand draft in favour of "BHEL" payable at New Delhi or Noida. Electronic Fund Transfer credited in BHEL account may also be accepted before tender opening. Cash deposit as permissible under the extant Income Tax Act (before tender opening) Tender not accompanied with EMD/ EMD submitted in any other forms other than mentioned above will not be accepted. Earnest Money is to be paid by each tenderer for securing fulfilment of any obligations in terms of the NIT.

#### a. Forfeiture of EMD

EMD by the Tenderer will be forfeited as per NIT conditions, if:

- i. After opening the tender and within the offer validity period, the tenderer revokes his tender or makes any modification in his tender which is not acceptable to BHEL.
- ii. The Contractor fails to deposit the required Security deposit or commence the work within the period as per LOI/ Contract.
- b. EMD given by all unsuccessful tenderers shall be refunded normally within fifteen days of award of work.
- c. EMD shall not carry any interest.
- d. EMD of successful tenderer will be retained as part of Security Deposit.

- 2) Bounded volume of:

- a) The Systems/Equipment, which the Contractor has failed to deliver within the stipulated delivery period in the concerned Purchase Order or if the same were not available, the best and the nearest available substitute(s) thereof which is not technically inferior to the undelivered System/Goods.
- b) The warranty and support which the Contractor has failed to provide in respect of the supplied system/equipment suffering from not less than 1 month of downtime.

The Contractor shall compensate the Client for any loss or additional expense, which the Client may sustain by reason of such purchase. The Client may recover the amount from any money due to the Contractor in respect of this contract or any other contract which the Contractor has with Purchaser. This clause will be operated only after completion of delivery period including extended period with LD, if any.

Recovery on account of purchases made by Purchaser at the risk and cost of Seller/Contractor shall be worked out as follows:

#### **6.21 Arbitration:**

All such claims in this regard will be settled as per Indian Laws.

In the event of any such claims being made against the Purchaser/ Lessee, Purchaser/Lessee will inform in writing to the Vendor/Lessor who shall at his own risk and cost either settle any such dispute or conduct any litigation that may arise there from.

#### **6.28 Limitation of Liability:**

Non-submission of online sealed bid by the bidder for any of the eligible items for which techno- commercially qualified will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines in vogue.
3. BHEL will engage the services of a service provider who will provide all necessary training and assistance before commencement of online bidding on internet.
4. In case of reverse auction, BHEL will inform the bidders the details of Service Provider to enable them to contact & get trained.
5. Business rules containing details like event date, time, bid decrement, extension etc. also will be communicated through service provider for compliance.
6. Bidders have to fax/e-mail the Reverse Auction Process Compliance Form (annexure IV) provided before RA along with Business Rules by the Service Provider. This Compliance Form shall be sent to the Service Provider well before the Reverse Auction in order to get the Log in ID and Password for participating in the RA. Without the submission of Reverse Auction Process Compliance Form, the bidder will not be eligible to participate in the event.
7. In line with the NIT terms, BHEL will provide the calculation sheet (Price Format- Annexure III) which will help to arrive at “Total Cost to BHEL” like Packing & forwarding charges, Taxes and Duties, Freight charges, Insurance, Service Tax for Services and loading factors (for non- compliance to BHEL standard Commercial terms & conditions) for each of the bidder to enable them to fill-in the price and keep it ready for keying in during the Auction.
8. Reverse auction will be conducted on scheduled date & time.
9. At the end of Reverse Auction event, the lowest bidder value will be known on auction portal.
10. The lowest bidder has to fax/e-mail the duly signed and filled-in prescribed format for price breakup including that of line items, if required, (Annexure VI) as provided on case-to-case basis to Service provider within two working days of Auction without fail.
11. In case BHEL decides not to go for Reverse Auction procedure for this tender enquiry, the Price bids and price impacts, if any, already submitted and available with BHEL shall be opened as per BHEL’s standard practice.
12. Bidders shall be required to read the “Terms and Conditions” section of the auctions site of Service provider, using the Login IDs and passwords given to them by the service provider before reverse auction event. Bidders should acquaint themselves of the Business Rules of Reverse Auction, which will be communicated before the Reverse Auction.
13. If the Bidder or any of his representatives are found to be involved in Price manipulation/ cartel formation of any kind, directly or indirectly by communicating with other bidders, action as per extant BHEL guidelines, shall be initiated by BHEL and the results of the RA scrapped/ aborted.
14. The Bidder shall not divulge either his Bids or any other exclusive details of BHEL to any other party.

15. In case BHEL decides to go for reverse auction, the H1 bidder (s) (whose quote is highest in online sealed bid) may not be allowed to participate in further RA process.

## ANNEXURE – II

### BUSINESS RULES FOR REVERSE AUCTION

This has reference to Enquiry, Reverse Auction Schedule and the Item description mentioned in the cover page of this document. BHEL shall finalise the Rates for the “-----” through Reverse Auction mode.

BHEL has made arrangement with M/s. -----, who shall be BHEL’s authorized service provider for the same. Bidders should please go through the guidelines given below and submit acceptance of the same. The technical & commercial terms are as per following:-

(b) Bidders technical & commercial bid (in case of two-part bid) as per the specifications finalized against the above tender and

(c) Subsequent correspondences between BHEL and the bidders, if any.

#### 1. Procedure of Reverse Auctioning

i. **Online Sealed Bid:** This duration of online sealed bid will be 60 minutes. All bidders to submit their online sealed bids during this period.

ii. **Online Reverse Auction:** The “opening price i.e. start price for RA and bid decrement will be decided by BHEL.

iii. If BHEL decides the lowest online sealed bid as the starting price, then the lowest bidder in online sealed bid shall be shown as current L1 automatically by the system and no additional confirmation / acceptance of that price by the sealed bid L1 bidder is required. System shall have the provision to indicate this bid as current L1.

iv. Bidders by offering a minimum bid decrement or the multiples thereof can displace a standing lowest bid and become “L1” and this continues as an iterative process.

- 3. Auction extension time:** If a bidder places a bid in the last 10 minutes of closing of the Reverse Auction and if that bid gets accepted, then the Auction's duration shall get extended automatically for another 10 minutes, for the entire auction (i.e. for all the items in the auction), from the time that bid comes in. Please note that the auto-extension will take place only if a bid comes in those last 10 minutes and if that bid gets accepted as the lowest bid. If the bid does not get accepted as the lowest bid, the auto-extension will not take place even if that bid might have come in the last 10 minutes. In case, there is no bid in the last 10 minutes of closing of Reverse Auction, the auction shall get closed automatically without any extension. However, bidders are advised not to wait till the last minute or last few seconds to enter their bid during the auto-extension period to avoid complications related with internet connectivity, network problems, system crash down, power failure, etc. The above process will continue till completion of Reverse Auction.

- 5. Bidding currency and unit of measurement:** Bidding will be conducted in *Indian Rupees*.

In case of foreign currency bids, exchange rate (TT selling rate of State Bank of India) as on scheduled date of tender opening (Part-I bid in case of two part bid) shall be considered for conversion in Indian Rupees.

- 6. Validity of bids:** Price shall be valid for **60 days** from the date of reverse auction. This shall not be subjected to any change whatsoever.

- 7. Lowest bid of a bidder:** In case the bidder submits more than one bid, the lowest bid at the end of Online Reverse Auction will be considered as the bidder's final offer to execute the work.

- 8. Bidders shall be assigned a Unique User Name & Password** M/s. -----, Bidders are advised to change the Password and edit the information in the Registration Page after the receipt of initial Password from M/s. ----- to ensure confidentiality. All bids made from the Login ID given to the bidders will be deemed to have been made by the bidders/bidders company.

- 9. Post auction procedure:** BHEL will proceed with the Lowest Bid in the Reverse Auction for further processing.

- 10. Any commercial/technical loading** shall be intimated to bidders prior to RA. The Price Format provided in this regard shall cover all these aspects. Commercial/ technical loading if any, shall be added by the respective bidder in its price during online sealed bid & Online Reverse Auction. Modalities of loading & de-loading shall be separately intimated to the bidders. The responsibility for correctness of total cost to BHEL shall lie with the bidders.

- 11. Computerized reverse auction** shall be conducted by BHEL (through M/s -----), on pre-specified date, while the bidders shall be quoting from their own offices/place of their choice. Internet connectivity shall have to be ensured by bidders themselves.

During the RA if a bidder is not able to bid and requests for extension of time by fax/ e-mail/ phone then time extension of additional 15 minutes will be given by the service provider provided such requests come before 5 minutes of auction closing time. However, only one such request per bidder can be entertained.

Despite this extension if bidder fails to upload his prices due to extreme case of failure of Internet connectivity, (due to any reason whatsoever may be) it is the bidders responsibility/decision to send fax/e-mail communication immediately to **M/s -----** furnishing the price the bidder wants to bid online with a request to the service provider to upload the faxed/e-mailed price online so that the service provider will upload that price on line on behalf of the Bidder. It shall be noted clearly that the concerned bidder communicating this price to service provider has to solely ensure that the fax message/e-mail is received by the service provider in a readable / legible form and also the Bidder should simultaneously check up with service provider about the clear receipt of the price faxed/mailed. It shall also be clearly understood that the bidder shall be at liberty to send such fax/e-mail communications of prices to be uploaded by the service provider only within the closure of Bid time and under no circumstance it shall be allowed beyond the closure of Bid time/reverse auction. It shall also be noted that the service provider should be given a reasonable required time by the bidders, to upload such prices online and if such required time is not available at the disposal of the Service provider at the time of receipt of the fax/e-mail message from the bidders, the service provider will not be uploading the prices and either BHEL or the service provider are not responsible for this unforeseen circumstances. In order to ward-off such contingent situation bidders are requested to make all the necessary arrangements/alternatives whatever required so that they are able to circumvent such situation and still be able to participate in the reverse auction successfully. Failure of power or loss of connectivity at the premises of bidders during the Reverse auction cannot be the cause for not participating in the reverse auction. On account of this, the time for the auction cannot be extended and neither BHEL nor Service Provider is responsible for such eventualities.

- 12. Proxy bids:** Proxy bidding feature is a pro-bidder feature to safe guard the bidders interest of any internet failure or to avoid last minute rush. The proxy feature allows bidders to place an automated bid in the system directly in an auction and bid without having to enter a new amount each time a competing bidder submits a new offer. The bid amount that a bidder enters is the minimum that the bidder is willing to offer. Here the software bids on behalf of the bidder. This obviates the need for the bidder participating in the bidding process until the proxy bid amount is decrementally reached by other bidders. When proxy bid amount is reached, the bidder (who has submitted the proxy bid) has an option to start participating in the bidding process.

The proxy amount is the minimum amount that the bidder is willing to offer. During the course of bidding, the bidder cannot delete or change the amount of a proxy bid.

Bids are submitted in decrements (decreasing bid amounts). The application automates proxy bidding by processing proxy bids automatically, according to the decrement that the Auction Originator originally established when creating the auction, submitting offers to the next bid decrement each time a competing bidder bids, regardless of the fact whether the competing bids are submitted as proxy or standard bids. However, it may please be noted that if a manual bid and proxy bid are submitted at the same instant manual bid will be recognized as the L1 at that instant.

In case of more than one proxy bid, the system shall bid till it crosses the threshold value of each lowest proxy bid and thereafter allow the competition to decide the final L1 price.

Proxy bids are fed into the system directly by the respective bidders. As such this information is privy only to the respective bidder(s).

13. Bidders are advised to get fully trained and clear all their doubts such as refreshing of Screen, quantity being auctioned, tender value being auctioned etc. from **M/s. -----**

Any variation between the final bid value and that in the confirmatory signed price breakup document will be considered as tampering the tender process and will invite action by BHEL as per extant guidelines for suspension of business dealings (as available on [www.bhel.com](http://www.bhel.com)).
17. Bidders bid will be taken as an offer to execute the work of the item as per **Enquiry no. -----**, **Dated -----**. Bids once made by the bidder, cannot be cancelled/withdrawn and bidder shall be bound to execute the work as mentioned above at bidders final bid price. Should bidder back out and not execute the contract as per the rates quoted, BHEL shall take action as per extant guidelines for suspension of business dealings (as available on [www.bhel.com](http://www.bhel.com)).
18. Bidders shall be able to view the following on their screen along with the necessary fields during Online Reverse Auction:
  - a. Leading (Running Lowest) Bid in the Auction (only total price of package)
  - b. Bid Placed by the bidder
  - c. Start Price
  - d. Decrement value
  - e. Rank of their own bid during bidding as well as at the close of auction.
19. BHEL's decision on award of contract shall be final and binding on all the Bidders.
20. BHEL reserves the right to extend, reschedule or cancel the Reverse Auction process at any time, before ordering, without assigning any reason, with intimation to bidders.
21. BHEL shall not have any liability to bidders for any interruption or delay in access to the site irrespective of the cause. In such cases, the decision of BHEL shall be binding on the bidders.
22. Other terms and conditions shall be as per bidder's techno-commercial offers and other correspondences, if any, till date.
