Sub: Implementation of Integrity Pact in BHEL –reg.

During the 23rd Quarterly Review Meeting (QRM) on Implementation of Integrity Pact (IP) in BHEL held on 08.12.2016, IEMs have expressed their concern over suppliers disturbing them over phone/ email for clarifications related to tender. It was decided that the Name and details for communication of the concerned officer/s of the tender issuing department, who is/are to be contacted in case of any queries related to tender, must be clearly spelt out in the tender.

All Units/ Regions are therefore advised to include the following modified clause in NIT on Integrity Pact (earlier Circular No. 06 of 2016-17 issued by Corp MM stands superseded) and Name and Contact details (Phone, email) of the concerned officer/s of the tender issuing department shall be provided at the end of the Clause on 'Integrity Pact' in the NIT as indicated below:

Integrity Pact (IP)

- (a) IP is a tool to ensure that activities and transactions between the Company and its Bidders/ Contractors are handled in a fair, transparent and corruption free manner. A panel of Independent External Monitors (IEMs) have been appointed to oversee implementation of IP in BHEL.

The IP as enclosed with the tender is to be submitted (duly signed by authorized signatory who signs in the offer) along with techno-commercial bid. Only those bidders who have entered into such an IP with BHEL would be competent to participate in the bidding. In other words, entering into this Pact would be a preliminary qualification.
