Please refer GCC, Rev.06 which is available on www.bhelnem.com/Tenders.aspx. GST related corrigendum to GCC, Rev.06 is enclosed and same is to be considered along with GCC, Rev.06. Bidders are requested to go through the same while submitting the offer.

1. Offers should be submitted **ONLINE via e-Procurement System** separately in two parts as follows :
Part-I: **TECHNO-COMMERCIAL BID** Part-II: **ONLINE PRICE BID**

For detailed instructions, please see clause no. 2 of "Instructions to Bidders of GCC Rev. 06".

2. If bidder uploads price bid in the unpriced section (techno-commercial attachment page) of the tender in e-procurement, in that case bidder(s) shall only be responsible for such mistake and any consequences thereof. Hence all bidders are requested to be more careful at the time of uploading the Unpriced and Price Bid for Part-I and Part-II respectively to avoid mismatch.
3. Bidders shall submit their offers meeting all the requirements as indicated in this Enquiry Letter.

12. Delivery Schedule :

- a) (Supply): Lot I - Four (04) months from the date of "drgs/docs approval in CAT-I" or "manufacturing clearance issued by BHEL", whichever is earlier. This is subjected to bidder's 1st submission of drawing/docs within two weeks from the date of PO. Vendor to re-submit documents, if any, within 10 days only, taking care of all the comments of BHEL/customer. Any deficiency in submitted documents w.r.t agreed specification/comments from BHEL shall be treated as non-submission. In case, there are delays in submission/resubmission of documents beyond the stipulated time frame indicated above, that much days of delay would be reduced from the delivery period.

Subsequent Lots: - Separate clearance shall be given for subsequent lots. Delivery period shall be Three (03) months from BHEL clearance.

- b) Price Basis: The price variation shall be limited to 10% of total ex-works actually supplied (cable size wise) and negative (-ve) price variation shall be unlimited as per the PVC formula, which is available at <http://www.bhhelpem.com/Tenders.aspx>.
- c) Quantity Variation - Overall quantity variation shall $\pm 30\%$ of the total contract value.

14. Pre-Qualifying Requirement :

Bidders are requested to furnish the details as per "TECHNICAL and FINANCIAL PRE-QUALIFYING REQUIREMENTS" (enclosed with the enquiry document). Along with the offer, bidders to furnish all legible & valid documents required as per Technical & financial PQR. The same shall be properly co-relating with respective clause of PQR. Bids of only those bidders, who meet the Technical pre-qualifying requirements, shall be evaluated.

15. The bidders (who are not registered with BHEL-PEM) - Online Registration Portal is operational in BHEL. Non-registered bidders, who wish to apply for registration with BHEL-PEM, have to apply through Online Registration Portal available at www.bhhelpem.com → vendor section → Online Supplier Registration. 16. Bidders to note for compliance that this is a conditional enquiry (Open Domestic Tender), and the price bid (Part-II) opening/RA shall be subjected to following criterion :
- Fulfilment of Technical and Financial pre-qualifying requirements.
 - Approval of bidder by Customer: Approval shall be taken up by BHEL with customer based on the credentials/ reference list (for bidders presently not approved by customer).
 - Bidder, who are approved by NTPC in any NTPC/BHEL project for LT XLPE POWER CABLES, shall be considered as approved by end customer for this tender subject to the fulfilment of the conditions, if any, mentioned in the NTPC approval letter. Bidder must furnish their NTPC approval letter for LT XLPE POWER CABLES package in lieu of the credentials mentioned at S.No. (b) above.

17. BHEL reserves the right to go for Reverse Auction (RA) (Guidelines as available on www.bhel.com) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. Bidders to give their acceptance with the offer for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.

Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'Process compliance form' (to the designated service provider) as well as 'Online sealed bid' in the Reverse Auction. Non-submission of 'Process compliance form' or

'Online sealed bid' by the agreed bidder(s) will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines for suspension of business dealings with suppliers/ contractors (as available on www.bhel.com).

The bidders have to necessarily submit online sealed bid less than or equal to their envelope sealed price bid already submitted to BHEL along with the offer. The envelope sealed price bid of successful L1 bidder in RA, if conducted, shall also be opened after RA and the order will be placed on lower of the two bids (RA closing price & envelope sealed price) thus obtained. The bidder having submitted this offer specifically agrees to this condition and undertakes to execute the contract on thus awarded rates.

If it is found that L1 bidder has quoted higher in online sealed bid in comparison to envelope sealed bid for any item(s), the bidder will be issued a warning letter to this effect. However, if the same bidder again defaults on this count in any subsequent tender in the unit, it will be considered as fraud and will invite action by BHEL as per extant guidelines for suspension of business dealings with suppliers/ contractors (as available on www.bhel.com)."

As a reminder to the bidders, system will flash following message (in RED Colour) during the course of 'online sealed bid':

"Bidders to submit online sealed bid less than or equal to their envelope sealed bid already submitted to BHEL".

19. Inspection shall be done by BHEL/End Customer/Third party Agency (finalized by BHEL).

The bidder along with its associate/collaborators/sub-contractors/sub-vendors/consultants/ service providers shall strictly adhere to BHEL Fraud prevention policy displayed on BHEL website <http://www.bhel.com> and shall immediately bring to the notice of BHEL management about any fraud or suspected fraud as soon as it comes to their notice.
