#### **GENERAL TERMS AND CONDITIONS**

- 1. QUALIFYING CRITERIA: Documents to be furnished under Techno Commercial Bid Part-I/ (cover-II):
  - Copy of Service Tax registration.
  - 2. Copy of PAN card indicating PAN No.
  - 3. No deviation certificate as per Annexure III, duly completed.
  - 4. Original tender enquiry document duly signed and stamped in token of acceptance of tender conditions.
- 2. Price to be quoted as in a separate sealed envelope superscribing on the envelope "PRICE BID, Tender no., Due date and Time" as per Price Format (Annexure-IV) in Part-II/ Cover IV (Price Bid).
- 3. The quoted rate shall be firm for a period of two years.
- 4. Price: It is mandatory to comply with all taxes applicable for the required services. Your price should be inclusive of all taxes, duties and levies except service tax. However, the amount towards Service Tax should be indicated separately in the specified place in the Price Performa enclosed as Annexure IV.
- 5. Bidders may inspect the premises to assess the quantum of materials required for the entire scope of work/services and quote accordingly. In case of submission of the quotation, it will be presumed that the bidder has understood the entire scope and quoted accordingly. Nothing extra will be payable on any account whatsoever later on.
- 6. Evaluation Criteria: Quotation will be evaluated on the basis of Qualifying Criteria, Suitability of the sample Dispenser and total cost to BHEL (excluding optional items) over two years period. Contract will be awarded to lowest bidder. However, the lowest bidder will be asked to match the lowest rates received for individual optional item against the tender Enquiry.
- 7. Bidder will be required to furnish 10% of the contract value as security deposit in the form of Demand Draft/ Local Cheque of scheduled banks in favour of BHEL before start of the contract. The security deposit will be refunded, without interest and after adjustment of any dues from the contractor on successful completion of the contract.

8. BHEL reserves the right to reject any offer at any stage of the tendering process without assigning any reason to the bidder.

- 9. If the services of the service provider is not satisfactory BHEL reserves the right to terminate the contract and forfeit the Security Deposit with one week notice period.
- 10. Payment Terms: On receipt of invoice on monthly basis, cheque/NEFT payment will be made within 30 days of receipt of invoice, duly certified by BHEL representative in respect of satisfactory services rendered by the party.
- 11. Tender/offer should be kept valid for a period of 90 days from the date of opening of the tender for placement of order.
- 12. Delivery: The Towel Dispensers to be supplied and installed within the specified delivery period of two weeks (X) from the date of award of contract. However, the maximum acceptable delivery period shall be four weeks (Y). Any offer beyond the `max. acceptable delivery period' will be rejected. All offers which do not conform to the specified delivery period (X) but are within the max. acceptable delivery period (Y) shall be loaded for the delayed delivery period beyond `X' @ 0.5% per week or part thereof subject to max. of 10% of the offered value.
- 13. Liquidated Damages/ Penalty: Liquidated damages shall be 0.5% of the order value per week of delay or part thereof, subject to a maximum of 10% of the full order value.

- (2) Bidders to provide the following in the Technical Bid (Part-1):

  - (iii) One number fully operational Towel Dispenser Sample as per Sl. No. 1
