#### **DETAIL OF WORK**

#### (A) SCOPE OF WORK: The work mainly comprises of as follows:

#### (1) Preparation of earth pits and laying of earth strips.

- 1.1 Preparation of earth pits: Excavation of earth pit of size as per given drawing receiving and shifting of material from store to work place, fixing of electrodes of size as per given drawing and backfilling of pit. All the material shall be provide by BHEL.
- **1.2** Laying of connections of earth strips: Receiving and shifting of material from store to work place, laying and connecting of earth strip from earth pit to concerned installation in all respect.

#### (2) Miscellaneous electrical wiring work.

- **2.1** Batten point wiring: Wiring will be done as per instruction of area in-charge. All material will be Issued from WE&S /Township store.

- 2.5 Laying and connecting of sub ó main: Laying of Sub ó Main will be done in township. The work includes removing of old Sub-Main and laying of new Sub-Main. All material will be issued from WE&S /Township store.

#### (B) SCOPE OF CONTRACT WORK FACILITY

- (a) All the tools and tackles, spares including consumable like gear oil, grease, cotton waste, Electrical items, gas cutting, welding and machining facilities etc. shall be provided by BHEL- Jhansi free of cost.
- (b) The contractor for the work mentioned above shall maintain sufficient staff. Work shall be done in first and Second shifts. However during production/ emergency, work in third shift may also be done in some areas as instructed by the in charge maintenance.

- **(C) DEPLOYMENT OF MANPOWER:** To carry out the above mentioned work during total contract period the contractor will deploy adequate numbers of workers with a adequate knowledge and experience with an approval of section / maintenance in-charge.
- **(D) URGENT WORK:** The contractor shall have to comply with the priorities fixed by the maintenance in charge or for taking urgent repair work.
- **(E) CANCELLATION OF CONTRACT IN FULL OR PART:** Contract shall be canceled in full or part if the contractor:
- (a) At any time makes defaults in proceeding with the work with due negligence and continuous to do so after a notice in writing or 7 days from the AGM (WE&S) BHEL, Jhansi.
- **(b)** Commits defaults in complying with any if the terms and conditions of the contract.
- **(F) PERIOD OF CONTRACT:** The period of contract will be for one year (Twelve months) or completion of total work whichever is earlier.

Above tender is in two Bid System - (Techno Commercial Bid & Price Bid).

- 1) The tender is to be submitted in two parts via. a)Techno Commercial bid and b) price/rate bid.
  - a) Techno-Commercial Bid-The Technical Bid Application (Annexure I) and its enclosures (along with the Contractors Obligations, General Terms & Conditions and copies of qualifying requirements) must be submitted in one sealed envelope superscripted with "Tender for Miscellaneous Electrical work in BHEL-Jhansi Factory and Township. (Work Contract). (Work Contract) TECHNOCOMMERCIAL BID". EMD/Cost of Tender Document or Documents required as per qualifying requirements must be enclosed.

"PRICE BID". Any other enclosures, which the bidder wishes to submit, must be enclosed with the Technical Bid only. The price bid envelope should contain the rates only. ## TENDER EVALUATION CRITERIA

The evaluation of the Tender will be carried out as follows:

- 1) BHEL officials may visit the biddersq office & their clients place to evaluate the capability and assess the performance.
- 2) Capability of the Contractor will be assessed on the basis of employees including supervisors on their rolls, machinery, equipments in its possession, previous track record, experience in other organizations, etc.
- 3) Price Bids will be opened or participation in Reverse auction will be allowed to only TechnoCommercially accepted bidders.
- 4) The contractor shall be awarded the work on overall L-1 basis if otherwise not specified in the tender document.
- In case of a tie between two or more lowest bidders, snap bid shall be called with discount on the offered rates. If snap bid is not feasible then the L1 shall be decided with lottery system. In case of discrepancy in words and figures offered in price bid the decision shall be taken based on annexure 16-14.

## CONTRACTOR & OBLIGATIONS

## A) <u>CONTRACTUAL</u>

#### Towards selection, control and supervision of employees

- Contractor shall decide the number of employees to be deployed for execution of the work awarded to him and he or his authorized representative will be solely entitled to instruct such workers about the manner of carrying out the work as per the prescribed specifications and quality plan.
- 2) Contractor shall supervise the work allotted to him and to be carried out by his employees.
- 3) Contractor will ensure that the job is executed through his employees on his rolls and under no circumstances the contractor will deploy any casual employee to carry out the job nor shall sub-contract the job without prior written permission.
- 4) Age of workers: The contractor shall not employ any person who has not completed his 18 years. Also age of worker deployed should not exceed 60 years.
- 5) Contractor to ensure that the employees deployed in the premises of BHEL are physically and mentally fit and do not have any criminal record. Such employees should possess requisite skill, proficiency, qualification, experience etc. acceptable to concerned department.
- 6) Discipline: The Contractor shall be responsible for the discipline of his own employees deployed under the contract. In case of any loss to the BHEL Jhansi on account of indiscipline of employee then such loss shall be assessed and recovered from the running bills of the contractor or from the security deposit.
- 7) The contractor, on advice of authorized BHEL official, shall immediately remove any person employed by him, who may in the opinion of such authorized BHEL official is involved in misconduct. Such person shall not be re-employed by the contractor without prior permission.
- 8) Contractor will keep watch on his employees and he will be liable for any pilferage / loss to BHEL due to acts of omission and commission by his employees. Similarly, liability for any compensation to outsiders on account of any act of omission and commission by the employees deployed by the contractor shall lie exclusively with him.

- 9) Contractor to ensure compliance of the instructions contained in safety guidelines issued by Safety Deptt. (HSE) of BHEL-Jhansi (Same can be downloaded from BHEL Jhansi website). The contractor has to ensure that all precautions are taken for safety of his employees and equipments.
- 10) In the event of termination of contract for any reason whatsoever, the contractor shall withdraw all his employees from the establishment of BHEL. In case contractor decides to terminate services of his employees, he should settle all terminal dues required.
- 11) Tools, tackles and materials: Contractor shall provide to his employees all tools, tackles, material, equipments as specified in contract and maintain the same to carry out the job under the contract at his risk and cost. BHEL shall not have any liability for these tools, tackles, equipments or material.

#### B) Towards statutory liability

1. As mentioned in the terms and conditions enclosed as Annexure £qof this contract. 2. Contractor shall indemnify BHEL against all claims by statutory authorities and losses under various Labour Laws, statutes or any civil or criminal law in connection with employees deployed by him.

#### C) Towards Finance

Contractor to arrange his own finance for carrying out the job including supply of tools, tackles and equipments, if required, to his employees, materials, payment of wages to his employees etc. Rates to be as per price bid.

# GENERAL TERMS & CONDITIONS FOR CONTRACTORS FOR DEPLOYMENT OF WORKERS UNDER WORKS CONTRACT

#### 1. Security Deposit:

#### A. Modes of deposit:

The balance amount to make up the required Security Deposit of 5% of the contract value may be accepted in the following forms:

- i) Electronic Fund Transfer in favor of BHEL(Refer BHEL Bank account details as per point no (i) of Annexure A.
- ii) Bank Guarantee from Scheduled Banks/ Public Financial Institutions as defined in the Companies Act. The Bank Guarantee format should have the approval of BHEL
- iii) Fixed Deposit Receipt issued by Scheduled Banks/ Public Financial Institutions as defined in the Companies Act (FDR should be in the name of the Contractor, a/c BHEL)
- iv) Securities available from Indian Post offices such as National Savings Certificates, Kisan Vikas Patras etc. (held in the name of Contractor furnishing the security and duly endorsed/hypothecated/pledged, as applicable, in favour of BHEL)

(Note: BHEL will not be liable or responsible in any manner for the collection of interest or renewal of the documents or in any other matter connected therewith.)

#### **B.** Collection of Security:

At least 50% of the required Security Deposit, including the EMD, should be collected before start of the work. Balance of the Security Deposit can be collected by deducting 10% of the gross amount progressively from each of the running bills of the Contractor till the total amount of the required Security Deposit is collected.

If the value of work done at any time exceeds the contract value, the amount of Security Deposit shall be correspondingly enhanced and the additional Security Deposit shall be immediately deposited by the Contractor or recovered from payment/s due to the Contractor.

The recoveries made from running bills (cash deduction towards balance SD amount) can be released against submission of equivalent Bank Guarantee in acceptable form, but only once, before completion of work, with the approval of the authority competent to award the work.

Security Deposit shall be released to the Contractor upon fulfilment of contractual obligations as per terms of the contract. The Security Deposit shall not carry any interest.

## Guidelines for dealing with "Discrepancy in words & figures – quoted in price bid"

In case of non-conformities/errors/discrepancies are observed between the quoted prices infigures and that in words, following guidelines are to be followed:-

- (d) If there is such discrepancy in an offer, the same shall be conveyed to the bidder with target date up to which the bidder has to send his acceptance on the above lines and if the bidder does not agree to the decision of the tenderer, the bid is liable to be ignored.
