1. BIDDER TO INFORM HIMSELF FULLY:

- 1.1. The bidder shall closely peruse all the clauses, specifications, drawings etc., specified in the tender documents, and the offer made should be in accordance with these documents. If bidder requires any clarification and additional information on any of the tender documents/conditions, the bidder shall contact the BHEL Official inviting bids at the earliest.
- 1.2. Bidders are advised to study all the tender documents carefully and submit their offer and the Bidder obliged to honor the offer without any modifications. Any offer not meeting the scope/specifications, terms, conditions, and any other clause specified in the tender documents shall be liable to be rejected.
- 1.3. No Counter Conditions will be accepted and bids with counter conditions will be summarily rejected. Any deviations shall be indicated under relevant clauses only. However the Bidder can submit their own SLA whose acceptance will be at the sole discretion of BHEL.

2. PROCEDURE FOR SUBMISSION OF BIDS

- 2.1. The bidder shall sign all the pages of the Tender document and all the supporting documents. Signing of the document means that the bidder has fully understood the Tender and complies with all the requirements.
- 2.1. The Techno-Commercial bid and the Price Bid shall be submitted on or before 14:00 Hrs of the due date indicated in the tender notice.
- 2.2. Offer shall be made in two parts in separate envelopes, as specified below.

Part-I: Techno-Commercial Bid

This part shall consist of the following documents in a separate envelope:

- a. All pages of the tender document should be signed.
- b. Un-priced Price Bid format duly signed with the tax break up details
- c. Copy of Service Tax registration Certificate, TIN No. and PAN No.
- d. The offer shall not contain any counter Conditions / Terms by the bidder. However the Bidder can submit their own SLA whose acceptance will be at the sole discretion of BHEL.

Part-II: Price Bid

This part shall consist of the following documents in a separate envelope:

- b. Price Bid shall not contain any technical details and/or Techno-Commercial terms/conditions.

5. BID OPENING

- 5.1 PART-I (Techno-commercial bid) shall be opened on the due date and time as specified in the Tender Notification, in the presence of bidders who may like to attend. Part-II (Price Bid) shall be opened only for such offers, which have qualified after evaluation of PART-I.
- 5.2 For Price Bid (Part-II) opening, date and time of Price opening shall be intimated to the bidders qualified in PART-I.

- 5.3 Not more than two representatives will be permitted to be present for the tender opening. Representative participating in Tender Opening must bring company's authorization letter in original.
- 5.4 Unsolicited bids shall not be entertained at any stage of the tendering process.
- 5.5 No Literature / Data Sheets other than what is relevant for the offer shall be enclosed. All such enclosures shall be considered as unread and also will not be considered as part of the quotation.
- 5.6 BHEL reserves the right to carry out negotiations with bidder on the tender offer / price.
- **6. Applicability of Taxes:** VAT on AMC spares value and Service Tax on AMC service value shall be quoted by the bidder. The service tax and VAT will be reimbursed based on documentary evidence.
- **Payment Terms**: The payment of AMC charges will be made at the end of each quarter. The payment will be made through EFT after receipt of invoice and verified by Informatics Centre.
- **8.** Contract Period: One year from the date of Acceptance of LOI. However this contract can be short closed after six months with one month notice period, if required by BHEL.BHEL will make payment only for the period AMC service utilized. On termination of the 'Contract', no payment shall be payable to 'Company' for the remaining period from the date of Termination
- 9. <u>Downtime Penalty:</u> Downtime will be calculated on monthly basis. The deduction for downtime will be as per the calculation given below:
 Downtime in days = A

Monthly AMC value in rupees = B

Deduction Factor = D = 3

Amount to be Deducted in Rupees = M = (A-2) * (B/30) * D

10. Price and Validity:

- Price shall be firm throughout the tenure of the contract. Variation of what so ever nature is to Vendor's account. Applicable Taxes shall be quoted separately in unambiguous terms. Invoices for claiming the contract price with relevant documentary evidence shall be as per the prevalent law.
- Price should be valid for a period of ninety days from the date of opening of the tender.
- Bidder should give the price bid in the format as per Annexure VI.

11. <u>Service Tax</u>:

The Bidder shall not include Service Tax in their quoted rates; but the bidder has to separately indicate the Service Tax rate, amount and workings thereof in the Price bid schedule included in the bid documents.

If service tax amount is not indicated separately in the price bid schedule included in the Bid documents, it will be presumed that the quoted rate is inclusive of applicable service tax and bids will be evaluated accordingly.

Bidders have to quote the applicable Service Tax payable in the Price bid format included in the Bid document which shall be considered for evaluation. The same shall be considered for reimbursement against valid documentary evidence to successful bidders.

12. Non-Disclosure Agreement:

The successful bidder should execute a Non-Disclosure Agreement as given in the format in Annexure – IV

13. Discrepancy in "words " & " Figures "

- a) If, in the price structure quoted for the required goods/services/works, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless in the opinion of the purchaser there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price corrected accordingly.
- b) If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and
- c) If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject of (a) and (b) above.
- d) If there is such discrepancy in an offer, the same shall be conveyed to the bidder with target date up to which the bidder has to send his acceptance on the above lines and if the bidder does not agree to the decision of the purchaser, the bid is liable to be ignored.

Whereas 'Company' is in the business of maintaining networking components and whereas the 'BHEL'

one year as per contract (<loi and="" date="" no="" ref="">) and 'Company' has agreed to provide AMC for Network</loi>
Switches to the 'BHEL' under the following terms and conditions.
Now, therefore, the agreement witnessed as follows:

1. CONTRACT REFERENCE:

1.1 This Document shall be read along with the contract (<loi ref no and date>) .This Terms and Conditions of the contract shall be fulfilled along with the clauses of this agreement.

2. SCOPE OF CONTRACT (in brief):

Company will provide AMC for Network Switches at BHEL, Ranipet for a period of one year in consideration of the payment as per Terms and Conditions of the Contract. This contract can be short closed after six months with one month notice period, if required by BHEL.

3. **DEFINITIONS**:

In this agreement, 'Contract' means the Contract referred in the Clause 1.1

4. PAYMENT TERMS:

The payment of AMC charges will be made at the end of each quarter. The payment will be made through EFT after receipt of invoice and verified by Informatics Centre.

5. TERMINATION AND FORE-CLOSURE:

'BHEL' reserves the right to terminate the order/contract, upon situations arising due to non-compliance of contract Terms and conditions or non-performance of the manpower continuously for more than one month.

On termination of the 'Contract', no payment shall be payable to 'Company' for the remaining period from the date of Termination.

6. **CONFIDENTIALITY**:

'Company' and its representatives shall, at all times, maintain complete confidentiality of all data, information, software, drawings and documents, etc. belonging to 'BHEL' and also of the systems, procedures, reports, input documents, manuals, results and any other documents discussed and/or finalized during the course of execution of the 'contract.

7. **ARBITRATION**:

In all cases of disputes emanating from and in reference to this agreement the matter shall be referred to the sole arbitration of the Head of the Unit of BHEL, Ranipet or any other person (including an employee of BHEL, even though he had to deal with the matter relating to this agreement in any manner) nominated by the said Head of the Unit to act as sole arbitrator. The arbitration shall be under 'THE ARBITRATION AND CONCILIATION ACT OF 1996' and the rules thereunder. The arbitrator may from time to times with the consent of the parties enlarge the time for making and publishing the award. The decision of the sole arbitrator is binding on both the parties.

8. JURISDICTION & GOVERNING LAWS:

- 8.1 In case of any suit or other legal proceedings arising under this contract the courts at Ranipet (Vellore District) Tamil Nadu only shall have the jurisdiction. This contract will be governed in all respects by India Laws.
