- 2.2 Tenders shall be uploaded strictly in accordance with the requirements of the above tender documents. Deviations (Technical as well as Commercial as per attached sheet), if any, shall be listed out separately in Annexure-II, along with reasons for taking such deviations.

- 2.3 Standard pre-printed terms & conditions of the tenderers shall not be considered valid.

- 2.4 In case there is no change in the technical scope and / or specification and / or commercial terms and conditions, the bidder/s shall not be allowed to change his / their price bids after the due date within the validity period.

- 2.9 **Delivery:- For Main Supply:-** Four (04) months from the date of drgs. /docs. approval in CAT-I issued by BHEL/CUSTOMER. This is subject to bidder's 1st submission of drawing/docs within two week from the date of P.O. Vendor to re-submit documents within 10 days only, taking care of all the comments of BHEL."

For Demonstration & Handing over to site/BHEL's customer: Vendor to depute their representative to site for carrying out activities within two weeks of intimation by BHEL as per site requirement, in case of delay in deputation, L.D. shall be leviable @ 0.5% per week of delay on value specified against "Demonstration charges".

- 2.10 **Please contact to BHEL (via mail or phone) for any clarification (technical or commercial) at least one week before the due date (Techno-Commercial bid opening).**

- 2.11 **Bidder to note for compliance that this is conditional enquiry and the price bid (Part-II) opening / Reverse Auction is subject to the following:-**

- a) **Techno-commercial qualification / recommendation of bidder by the BHEL-PEM**
b) **Customer specified makes (as per Annexure –IV of section –I of Technical specifications) shall be applicable, no separate approval of vendors from Customer (GSECL) shall be required for subject package.**

Note:- Non-registered Vendors who wish to apply for registration in BHEL-PEM can apply through Online Registration Portal available at www.bhelpem.com - vendor section - Online Supplier Registration. All credentials and/or documents duly signed and stamped related to registration has to be uploaded on the website and submit the application for registration. One set of hard copy of the filled-up SRF downloaded from Online Registration Portal duly signed and stamped has to be submitted.

- 2.12 **PRE-QUALIFICATION REQUIREMENT:-**

Technical Pre-Qualification Requirement Criteria are part of NIT and the bidders are required to submit Technical Pre-Qualification Requirement Criteria along with their offer. **Only those vendors, who fulfill Technical requirements, shall be considered further for evaluation.**

- 2.13 **Evaluation** will be done on item wise basis. Prices for "Demonstration & handing over charges" are firm & already specified in technical spec. Same shall not be considered for evaluation. However, Prices of two (02) visits & Ten (10) days shall be considered for ordering for each vendor for site demonstration inline with rate specified in technical spec.

Further, **evaluation** shall be done excluding GST quoted by bidders, i.e. on "Ex-Works + Freight" only.

2.14 CIF content:- Not Applicable

2.15 Payment Terms shall be as per Clause no. 9.2 of GCC Rev 06 & GST related corrigendum of GCC Rev-06.

2.16 Foreign bidders will have to quote C&F (cost & freight) basis. For importing materials on C&F basis, bidders to note following:

- As per Incoterms (CFR), risk transfers to buyer when the goods have been boarded on the ship in the country of Export. Hence, shipped on board date mentioned on the clear Bill of Lading or Air way Bill, shall be treated as the date of Shipment/ Dispatch for all contractual purposes including calculation of LD.
- Usance period (90 days) of the L/C shall start from the date of Bill of lading/Air Way Bill.
- Bill of Lading shall be considered as equivalent document (refer clause 9.7.1 b of GCC rev.06) for recognition of dispatch.
- For claiming payment under clause 9.1.1 and 9.2.1 of GCC rev.06, Bill of lading shall be considered instead of receipted LR (refer clause 9.7.2 b of GCC rev.06).
- Freight is to be quoted as inclusive in basic price by vendor and is not to be quoted separately.
- Insurance for evaluation purposes shall be @ 0.1 % of quoted C&F price.
- There will be no change in MRC payment.

2.17 All the tender documents shall automatically become a part of the Order/Contract after its finalization.

2.18 The bidder along with its associate/collaborators/sub vendor/subcontractors/sub vendors/consultants/ service providers shall strictly adhere to BHEL fraud Prevention Policy displayed on BHEL website www.bhel.com and shall immediately bring to the notice of BHEL Management about any fraud or suspected fraud as soon as it comes to their notice. BHEL Fraud prevention policy is also uploaded in vendor's section on www.bhelpem.com.

2.19 If any bidder uploads price bid in the unpriced section (techno-commercial attachment page) of the tender in e-procurement, in that case bidder(s) shall only be responsible for such mistake and any consequences thereof. Hence, all bidders are requested to be more careful at the time of uploading the Unpriced and Price Bid for Part-I and Part-II respectively to avoid mismatch.

2.20 "BHEL reserves the right to go for Reverse Auction (RA) (Guidelines as available on www.bhel.com) instead of opening the sealed envelope price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. Bidders to give their acceptance with the offer for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.

Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'Process compliance form' (to the designated service provider) as well as 'Online sealed bid' in the Reverse Auction. Non-submission of 'Process compliance form' or 'Online sealed bid' by the agreed bidder(s) will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines for suspension of business dealings with suppliers/ contractors (as available on www.bhel.com).

The bidders have to necessarily submit online sealed bid less than or equal to their envelope sealed price bid already submitted to BHEL along with the offer. The envelope sealed price bid of successful L1 bidder in RA, if conducted, shall also be opened after RA and the order will be placed on lower of the two bids (RA closing price & envelope sealed price) thus obtained. The bidder having submitted this offer specifically agrees to this condition and undertakes to execute the contract on thus awarded rates.

If it is found that L1 bidder has quoted higher in online sealed bid in comparison to envelope sealed bid for any item(s), the bidder will be issued a warning letter to this effect. However, if the same bidder again defaults on this count in any subsequent tender in the unit, it will be considered as fraud and will

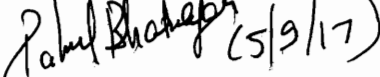
