 - Authorization letter from their principal is mandatory
 - In case of foreign principal: An agency agreement deed copy is required.

Note- Vendor to submit PQR document along with offer. Bidders who qualifies in above qualifying requirement shall be eligible for techno-Commercial evaluation of the offer.
