- c. **For manufacturer:** - Capabilities with respect to personnel, equipment and manufacturing Facilities.
Or for Trader/Dealer/Agent etc.
 - a. Authorization letter from their principal is mandatory
 - b. In case of foreign principal: An agency agreement deed copy is required.

Note- Vendor to submit PQR document along with offer. Bidders who qualifies in above qualifying requirement shall be eligible for techno-Commercial evaluation of the offer.
