18. Delivery:

For Main Supply (along with commissioning spares):-

The delivery completion shall be "Six (06) months from Drgs. /Docs. approval in CAT-I issued by BHEL/Customer. This is subject to bidder's 1st submission of drawing/docs within two weeks from the date of P.O. Vendor to re-submit documents within 10 days only, taking care of all the comments of BHEL. In case there are delays of submission/resubmission of drawings/documents as per above schedule, that much delay would be reduced from delivery period.

For Mandatory Spares:-

Delivery shall be 03 months from the date of manufacturing clearance. Separate dispatch/manufacturing clearance will be issued for mandatory spares as per SCC Rev00

24. Pre-Qualifying Requirement

Bidders who fulfil PRE-QUALIFICATION REQUIREMENT (PQR) criteria are eligible to participate in this tender. Bidders are requested to provide the details as per PQR. Bids of only those bidders shall be evaluated who shall meet the PQR.

25. In case of foreign bidders, bidders have to quote the prices on C & F Basis instead of FOB Basis. Further, foreign bidder to please note the following points :-

- Shipped on board* date mentioned on the clean Bill of Lading or Air way Bill, shall be treated as the date of shipment/ Dispatch for calculation of LD.
- Usance period (90 days) of the L/C shall start from the date of Bill of lading/Air Way Bill.
- Bill of Lading shall be considered as equivalent document (refer clause 9.7.1 b OF GCC Rev-06) for recognition of dispatch.
- For claiming payment under clause 9.1.1 and 9.2.1 Bill of lading shall be considered instead of receipted LR (refer clause 9.7.2 b of GCC rev-06)
- Freight is to be quoted as inclusive in basic price by vendor and is not to be quoted separately.
- Insurance for evaluation purposes shall be @ 0.1 % of quoted C&F price.
- There will be no change in MRC payment.

26. Evaluation shall be done on project wise. (Total cost to BHEL i.e. FOR site price). Separate offers are required for each project i.e. Techno-Commercial bids and Price bids should be submitted separately for separate projects. Enquiry No. & Name of the project/package is to be clearly mentioned in BOLD LETTERS on top of each envelope submitted.

27. The Bidder along with its associate/ collaborators/ sub-contractors/ sub-vendors/ consultants/ service providers shall strictly adhere to BHEL Fraud Prevention Policy displayed on BHEL website <http://www.bhel.com> and shall immediately bring to the notice of BHEL Management about any fraud or suspected fraud as soon as it comes to their notice.
