BHEL has issued tender enquiry to approved agency by Delhi Govt. for entering into rate contract for two years for collection, transportation, treatment & disposal of bio-medical waste from BHEL dispensary at Asiad Khelgaon & Lodhi Road, New Delhi. You are requested to submit your competitive bid in sealed envelope for the subject work before due date and time.

1. Terms & conditions of tender:

- 1.1 The Tender Enquiry No. & due date must be legibly super scribed on the envelope.
- 1.2 Tender shall be received and opened at BHEL House, Siri Fort, New Delhi on the due date and time as mentioned above.
- 1.3 Tenders shall be strictly in accordance with the tender specifications. Any deviation may lead to rejection of tender.
- 1.4 The offers shall remain valid for 60 days' period from the due date of submission of tenders.
- 1.5 BHEL shall be under no obligation to accept the lowest or any other tender and shall be entitled to accept or reject any tender in part or full without assigning any reason whatsoever.
- 1.6 The complete tender document is available on e-procurement portal and BHEL web site (www.bhel.com) for download. Tenders received after due date & time are liable to be rejected.
- 1.7 Price quoted by the approved agency will be firm for two years and no escalation on account of labour or fuel or any other reason whatsoever will be paid to the successful tenderer for execution of the above work, however whenever service charge is revised by the competent authority (DHS), same will be implemented as part of the agreement and payment will be made accordingly, for which you have to submit documentary evidence in BHEL.

- 1.8 Price quoted by the tenderers should be inclusive of all taxes and charges etc. as per Govt. rules and regulations.
- The complete bio-medical waste garbage must be lifted daily (except Sundays, BHEL holidays and National holidays) failing which, no payment at prorate basis for that particular day will be made besides a penalty of Rs.50/- per day and penalty amount will be deducted from the monthly bill. The garbage must be disposed of in a safe way specially recommended by concerned authorities of Delhi Government. Any dispute arising in this regard will be the sole responsibility of the contractor.
- 1.10 BHEL reserves the right to accept or reject any of the bid / all bids with or without deviation or cancel / withdraw the invitation for bid without assigning any reason whatsoever and in such case no tenderer shall have any claim arising out of such action by BHEL.
- 1.11 All documents submitted by the tenderer shall be accompanied with a covering letter with index interlinking all the documents.
- 1.12 Evaluation of the tenders will be done on the basis of total cost to company i.e. at SI. No.4 in price bid. If at any point of time, it is found that there is mismatch/discrepancies in price bid between unit price and total price (which is obtained by multiplying the unit price by quantity), the unit price shall prevail and the total price shall be corrected accordingly, unless in the opinion of the purchaser, there is an obvious misplacement of decimal point in the unit price, in which case the total price as quoted shall govern and unit price corrected accordingly.
- 1.13 The bidder along with its associate/collaborators/sub-contractors/sub-vendors/consultants/service providers shall strictly adhere to BHEL fraud prevention policy displayed on BHEL web site; http://bhel.com and shall immediately bring to the notice of BHEL Management about any fraud or suspected fraud as soon as it comes to their notice.

2. Payment terms:

- 2.1 Payment will be made through NEFT on monthly basis after successfully execution of work throughout the month, duly verified by the concerned dispensary within 20 days approximately after submission of bill after deduction of TDS etc if any as per Govt. rules. As per company policy, no advance will be given to the bidder.
- 2.2 Tenderers are requested to go through the scope of work as per tender enquiry, visit the site location etc. and get fully acquainted with the scope of work to get all their doubts, if any, clarified by contact person mentioned in tender enquiry before submitting the offer.
- 2.3 Penalty will be levied by BHEL as per clause No. 1.9 of this tender enquiry on account of delay or no service.

3.0 SCOPE OF WORK:

The complete bio-medical waste garbage from both the dispensaries at Asiad, Khelgaon & Lodhi Road, New Delhi must be lifted daily except Sundays, BHEL holidays and National holidays.
