PART-I

Instructions to Tenderer

1. Sealed tenders in two part bid are invited from the agencies for photography and Video coverage of Official functions/meetings at BAP, BHEL Ranipet.
2. Tenders will be received up to 15:00 hrs on 02.07.2018 in the prescribed form. The pre-qualification bid (Part-A) will be opened on on 02.07.2018 at 15:30 hrs at HRM Conference Hall, BAP, BHEL, Ranipet in the presence of tenderers / representatives who chose to be present for the tender opening.
3. Tenders will be evaluated further and tenderers who are found to meet the pre qualification criteria will be intimated to attend the tender opening of Part 'B' - price bid at a date to be notified separately. Part 'B' will be opened at the specified date in the presence of the tenderers / representatives who are notified and chose to attend the tender opening.
4. Bidders to ensure that their offers are complete in all respect. Offer should be either typed or written legibly. Alterations / over-writings, if any, in the tender should be attested by the person signing the tender. Any deviation or non-compliance may lead to rejection of their offer at any stage.
5. Tender offers should be posted with due allowance for any delay in postal delivery. Tender offers received after the due date and time of opening tenders will be rejected.
6. The management of BHEL will not be responsible for any loss or damage or delay in transit of offer documents sent by BHEL to the prospective offerer or sent by the offerer to BHEL duly filled in, by Post.
7. Tenderer shall affix signature and seal on all pages as a token of acceptance.

8. The tenderer should submit the tender documents intact without detaching any page or pages.
9. The tenderer shall expressly accept all the terms and conditions of the tender.
10. BHEL reserves the right to assess the capacity and capability of the parties for pre-qualification. The company also reserves the right to accept or reject any or all the tenders or any part thereof at any stage of process without assigning any reason whatsoever. The company has no obligation to accept the lowest tender. BHEL's decision in this regard shall be final and binding.

PART-II

Scope and Terms & Conditions

SPECIFICATION/SCOPE OF WORK:

Services of photography/Video coverage of Official functions/meetings held at BAP, Ranipet and supply of Maxi Size colour photo copies/CD,DVD of Video coverage.

ELIGIBILITY CRITERION

1. The tenderer should have an established photo studio/shop.
2. The studio/shop must be located within 30 kms from BHEL, Ranipet.
3. The tenderer should be a professional/full time photographer or should have employed such persons.

TERMS AND CONDITIONS:

1. Good HD quality and branded camera (still/Video) shall be used for the above work.
2. Date and Time of Photo/Video coverage and no. of snaps/duration of programme to be covered will be informed by the undersigned/PR Staff.
3. You shall be required to report at the venue for photography/Video coverage when asked by the authorized person of BHEL/Ranipet within an hour.
4. The photography/Video coverage shall be converted in to CD/DVD along with relevant photo copies and delivered to BHEL/PR dept. No payment will be made for the cost of CD/DVD and conversion of the programme in to CD/DVD. A good quality CD/DVD must be used for this purpose.
5. In case of urgency, photographs are to be delivered according to the nature of urgency at the shortest possible time as notified.
6. The entire photos/Video with negative is sole property of BHEL. No photograph or CD/DVD of BHEL/Ranipet shall be parted to any persons without the authorization in writing by the undersigned.
7. You are advised to maintain a record which specifies Date, event, no. of copies requested, no. of copies delivered and the signature of the official to whom the photos/CDs handed over. This may be required to be produced during submission of Bills by you.
8. The quantity indicated in the price bid is not 'single time requirement', it is for the entire contract period i.e. for 2 years. Also the quantity indicated in the Price bid is tentative only. However, the actual quantum may vary according to the requirements and BHEL will not compensate any reduction in the quantity during the tenure of contract.
9. The rates quoted in the tender shall be firm and valid throughout the contract period for 2 years from the date of issue of LOI.

10. The Contractor's responsibility under this contract shall commence from the date of receipt of the order of acceptance of his offer through letter of intent.
11. BHEL reserves the right to accept/reject any or all tenders received or part thereof without assigning any reason there for.
12. Conveyance charges will be given at the flat rate of Rs 40/- per trip. In case more than one trip in a day is requested, conveyance will be paid accordingly.
13. Halting charges will be given at the flat rate of Rs 60/- per trip irrespective of no. of hours engaged in the company.
14. Contract will be awarded to the lowest bidding tenderer i.e.LI party. **The LI will be decided on overall basis of sum of the estimated quantity multiplied by the rate quoted for respective item i.e. based on Sl.no: 6 of Price bid.** Any omission to quote for individual rate schedule will lead to rejection of the tender at the discretion of BHEL. If more than one bidder emerge as LI, snap bidding will be done to decide the LI party. No splitting of contract will be done.
15. It is mandatory to comply with all taxes applicable for the required services. In the Price bid applicable service tax in percentage is to be indicated separately. If it is not mentioned at the given place, it will be assumed that no service tax is applicable.
16. The contract shall commence from date of awarding the contract or at a later date as decided by BHEL and shall remain in force for a period of **Two years**. BHEL shall have the right to terminate the agreement for convenience without any liability whatsoever by giving one month's written notice.
17. In case of the matters not specifically provided herein, BHEL shall have the right to give instructions for compliance of the contract.

VALIDITY OF RATES:

The rates quoted should be valid for 90 days initially from the date of opening of the price bid. The rates of successful bidder should be valid for two years from the date of commencement of the contract.

SECURITY DEPOSIT

The successful bidder shall be required to furnish security deposit at the rate of 5% of the order value within 3 days from the date of LOI by way of demand draft drawn in favour of 'Bharat Heavy Electricals Ltd., Ranipet-632406' payable at SBI, Mukundarayapuram, (Branch Code 7013). SD will remain with BHEL till the tenure of the contract i.e. 2 years (24 months). Security Deposit can also be submitted by way of Bank Guarantee, as per format provided/ approved by BHEL. Bidders to note that Security Deposit amount carries no interest. Security deposit shall be forfeited in case the successful bidder refuses to commence the work within the period as per LOI / Contract and/or nonfulfillment of conditions of the order.

GST:

Consequent to the implementation of GST by Govt.of India w.e.f. 01.07.2017, the other applicable taxes like Service Taxes, VAT etc have been withdrawn. It has become mandatory for all service providers/vendors to adopt to GST system. If GST is applicable, the contractor shall furnish the following details and comply.

Registration & GST Rate:

Bidder should indicate GSTIN No. (Copy of GST registration to be enclosed) and PAN No. (copy of PAN to be enclosed).

Tender will be considered/ accepted, if & only if the vendor has a valid GST Registration No. in Tamil Nadu. In case the vendor is not having GST registration in Tamil Nadu the same shall be submitted within one week of award of contract.

Central Tax/ State Tax/ Integrated Tax/ Union Territory tax to be quoted as extra in %.

Bidders to ensure correct applicability of Central Tax/ State Tax/ Integrated Tax/ Union Territory tax based on the Inter / Intra state movement Supply of goods and provision services or both.

Invoicing & Payment:

- a. The Tax Invoice for supply of Goods & Services should be raised as per the provision of GST Act & Rules and must compulsorily mention the following :-

- d. Name & address of supplier
- e. GSTIN of Supplier in Tamil Nadu
- f. Consecutive Serial Number & date of issue
- g. Description of goods or services
- h. Total value of supply
- i. Taxable value of supply
- j. Tax Rate – Central Tax & State Tax or Integrated Tax, Cess
- k. Amount of Tax charged
- l. Place of supply
- m. Address of delivery if different from place of supply
- n. Signature of authorized signatory
- o. Reimbursement of GST to the vendor is contingent upon complying with the following condition by the service provider:-
- p. Uploading the onward GST Return (GSTR-1) in GSTN Network portal within the statutory time period.
- q. Discharging the GST tax liability to the Government.
- r. Submission of Tax Invoice to BHEL.
- s. Submission of proof of payment of GST to BHEL.
- t. Availment of Input Tax Credit by BHEL.

Input Tax Credit:

- a. In case GST credit is delayed/ denied to BHEL, due to non/delayed receipt of goods and/or services and/or tax invoice or expiry of timeline prescribed in GST Law for availing such ITC, or any other reason not attributable to BHEL, GST amount shall be recoverable from Vendor along with interest & penalty levied/ leviable.
- b. In case vendor delays declaring such invoice in his return and GST credit availed by BHEL is denied or reversed subsequently as per GST law, GST amount paid by BHEL towards such ITC reversal as per GST law shall be recoverable from vendor/contractor along with interest & penalty levied/ leviable on BHEL.
- c. In case of discrepancy in the data uploaded by supplier in the GSTN portal or in case of any

incomplete work/service, then BHEL will not be able to avail the tax credit and will notify the supplier of the same. Supplier has to rectify the data discrepancy in the GSTN portal or issue credit note (details to be uploaded in GSTN portal).

d. For any such delay in availing of tax credit for reasons attributable to vendor (as mentioned above), interest as per the GST Act & Rules, along with penalty, if any will be deducted for the delayed period i.e. from the month of receipt till the month tax credit is availed, from the running bills.

Penalty for Non-compliance of GST Act:

Penalty amount so determined along with GST if applicable thereon shall be recovered from the contractor.

Benefits of GST:

Any reduction in rate of Tax on any supply of goods or services or the benefit of input tax credit on account of GST shall be passed on to BHEL by way of reduction in prices.

13.6. Other Provision:

- a. The agency should quote the applicable taxes and duties in the PRICE BID (part-B).
- b. All the terms & conditions of the contract with respect to Taxes & Duties are subject to the new taxation laws introduced from time to time (e.g., GST). The terms & conditions will be modified in accordance with the provisions of new laws (e.g., GST).
- c. The Prices quoted above must be inclusive of all taxes and duties and exclusive of GST, which will be payable extra as per applicable rules and subject to Submission of documentary evidence.

PENALTY - DELAY

The contract is subject to the satisfactory performance of work, quality of product and adherence to BHEL requirements. In case of failure or delay on the part of contractor, BHEL will take alternative arrangement and the entire amount incurred in that connection will be recovered from the contractor. Persistent deviation in the contract may lead to termination of the contract at any moment without assigning any reason in writing at the discretion of BHEL, Ranipet.

PAYMENT TERMS:

1. Payment will be made on monthly basis and will be paid within thirty days from the date of submission of bills. The bills should be addressed to the undersigned in triplicate and submitted during 1st week of every succeeding month. All statutory formalities will have to be complied with.
2. Payments will be made only to bidder's Bank Account through EFT (Electronic Fund Transfer). In this regard, necessary forms for EFT shall be submitted by the successful bidder at the time of agreement.

EFFECT AND JURISDICTION OF CONTRACT

The law applicable to this contract shall be the laws in force in India. The courts in Ranipet, Tamilnadu, India shall have exclusive jurisdiction in all matters arising under and on account of this contract.
