23. Tender Evaluation - Evaluation will be done on overall L1 (Total Cost to BHEL excluding GST) basis for complete scope of the tender with necessary loading as applicable.

Bidders to note that Reverse Auction shall not be conducted in this case and L1 bidder shall be established on the basis of prices quoted in price bids submitted along with offer.

35. Bidder to note that this is an Open Tender enquiry & price bid (Part-II) opening/RA participation shall be subject to following condition:

- a) **Techno-commercial recommendation of bidder by the BHEL-PEM.**
- b) **Approval of bidder by End Customer.** Same shall be taken up with end customer based on the latest credentials/reference list furnished by bidder. Accordingly, bidders are requested to submit credential as per the format enclosed herewith along with their technical bid.

The bidders who are not registered with BHEL-PEM may apply for registration in BHEL-PEM through Registration Portal available at www.bhelpem.com-->vendor section-->online supplier registration. All credentials and/or documents duly signed & stamped related to registration has to be uploaded on the website & submit the application for registration. One set of hard copy filled-up SRF downloaded from Online Registration Portal duly signed & stamped has to be submitted.

36. The Bidder along with its associate/ collaborators/ sub-contractors/ sub-vendors/ consultants/ service providers shall strictly adhere to BHEL Fraud Prevention Policy displayed on BHEL website <http://www.bhel.com> and shall immediately bring to the notice of BHEL Management about any fraud or suspected fraud as soon as it comes to their notice.

37. BGs should be in favour of BHEL-PSWR in place of PEM. L1 Vendor will be required to submit BGs as per GCC Rev-06. Refer enclosed BG format to NIT for BG Submission instead of format mentioned in GCC Rev 06.

38. In case of joint bidding Bidders to furnish scope matrix which should be clearly defined between them along with the offer for the Main Supply and Erection & Commissioning.

39. Bidders to note that offers shall be submitted strictly in accordance with the requirements of the all the enclosed Tender Documents. shall automatically become the part of the Order/Contract after its finalisation.

40. Risk & cost- Additional Overhead Charges shall be 5% instead of 30% as mentioned in Clause No 26.2.of GCC Rev 06.

41. In the event of any contradiction in the terms and conditions mentioned, the order of precedence shall be N.I.T. covering letter (including Tech Spec) followed by SCC and followed by GCC terms & Corrigendum to GCC Rev-06.

42. CGST/SGST/UGST/IGST shall be paid at actuals against documentary evidence but restricted to the amount and percentage as per agreed HSN/SAC Code.

43. Over all (%) quantity variation: The variation on overall package value due to changes in the scope shall be limited to +/-10% in place of 30% mentioned in clause no 6.0 of GCC-REV-06.

44. Insurance Deductibles/Excess:

Marine: Rs. 20000/-

Storage /Erection and Testing Cover:

- Rs 2,25,000/- or 5% of the claim amount whichever is higher for Normal Period.

- Rs 6,00,000/- or 5% of the claim amount whichever is higher for Testing Period.

Act of God (AOG) Perils: 10% of the claim amount subject to a minimum of testing periods excess and maximum of 5 crs per event

Fire / Explosion Claims: 20% of the claim amount subject to minimum of testing period excess.

Terrorism Cover: 5% of loss amount subject to minimum of Rs. 1,00,000/- and maximum if Rs. 2,50,00,000/- each and every loss.

Extended Maintenance Cover/ Defect Liability Cover: As applicable for testing period

Third Party Liability:

1. The policy excesses (Normal/ Testing periods) shall apply for third party liability property damage claims also.

2. For third party liability claims arising out of Acts Of God perils, the excess applicable to AOG claims shall apply.

45. Construction Power, Construction Water & Storage Space:

Construction Power: BHEL will provide the single point power source to all working agencies from where they have to extend it up to their work areas. Agency has also make the Suitable metering arrangement along with associated Instrument transformers and Metering Cubicles for the measurement of actual energy consumed by him. The charges only for the actual energy consumed

shall be recovered from the agency based on prevalent rates. Agency has also to arrange the capacitor banks (if required).

Construction water will be made available at one point on chargeable basis and agency has to extend the water supply up-to their working areas.

Storage space shall be made available to the agencies free of cost on the basis of space availability from customer end.

46. For this procurement, Public Procurement (Preference to Make in India), Order 2017 dated 15.06.2017 & 28.05.2018 and subsequent Orders issued by the respective Nodal Ministry shall be applicable even if issued after issue of the NIT but before finalization of contract/ PO/WO against the NIT. In the event of any Nodal Ministry prescribing higher or lower percentage of purchase preference and / or local content in respect of this procurement, same shall be applicable. The package is not divisible in nature.

Vendors are required to provide the following certificate along with the part-1 bid:

- (i) Provide self-certification that the item offered meets the minimum local content as per above mentioned orders.
- (ii) Provide the details of the location(s) at which the local value addition shall be made.

47. **Payment for Operation & Maintenance Services:** Payment shall be made on monthly basis based on per month rate derived from total rate quoted by bidder. Required personnel for the O&M shall be deputed within 10 days from the date of intimation.

48. **Conciliation Guidelines** - The Parties agree that if at any time (whether before, during or after the arbitral or judicial proceedings), any Disputes (which term shall mean and include any dispute, difference, question or disagreement arising in connection with construction, meaning, operation, effect, interpretation or breach of the agreement, contract or the Memorandum of Understanding (delete whichever is inapplicable), which the Parties are unable to settle mutually), arise inter-se the Parties, the same may, be referred by either party to Conciliation to be conducted through Independent Experts Committee to be appointed by competent authority of BHEL from the BHEL Panel of Conciliators.

Notes:

- 1. No serving or a retired employee of BHEL/Administrative Ministry of BHEL shall be included in the BHEL Panel of Conciliators.
- 2. Any other person(s) can be appointed as Conciliator(s) who is/are mutually agreeable to both the parties from outside the BHEL Panel of Conciliators.

The proceedings of Conciliation shall broadly be governed by Part-III of the Arbitration and Conciliation Act 1996 or any statutory modification thereof and as provided in Annexure-C to this NIT.

The Annexure -C together with it's Formats will be treated as if the same is part and parcel hereof and shall be as effectual as if set out herein in this NIT. The Purchaser/Contractor/Seller agrees that the Purchaser/Contractor/Seller may make any amendments or modifications to the provisions stipulated in the Annexure -C to this NIT from time to time and confirms that it shall be bound by such amended or modified provisions of the Annexure -C with effect from the date as intimated by BHEL to it.

49. MSME/Start up: - Bidders to submit applicable documents along with their offer for availing the benefits as per GOI guidelines. Further PEM is already registered with RXIL(TReDS) Platform. Bidders are requested to get registered with RXIL(TReDS) platform to avail the facility as per GOI guidelines.
50. Bidders must visit site/ work area and study the job content, facilities available, availability of materials, prevailing site conditions including law & order situation etc. before quoting for this tender. They may also consult this office before submitting their offers, for any clarifications regarding scope of work, facilities available at sites or on terms and conditions.
