23. Bidders who fulfil Technical & Financial Pre-Qualification Requirement Criteria are eligible to participate in this tender. Bids of only those bidders shall be evaluated who meet the Technical as well as Financial Pre-Qualifying requirements.
24. Bidder to note that this is an Open Tender enquiry & Price bid (Part-II) opening/RA participation shall be subject to following condition:

32. **Deductibles/ Excess: Following Deductibles/ EXCESS may be considered.**

Transit Excess: - 0.25 % of consignment value with a minimum excess of Rs. 20,000/-.

Fire cover Deductibles: - 5% of the claim amount subject to a minimum of Rs. 25,000/- each and every loss.

Terrorism Deductibles: 5% of claim amount subject to minimum of Rs. 1,00,000/- and maximum of Rs. 25,00,000/-.

Burglary Excess:- 5% of claim amount subject to minimum of Rs. 25,000/- (Burglary including theft)

33. **Construction Power:** Construction power at one point shall be provided to vendor on chargeable basis, complete network beyond the one-point supply shall be responsibility of vendor.

Construction water: Construction water shall not be provided by BHEL, it is to be arranged by vendor on its own.

34. Bidders to quote freight charges in percentage of their quoted Total Ex-works Prices.

35. GST shall be payable extra at actual as per the HSN code finalised for the items during detailed BBU.

36. In line with clause no 26 of (ITB) GCC-REV-07, this package is not divisible in nature and minimum local content requirement is 100%. Local supplier at the time of tender are required to provide the following certificate along with the part-1 bid:

- (i) Provide a certificate (in line with attached draft) from the statutory provide or cost auditor of the company (in the case of companies) or from a practicing cost accountant or practicing chartered accountant (in respect of suppliers other than companies) giving the percentage of local content.
- (ii) Provide the details of the location(s) at which the local value addition shall be made.

37.
