Delay in BHEL's comments/approval beyond 18 days shall also be considered for delay analysis. <u>Supply for Stage-II (Unit-III to V)</u> : Delivery shall be 6 months from BHEL clearance.			
<u>Mandatory Spares (Optional)</u> : To be delivered along with last consignment of Stage-2 Main Supply quantity within the contractual delivery period.			
<u>Supervision of E&C</u> : Vendor to deploy its Service Engineer/Supervisor at project site for supervision of E&C within 30 days from BHEL intimation.

A. Clearance for Stage-2 Main supply shall be within 03 years from the date of Purchase Order, in line with clause No. 6 of General Commercial Terms & conditions of GCC Rev. 07.			
B. The end period specified is for completion of the deliveries. Deliveries to start progressively so as to meet the completion schedule.			
C. The delivery conditions specified are for contractual LD purposes, however BHEL may ask for early deliveries without any compensation thereof.			
D. Wherever schedule of drawings/documents submission / re-submission is stipulated in the Technical Specifications, same shall be superseded by delivery specified in NIT.

12. **Tender Evaluation - Evaluation will be done on overall L1 (Total Cost to BHEL excluding GST) basis with necessary loading as applicable. Mandatory Spares are optional and shall not be considered for evaluation and ordering.**

In case of PBO, the loading (technical/commercial), if any, shall be added by BHEL for evaluation.

In case of RA, the loading (technical/commercial), if any, shall be added by bidder while submitting the bid in reverse auction portal.

Ordering shall be done after de-loading the commercial/ technical loading from bidder's final price.

13. Terms & Conditions: - All other terms & conditions shall be as per Notice Inviting Tender (NIT) conditions, GCC Rev-07 & SCC-R01 for 5x800 MW Yadadri TPS. Order of precedence shall be as per clause No, 36.0 of GCC Rev. 07 (GENERAL COMMERCIAL TERMS & CONDITIONS).

14. Bidder to note that this is a Conditional Tender enquiry and the price bid (Part-II) opening/RA participation shall be subject to following condition:

- a) Qualifying technical PQR
- b) Techno-commercial recommendation by BHEL.
- c) Approval of bidder by End Customer.

Note: Approval shall be taken up with end customer based on the latest credentials/reference list furnished by bidder. Accordingly, bidders are requested to submit credentials along with their technical bid as per the format enclosed with this enquiry.

The bidders who are not registered with BHEL-PEM may apply for registration in BHEL-PEM through Registration Portal available at www.bhelpem.com-->vendor section-->online supplier registration. All credentials and/or documents duly signed & stamped related to registration has to be uploaded on the website & submit the application for registration. One set of hard copy filled-up SRF downloaded from Online Registration Portal duly signed & stamped has to be submitted.

Bidders to ensure that Third party/Customer issued certificates being submitted as proof of PQR qualification should have verifiable details of documents/certificate issuing authority such as name & designation of issuing authority and its organization contact number and e-mail id etc. In case the same found not available, purchaser has right to reject such document from evaluation

19. Unsolicited fresh/revised price bid shall not be entertained.
20. Purchaser shall be under no obligation to accept the lowest or any other tender and shall be entitled to accept or reject any/all tender(s) in part or full without assigning any reason whatsoever.
21. Bid should be free from correction, overwriting, using corrective fluid etc. Any interlineation, cutting, erasure or overwriting shall be valid only if they are attested under full signature(s) of person(s) signing the bid else bid shall be liable for rejection.

24. In case of joint bidding, Bidders shall be required to furnish scope matrix which should be clearly defined between them along with the offer for the complete scope as per NIT.
25. Overall (%) variation in contract value (due to changes in the scope) for this package is +/- 5% which shall prevail over the variation of contract value clause no. 6.0 of GCC rev 07.
26. Bidders to quote freight charges in percentage of their quoted Total Ex-works Prices.
27. In line with clause no 26 of GCC-REV-07 (ITB), bidders are requested to go through the mentioned orders related to Make in India.
For this procurement, Public Procurement (preference to make in India), order 2017, Dt: - 15.06.17, 28.05.18 & 29.05.19 and subsequent orders issued by the respective nodal ministry shall be applicable even if issued after issue of the NIT but before finalization of contract/PO/WO against the NIT. In the event of any nodal ministry prescribing higher or lower percentage of purchase preference and / or local content in respect of this procurement, same shall be applicable. 28. Minimum local content value for the tendered package is 100% and it may vary in case department of industrial Policy and Promotion (DIPP) issue any new (revised) circular in future, the same % shall be informed as & when received from authorities.
29. This package is not divisible in nature and margin of purchase preference shall be 20%.
30. BHEL reserves the right to go for Reverse Auction (RA) (Guidelines as available on www.bhel.com) instead of opening the price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. Bidders to give their acceptance with the offer for participation in RA. Non-acceptance to participate in RA may result in non-consideration of their bids, in case BHEL decides to go for RA.
31. The Bidders has to quote the Single Price (i.e. Total Cost to BHEL) in Reverse Auction. Price are to be inclusive of Packing & Forwarding charges, all the routine & type tests as per tender scope, Freight as applicable, including loading (if any). De-loading (if any) shall be done in line with NIT terms.
32. All the above terms and conditions, post-bid agreements/MOMs (during Techno- Commercial evaluation) shall automatically become a part of the Order/Contract after its finalisation.
