23. The scope of switchyard shall be executed by TBG and scope of stage-I & II main plant area shall be executed by PSSR. Bank guarantee for the respective scope shall be submitted to PSSR and TBG.	
24. Bidders who fulfil Technical & Financial Pre-Qualification Requirement Criteria are eligible to participate in this tender. Bids of only those bidders shall be evaluated who meet the Technical as well as Financial Pre-Qualifying requirements.	
25. Regarding verification of PQR documents: Bidders to ensure that Third party/customer issued certificates being submitted as proof of PQR qualification should have verifiable details of document/certificate issuing authority such as name & designation of Issuing Authority and its organization contact number and e-mail Id etc. In case the same found not available, Purchaser has right to reject such document from evaluation.

30. Over all (%) quantity variation: The variation on overall package value due to changes in the scope shall be limited to +/-10% in place of 30% mentioned in clause no 6.0 of GCC-REV-07.

33. GST shall be payable extra at actual as per the HSN code finalised for the items during detailed BBU.
