D) Vendor should have supplied similar*/ same item to reputed companies in past 02(Two) Years. Copies of purchase orders are required to be submitted as a documentary proof.

* Supply of Liquid oxygen or any other compressed gas in cryogenic state.

Note- Vendor to submit PQR document along with offer. Bidders who qualifies in above qualifying requirement shall be eligible for techno-Commercial evaluation of the offer.

(IV) Technical requirement:

- Test certificate comprising purity of liquid oxygen, should be send in original along with each lot of supply along with material.
- Overall Quantity variation is applicable +/-10%. Either qty. will exhaust or time period exhaust in both cases contract will expire.
- Oxygen purity test shall be provided with each lot/tanker.
- Contract validity shall be 2 years from the date of Purchase Order.
- For the computation of the quantity for billing and payments, conversion factor from KG to cubic meter will be 1 kg liquid oxygen = 0.77 Cubic Meter of gas at 27 deg cent. & 1 Atm.
