D. EMD of the Bidder will be forfeited if:

d.1 After opening the tender and within the offer validity period, the Bidder revokes his tender or makes any modification in his tender which is not acceptable to BHEL.

d.2 The Bidder fails to deposit the required Security deposit or commence the work within the period as per LOI/ Contract

d.3 If the bidder declines to accept the LOI / WO or is unable to accept the work which has been awarded on the basis of the offer received from the bidder or revokes the offer within the validity period of the offer, the earnest money shall stand forfeited

d.4 EMD by the Bidder shall be withheld in case any action on the Bidder is envisaged under the provisions of extant “Guidelines on Suspension of business dealings with suppliers/ Bidders” and forfeited/ released based on the action as determined under these guidelines.

E. EMD of successful bidder will be adjusted towards part of the security deposit.

- F. EMD of all unsuccessful bidders shall be returned normally within fifteen days of placement of LOI/Work Order on successful bidder.
- G. EMD shall not carry any interest.

6. **Taxes and duties**

- 6.1 All taxes .excluding gst, gst cess but including, royalties, fees, license, deposits, commission, any state or central levy and other charges whatsoever, if any, shall be borne by bidder and shall not be payable extra.
- 6.2 The successful bidder shall furnish proof of GST registration, if registered , along with cess (as applicable) legally leviable & payable by the successful bidder as per GST law, shall be paid by BHEL Hence bidder shall not include GST along with Cess (as applicable) in their quoted price in tender,
- 6.3 GST charged in, the "tax invoice by the contractor shall be released along with Tax invoice; but contractor has to ensure of filing of GSTR-I on regular basis fat availing GST input credit by BHEL and details of such invoice should match with corresponding details of outward supply of the contractor and has paid the GST at the time of filing the regular return.
- 6.4 Bidder shall note that the GST tax invoice complying with GST invoice rules (section 31 of - GST act & rules referred there under) wherein the 'bill to' details will as below

- 6.5 case of raising any supplementary tax invoice (debit / credit note) bidder shall issue the same containing all the details as referred to in section 34.read with rule 53.
- 6.6 Bidder shall note that in case GST credit is delayed/ denied to BHEL due to delayed / 11011 receipt of goods and /01' tax invoice or expiry of the timeline prescribed in GST law for availing such itc, or any other reasons riot attributable: to BHEL, GST amount shall be recoverable from the vendor along with interest levied / leviable on BHEL, as the case may be.
- 6.7 Bidder shall upload the invoices raised on BHEL in gstr-I within the prescribed time as given in the GST act. bidder shall note that in case of delay in declaring such invoice in bidder's return and GST credit availed by BHEL. is denied or reversed subsequently as per GST law, GST amount paid by BHEL towards such ut's reversal as 'per GST law shall be recoverable from the bidder along with interest levied / Leviable on BHEL.
- 6.8 New taxes and duties-any new taxes & duties, if imposed subsequent to due date of offer submission as per NIT, by statutory authority during contract period including extension, if the same is not attributable to contractor, shall be reimbursed by BHEL on production of relevant supporting document to the satisfaction of BHEL. However, Bidder shall obtain prior approval from BHEL before depositing new taxes and duties. Benefits and/or abolition of all existing taxes must be passed on to BHEL against new taxes, if any, proposed to be introduced at a later date.

Any new taxes & duties, if imposed subsequent to the due date of offer submission as per NIT &TCN, by statutory authority during contract period (including extensions for which delay is not attributable to the bidder), shall be reimbursed by BHEL on production of relevant supporting document to the satisfaction of BHEL. However, bidder shall obtain prior approval from BHEL before depositing any such new taxes and duties. 9. Payment Term

- A. No advance will be paid.
- B. The payment to be made to contractor will based on actual work done by contractor and its verification and recommendation by BHEL representative. Payment would be made based on actual work completed by bidder and certified by BHEL representative.
- C. In case of bill having GST No, it should be in name of BHEL bearing GST No. 27AAACB4146P1ZF. The GST amount would be released once it is reflected on GST portal.
- D. The taxes and duties including, royalties, fees, license, deposits, commission, any state or central levy and other charges whatsoever, if any, shall be borne by contractor and shall not be payable extra.
- E. Payment will be made online through NEFT/RTGS to contractor bank account within 30 days of submission of bill and its verification. Successful bidder must give bank details for NEFT/RTGS in prescribed format.

10. Liquidated damages

In case of delay of the work, The Contractor shall pay liquidated damages to BHEL at the rate 5% of contract value per week. The total amount of liquidated damages shall not exceed the 10% of Contract Value. BHEL may deduct liquidated damages from payments due to the Contractor. Payment of liquidated damages does not affect the Contractor's liabilities.

11. Security Deposit

- A. Total amount of security deposit is 5% of the contract value.
- B. As a guarantee towards due performance and compliance of the contract work, the successful bidder or lowest bidder shall deposit an amount equivalent to 5% of Contract Value towards Security Deposit by way of online money transfer to BHEL or demand draft in favor of "BHEL" drawn on any Nationalized Bank/ Scheduled Bank payable at Mumbai.
- C. BHEL reserves the right of forfeiture of Security Deposit in case of leakage or non-satisfactory outcome of the jobs
- D. **RETURN OF SECURITY DEPOSIT:** If the contractor duly performs and completes the work in all respects to the entire satisfaction of BHEL, Security Deposit will be released to the contractor after 6 months of job completion. No interest shall be payable by BHEL on Security Deposit or on any money due to the contractor.

12. Bid Validity:

- A. The bid shall be valid and open for the acceptance of the Competent Authority of BHEL for a period of 90 days from the date of opening of the tenders and no request for any variation in quoted rates and/ withdrawal of tender on any ground by successful bidder shall be entertained.
- B. The bid shall be valid and firm till completion of entire job in all respect
- C. The rate quoted by contractor shall be firm irrespective of any upward variation in the price of manpower or material.

13. General Terms & Conditions

- A. The bidder should not be involved in any litigation that may have an impact of affecting or compromising the delivery of services as required under this tender. There should be no

case (pending and/or convicted) with the Court of Law against the proprietor /Firm/Partner or the Company.

- B. The works to be performed in the above construction includes execution of the work including providing of all labour, supervision, materials, power, fuel, construction equipment, tools and plants, supplies, transportation, all incidental items necessary for successful completion of the work including contractor's supervision and in strict accordance with the safety norms and labour laws.
- C. The Bidder shall indemnify BHEL against any violation of safety laws, rules and regulations while carrying-out operations as required by the contract. The Contractor shall be liable for the consequences of faulty design and specifications, lack of care and negligence for that part of the Works, which was designed and specified by the Contractor for the period specified. The Bidder shall indemnify and keep indemnified BHEL all losses, claims etc. arising out of any of his acts or out of the acts of his agents or associates or servants during the currency of the contract.
- D. Good quality material shall be used the contractor for these jobs. Well trained worker/manpower shall be deployed by contractor for these jobs.
- E. The contractor will make his own arrangements for electricity / water required for construction. Nothing shall be paid on this account.
- F. The contractor will arrange for temporary stores at the site of work at his own cost. BHEL does not bear responsibility for Safety of contractor's items at working location.
- G. BHEL reserves the right to accept or reject any or all bids without assigning any reasons. BHEL also reserves the right to reject any bid which in its opinion is non- responsive or violating any of the conditions/specifications without any liability to any loss whatsoever it may cause to the bidder in the process.
- H. All cost incurred in connection with submission of bids like preparation, submissions, any personal visits for seeing the location, submitting the bids personally, subsequent processing etc shall be borne by the bidder. BHEL will not be responsible/ liable for the same regardless of the outcome of the tendering process.
- I. The period of offer of under the scope of work shall be valid for three month from date of opening of bid.
- J. Staff deployed must have expertise in civil work and they must be of good conduct and physically fit for the work. Bidder should be having required labor license.
- K. Bidder must ensure that workers are not having cough, cold , fever and /or pneumonia like symptoms at the time of execution of jobs. Bidder must also ensure that workers must use proper mask, gloves and other necessary PPE at the time of execution of job. They must ensure social distancing norms as work place.
- L. Obtain necessary license, permit, consent, sanction, etc., as may be required or called for from/ by local or any other authority for doing such work. The Agency shall comply at its own cost with all applicable laws, rules and regulations in force from time to time of State or

local Govt. as applicable to him or to this contract without any liability and responsibility to BHEL whatsoever it may be.

M. Bidder shall bear all taxes, rates charges, levies or claims, whatsoever, as may be imposed by the State/Central Government/any local body or authority. To furnish such proof of payment of compliance or the obligations including registration certificates, receipts licenses, clearance certificates etc. as may be required by the BHEL, from time to time.

N. Bidder shall be Responsible for compliance to the provisions of various labour laws relating to the personnel deployed by the Agency.

O. For any accident happened during execution of the job, the BHEL shall not be liable to bear any expense in this regard. Bidder must take liability of the same.

P. The personnel deployed by it are disciplined and do not participate in any activity prejudicial to the interest of the BHEL / Govt. of India/ any State/or any Union Territory.

Q. Good standard of services shall be maintained as indicated.

R. Under no circumstances Agency is entitled to claim any charges over and above the charges prescribed in the terms of this contract.

S. The decision of BHEL in regard to interpretation of the Terms & Conditions shall be final and binding on the Agency.

T. All disputes concerning questions of fact arising under the Contract shall be decided by the Head of ROD Mumbai subject to a written appeal by the Bidder to the GM ROD whose decision shall be final to the parties hereto. If amicable settlement cannot be reached, then all disputed issues shall be settled by arbitration/court and it shall be subject to the jurisdiction of court at Mumbai.

14. Corruption And Fraud Prevention

A. Bidder along with its associate/ collaborators/ sub-Bidders/ sub vendors/ consultants/ service providers shall strictly adhere to BHEL fraud prevention policy displayed on BHEL web site <http://www.bhel.com> and shall immediately bring to the notice of BHEL Management about any fraud or suspected fraud as soon as it comes to their notice.

B. Canvassing in any form or any attempt to influence directly or indirectly any official of BHEL will lead to rejection of the bid and forfeiture of the Earnest Money Deposit.

C. BHEL shall be entitled to cancel the contract and to recover from the Bidder the amount of any loss resulting from such cancellation, if the Bidder has offered or given any person any gift or consideration of any kind as an inducement or reward for doing or intending to do any action in relation to the obtaining or the execution of the contract or any other contract with BHEL or for showing or intending to show favor or disfavor to any person in relation to the contract with BHEL, if the like acts shall have been done by any persons employed by him or acting on his behalf whether with or without the knowledge of the Bidder in relation to this or any other contract with BHEL.

15. Guarantee

The contractor shall guarantee the work under the scope of contract for a period of 12 months from date of start and shall rectify free of cost all defect due to faulty supply or work done, if any

16. Termination
