1. Only those bids will be considered which have been submitted with requisite EMD. Those vendors who do not submit requisite EMD along with the offer shall be outrightly rejected.
2. BHEL team may visit the vendor (s) works for verification of capability and capacity claimed in tender documents/offer (s).

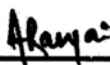
