In case more than one bidder happens to occupy the L-1 status even after soliciting discounts, the L-1 bidder shall be decided by a toss/draw of lots, in the presence of the respective L-1 bidder (s) or their representative(s).

Ranking will be done accordingly. BHEL's decision in such situations shall be final & binding.

23. Terms & Conditions:- The terms & conditions shall be as per enclosed special conditions of the contract (copy enclosed), GCC Rev 07 which is available on www.bhelpem.com and other Terms and Conditions included in this Enquiry Letter.

24. BGs should be in favour of BHEL-PSER in place of PEM. L1 Vendor will be required to submit BGs as per GCC Rev-07.

25. Bidders who fulfil Technical & Financial Pre-Qualification Requirement Criteria are eligible to participate in this tender. Bids of only those bidders shall be evaluated who meet the Technical as well as Financial Pre-Qualifying requirements.

26. "BHEL shall be resorting to Reverse Auction (RA) (Guidelines as available on www.bhel.com) for this tender. RA shall be conducted among all the techno-commercially qualified bidders. Price bids of all techno-commercially qualified bidders shall be opened and same shall be considered as initial bids of bidders in RA. In case any bidder(s) does not participate in online Reverse Auction, their sealed envelope price bid along with applicable loading, if any, shall be considered for ranking."

Note - Vendors to note that above RA clause will supersede clause no 13 of "Instruction to Bidders" of GCC Rev 07

27. Regarding verification of PQR documents-
Bidders to ensure that Third party/customer issued certificates being submitted as proof of PQR qualification should have verifiable details of document/certificate issuing authority such as name & designation of Issuing Authority and its organization contact number and e-mail Id etc. In case the same found not available, Purchaser has right to reject such document from evaluation.

28. Bidder to note that this is an Open Tender enquiry & RA participation shall be subject to following condition:

- a) Qualifying Technical & Financial Pre-Qualification Requirement.
- b) Techno-commercial acceptance of offer by BHEL-PEM.
- c) Approval of bidder by End Customer: - Same shall be taken up with end customer based on the latest credentials/reference list furnished by bidder. Accordingly, bidders are requested to submit credential as per the format enclosed herewith along with their technical bid.

The bidders who are not registered with BHEL-PEM may apply for registration in BHEL-PEM through Registration Portal available at www.bhelpem.com-->vendor section-->online supplier registration. All credentials and/or documents duly signed & stamped related to registration has to be uploaded on the website & submit the application for registration. One set of hard copy filled-up SRF downloaded from Online Registration Portal duly signed & stamped has to be submitted.

29. All corrigenda, addenda, amendments, time extensions, clarifications, etc. to the tender will be hosted on BHEL website (www.bhel.com), <https://bhel.abcpocure.com> & BHEL-PEM website (www.bhelpem.com). Bidders should regularly visit websites to keep themselves updated.

30. If bidder mentions Not Applicable / Not required / Not Quoted in BHEL price format, the same to be substantiated by the bidder. If such item is required to be supplied for system completion in future, same will be supplied free of cost.

33. Over all (%) quantity variation: The variation on overall package value due to changes in the scope shall be limited to +/-10% in place of 30% mentioned in clause no 6.0 of GCC-REV-07.			
34. Construction Water and Construction Power shall be as follows Construction water: Bidder shall make all arrangements himself for the supply of construction water as well as potable water for labour and other personnel at the worksite/colony. However, drawl of construction/ potable water from bore-well shall be permitted if found suitable and permitted by statutory authority. Any statutory clearance required shall be obtained by the bidder. Construction Power: Construction power will be provided to the bidders at one single point within the plant area by BHEL on chargeable basis as per the prevailing rates of DISCOM and meter shall be installed by bidder to draw out the power supply. All temporary wiring must comply with local regulations and will be subject to BHEL / end customer's inspection and approval before connection to supply. Power supply shall not be provided for use in labour & staff colony.			
35. Bidder to quote freight charges in percentage (%) of their quoted Total Ex-Works prices of supply portion.			
36. GST shall be payable extra at actual as per the HSN code finalised for the items during detailed BBU.			
37. This package is not divisible in nature. In place of clause no 26.0 of GCC rev -07 following shall be applicable. “For this procurement, Public Procurement (Preference to Make in India), Order 2017 dated 15.06.2017, 28.05.2018, 29.05.2019 & 04.06.2020 and subsequent Orders issued by the respective Nodal Ministry shall be applicable even if issued after issue of this NIT but before finalization of LOAs against this NIT. In the event of any Nodal Ministry prescribing higher or lower percentage of purchase preference and/ or local content in respect of this procurement, same shall be applicable.” In line with above clause, kindly provide the followings. (i) Provide a self-certification (in line with attached draft) giving the percentage of local content. (ii) Provide the details of the location(s) at which the local value addition shall be made.			
38. This item/Package falls under the list of items defined in Para 3 of Ministry guideline ref no.F.20/2/214-PPD(Pt.) dated.20-09-2016 (in respect of procurement of items related to public safety, health, critical security operations and equipment's, etc) & hence no relaxation of PQR for start-up/MSME vendors is envisaged for the NIT items/Package”			
39. Guarantee period for package except lining material shall be applicable as per Clause No.12 except 12.2 (a) of GCC Rev 07. However, lining material shall be guaranteed for a minimum life of 25000 hrs (Three years Approx.) from date of commissioning of tanks.			
40. Bidders to comply government of India order dtd 02/07/2020 regarding mandatory testing of all the imported items/equipments/components.			
41.
