

1.0 Introduction:

Bharat Heavy Electricals Limited (BHEL), Electronics Division, Bangalore is executing various SPV projects. For executing these projects, Drafting personnel are required to assist BHEL engineers in drafting, & drawing of array layouts, general arrangement drawings, module mounting structures, single line diagrams etc. in AutoCAD software and also 3D modelling in Autodesk Inventor software.

2.0 Scope of vendor:

- Vendor should depute four personnel to work in the BHEL EDN campus for the duration of the contract i.e. 12 months. He/she will work as per general shift timings of BHEL, EDN
- Work station shall be provided by BHEL EDN.

3.0 Pre-Qualification Criteria:

- Deputed personnel should have minimum qualification of Diploma in the field of Mechanical, Electrical or Civil Engineering (Civil=2 Nos., Mechanical = 1 No., Electrical = 1 No.).
- Deputed personnel should have done a certificate course in AutoCAD.
- Deputed personnel should have worked in AutoCAD software for at least three months in last two years and he /she has to provide a certificate from the contractor or self-declaration in this regard.
- During the period of contract, contractor should not depute another person in place of existing person unless in extraordinary circumstances, which are acceptable to BHEL.
- Vendor has to give the following declaration on his/her company letter head
 - Vendor will take insurance cover for the personnel to be deputed at BHEL EDN

4.0 Instructions to vendors on bid submission:

4.1	Offer shall be submitted in two-parts (Two part-bid). Both parts shall be in separate sealed envelopes as per instructions in tender. The individual envelopes shall be enclosed in a common bigger envelope with markings on the envelope (address, etc) as per instructions provided in tender.
4.2	First-part shall be Technical bid . Following details shall be furnished: <ol style="list-style-type: none"> Technical offer covering letter. Filled up EFT form in original (enclosed) and a copy of pan card with self-attestation. Separate clause-wise deviation sheet in case of deviations from BHEL spec.
4.3	Second-part shall be Price bid as per BHEL tender format.
4.4	In addition to the above instructions, tender document provides detailed instructions for bid submission. Vendor shall submit the bid based on such tender instructions.
