1.0 (Financial)	Average annual financial turnover of bidder, during the last three financial years (ending on 31-03-2017 or latest closing date of financial year) should not be less than Rs 1.56 Lakhs (or) equivalent. Notes: i. Other Income shall not be considered for arriving at Annual Financial Turnover/Sales. ii. The bidder has to submit audited financial accounts (comprising of Audit report, Balance Sheet, Profit & Loss A/c Statement and Notes/Schedules pertaining to Turnover/Sales/Revenue, Income Tax Returns for last 3 years for which audited annual accounts have been submitted) in support of above. iii. In case audited financial statements are not available for latest financial year, then the applicable audited statements of preceding three financial years shall be considered. iv. Bidder has to submit copies of valid ED, CST/VAT/PF registration certificates, PAN card. v. Certificate of incorporation from the registrar of companies/ partnership deed/ proprietorship documents etc. as applicable. vi. For evaluation of foreign bidder, exchange rate (TT selling rate of SBI) as on scheduled date of tender opening (Part-I bid in case of two part bid) shall be considered.
2.0 (TECHNICAL)	Refer technical PQC enclosed
3.0	<u>For Foreign Bidders :</u> <u>Credit Rating Report</u> a. The bidder to provide business information report incorporating the rating of the company by international credit rating agencies viz Dun & Bradstreet (D&B) etc along with technical offer. Such ratings reports shall not be older than 1 year form the date of submission of offer. b. Agency agreement needs to be submitted by foreign bidder in case of associating with Indian entity.

GENERAL NOTES:

A.	Only after satisfactory fulfillment of all the above Pre-Qualification Criteria / Requirements, Bidder's Offer shall be considered for further evaluation as per NIT conditions and all other terms of the tender.
B.	Bidder(s) already registered with BHEL other units for subject package, also need to submit credentials for criteria indicated in sl. nos. '1.0' and '2.0' above. They also must submit proof of their registration with BHEL-other units for subject package.
C.	Bidders should have technological capability for submitting offer through "Electronic Procurement System "and for participating in "On-line Reverse Auction "process.
D.	Mere submission of above documents does not entitle bidders for issue of order, enlistment with PE&SD or issue of tenders, but is subject to scrutiny of documents and/ or physical survey of bidder's facilities by BHEL or its appointed agencies.
