4	For addition/reduction of quantity, unit rate quoted in the present offer shall be considered during ordering and shall be valid up to execution of the contract to the extent of $\pm 10\%$ of order Value. These would include the cost up to engineering, installation of the item, wiring up in the panel and seamless integration with main system at works/site without any cost implications. All accessories required for this purpose shall be included in the price quoted.	
5	Billing will be as per BOM of actual supplied main equipment (including accessories & services) & spares.	
6	The total Erection & Commissioning charges should be minimum 10% of the total quoted price of the supply package excluding taxes and duties, failing which break up of prices shall be adjusted accordingly for evaluation & ordering.	
7	Per diem charges shall be applicable from the day bidder's person reaches site, up to the day he leaves the site.	
8	No of Man Days / no of visits are indicative only.
