3.17 PRE-QUALIFICATION REQUIREMENT:-

Technical Pre-Qualification Requirement Criteria is part of NIT and the bidders are required to submit Technical Pre-Qualification Requirement documents along with their offer. **Only those vendors, who fulfill these requirement, shall be considered further for evaluation.**

3.18 During price evaluation in case of foreign currency bids, exchange rate (TT selling rate of State Bank of India) as on schedule date of tender opening (part I bid in case of two part bids) will be considered for conversion in Indian Rupees. No correspondence will be entertained on this account.

3.19 Evaluation shall be done on lump sum basis (total cost to BHEL).

3.20 CIF content:- Not Applicable.

3.21 Foreign and indigenous bidders participating through open tender will necessarily have to buy class III DSCs issued by the certifying authorities in India for future tenders. Basic procedure /checklist has been upload on www.bhel.com for participating in future tender enquires through e procurement.
