8. Bidder is requested to quote their best competitive prices. "BHEL reserves the right to go for Reverse Auction (RA) (Guidelines as available on www.bhel.com) instead of opening the price bid, submitted by the bidder. This will be decided after techno-commercial evaluation. Bidders to give their acceptance with the offer for participation in RA. Non-acceptance to participate in RA may result in non- consideration of their bids, in case BHEL decides to go for RA.

Those bidders who have given their acceptance to participate in Reverse Auction will have to necessarily submit 'Process compliance form' (to the designated service provider) as well as 'Online sealed bid' in the Reverse Auction. Non-submission of 'Process compliance form' or 'Online sealed bid' by the agreed bidder(s) will be considered as tampering of the tender process and will invite action by BHEL as per extant guidelines for suspension of business dealings with suppliers/ contractors (as available on www.bhel.com).

The bidders have to necessarily submit online sealed bid less than or equal to their price bid already submitted to BHEL along with the offer (Through e-procurement). **The price bid (Through e-procurement) of successful L1 bidder in RA, if conducted, shall also be opened after RA and the order will be placed on lower of the two bids (RA closing price & price through e-procurement) thus obtained. The bidder having submitted this offer specifically agrees to this condition and undertakes to execute the contract on thus awarded rates.**

11. Important Details for Foreign Bidder-

- Bill of Lading shall be considered as equivalent document (refer clause 9.7.1 b) for recognition of despatch.
- For claiming payment under clause 9.1.1, 9.2.1 and 9.3.1 Bill of lading shall be considered instead of receipted LR (refer clause 9.7.2 b)
- Freight is to be quoted as inclusive in basic price by vendor and is not to be asked separately.
- There will be no change in MRC payment.

14. Bidder to note for compliance that this is conditional enquiry and the price bid (Part-II) opening /Reverse Auction is subject to the following: -

a) Techno-commercial qualification / recommendation of bidder by the BHEL-PEM.

b) Approval of bidder by End Customer. Same shall be taken up with end customer based on the latest credentials/reference list (Preferably not older than 5 years) furnished by bidder. Accordingly, bidders are requested to submit the following as per enclosed format for credentials on or before technical bid Part-1 opening.

All credentials and/or documents duly signed & stamped related to registration has to be uploaded on the website & submit the application for registration. 15. BGs should be in favour of BHEL-PSWR in place of PEM. L1 Vendor will be required to submit BGs for complete tender value to executing agency BHEL-PSWR. Refer enclosed Annexure B to NIT for BG Submission instead of format mentioned in GCC Rev 06.

16. In case of joint bidding Bidders to furnish scope matrix which should be clearly defined between foreign bidder and their Indian representative along with the offer for the complete scope.

17. Bidders to note that offers shall be submitted strictly in accordance with the requirements of the all the enclosed Tender Documents. Post-bid agreements/MoMs (during Techno- Commercial evaluation) shall automatically become the part of the Order/Contract after its finalisation.

18. Total erection & commissioning charges including GST should be minimum 20% of the total quoted package (excluding mandatory spares but including all taxes & freight), falling which the break-up of price shall be adjusted accordingly for ordering.

19. Risk & cost- Additional Overhead Charges shall be 5% instead of 30% as mentioned in Clause No 26.2. of GCC Rev 06.

20. In the event of any contradiction in the terms and conditions mentioned, the order of precedence shall be N.I.T. covering letter (including Tech Spec) followed by SCC and followed by GCC terms & Corrigendum to GCC Rev-06.

21. CGST/SGST/UGST/IGST shall be paid at actuals against documentary evidence but restricted to the amount and percentage as per agreed HSN/SAC Code.

22. Over all (%) quantity variation: The variation on overall package value due to changes in the scope shall be limited to +/-10% in place of 30% mentioned in clause no 6.0 of GCC-REV-06

23. Construction Power: - BHEL will provide the single point power source to all working agencies from where they have to extend it up to their work areas. Agency has to also make the Suitable metering arrangement along with associated Instrument transformers and Metering Cubicles for the measurement of actual energy consumed by him. The charges only for the actual energy consumed shall be recovered from the agency based on prevalent rates. Agency has to arrange also the capacitor banks (if required).

Construction Water: - Construction water will be made available at one point on chargeable basis and agency has to extend the water supply up-to their working areas.

Storage Space: Storage space shall be made available to the agencies free of cost on the basis of space availability from customer end.

24. All the tender documents, amendments & agreements till placement of order shall automatically.

25.
