22. Terms & Conditions:- The terms & conditions shall be as per enclosed special conditions of the contract (copy enclosed), GCC Rev 07 which is available on www.bhelpem.com and other Terms and Conditions included in this Enquiry Letter.
23. BGs should be in favour of BHEL-PSWR in place of PEM. L1 Vendor will be required to submit BGs as per GCC Rev-07.
24. Bidders who fulfil Technical & Financial Pre-Qualification Requirement Criteria are eligible to participate in this tender. Bids of only those bidders shall be evaluated who meet the Technical as well as Financial Pre-Qualifying requirements.
25. Bidder to note that this is an Open Tender enquiry & Price bid (Part-II) opening/RA participation shall be subject to following condition:
- Qualifying Technical & Financial Pre-Qualification Requirement.
 - Techno-commercial acceptance of offer by BHEL-PEM.
- The bidders who are not registered with BHEL-PEM may apply for registration in BHEL-PEM through Registration Portal available at www.bhelpem.com-->vendor section-->online supplier registration. All credentials and/or documents duly signed & stamped related to registration has to be uploaded on the website & submit the application for registration. One set of hard copy filled-up SRF downloaded from Online Registration Portal duly signed & stamped has to be submitted.

Bidders to ensure that Third party/customer issued certificates being submitted as proof of PQR qualification should have verifiable details of document/certificate issuing authority such as name & designation of Issuing Authority and its organisation contact number and email Id etc. In case the same found not available, Purchaser has right to reject such document from evaluation.
27. All corrigenda, addenda, amendments, time extensions, clarifications, etc. to the tender will be hosted on BHEL website (www.bhel.com), <https://bhel.abcpocure.com> & BHEL-PEM website (www.bhelpem.com). Bidders should regularly visit websites to keep themselves updated.
28. If bidder mentions Not Applicable / Not required / Not Quoted in BHEL price format, the same to be substantiated by the bidder. If such item is required to be supplied for system completion in future, same will be supplied free of cost.

31. Over all (%) quantity variation: The variation on overall package value due to changes in the scope shall be limited to +/-10% in place of 30% mentioned in clause no 6.0 of GCC-REV-07.
32. **Insurance Deductibles/ EXCESS:** Following Deductibles/ EXCESS may be considered.
- Marine-Rs. 20000/-
 - Storage /Erection and Testing Cover
 - Rs 2,25,000/- or 5% of the claim amount whichever is higher for Normal Period.
 - Rs 6,00,000/- or 5% of the claim amount whichever is higher for Testing Period.
 - Act of God (AOG) Perils: 10% of the claim amount subject to a minimum of testing periods excess and maximum of 5 crs per event

- d) Fire / Explosion Claims: 20% of the claim amount subject to minimum of testing period excess.
- e) Terrorism Cover: 5% of loss amount subject to minimum of Rs. 1,00,000/- and maximum if Rs. 2,50,00,000/- each and every loss.
- f) Extended Maintenance Cover/ Defect Liability Cover: As applicable for testing period excess.
- g) Third Party Liability Cover: The policy excesses (Normal/ Testing periods) shall apply for third party liability property damage claims also. For third party liability claims arising out of Acts of God perils, the excess applicable to AOG claims shall apply.
33. **Construction Power**: - BHEL will provide the single point power source to all working agencies from where they have to extend it up to their work areas. Agency has to also make the Suitable metering arrangement along with associated Instrument transformers and Metering Cubicles for the measurement of actual energy consumed by him. The charges only for the actual energy consumed shall be recovered from the agency based on prevalent rates. Agency has to arrange also the capacitor banks (if required).
Construction Water: - Construction water will be made available at one point on chargeable basis and agency has to extend the water supply up-to their working areas.
Storage Space: - Storage space shall be made available to the agencies free of cost on the basis of space availability from customer end.
34. Bidder to quote freight charges in percentage (%) of their quoted Total Ex-Works prices of Main supply.
35. GST shall be payable extra at actual as per the HSN code finalised for the items during detailed BBU.
36. In line with clause no 26 of (ITB) GCC-REV-07, this package is not divisible in nature and minimum local content requirement is 100%. Bidders at the time of tender, bidding or solicitation are required to provide the following certificate along with the part-1 bid:
(i) Provide a self-certification (in line with attached draft) giving the percentage of local content.
(ii) Provide the details of the location(s) at which the local value addition shall be made.
37. This item/Package falls under the list of items defined in Para 3 of Ministry guideline ref no.F.20/2/214-PPD(Pt.) dated.20-09-2016 (in respect of procurement of items related to public safety, health, critical security operations and equipment's, etc) & hence no relaxation of PQR for start-up/MSME vendors is envisaged for the NIT items/Package"
38. Bidders may visit site/ work area and study the job content, facilities available, availability of materials, prevailing site conditions including law & order situation etc. before quoting for this tender. They may also consult this office before submitting their offers, for any clarifications regarding scope of work, facilities available at sites or on terms and conditions. No additional claim shall be entertained by BHEL in future, on account of non-acquaintance of above.
39. All the above terms and conditions, post-bid agreements/MoMs (during Techno- Commercial evaluation) shall automatically become a part of the Order/Contract after its finalisation.
40. Bidders to note that offers shall be submitted strictly in accordance with the requirements of tender documents. Bidders shall upload their complete offer meeting the requirements of the tender documents on e-procurement portal <https://bhel.abcprocure.com>.
